Re: Fee Waivers to News Media

Dear Judge Evans:

It has come to our attention that fee waivers have been recently granted to the news media submitting bulk data requests to your office, and then, upon your approval, forwarded to the Clerk's Office for processing and compiling. As you know, a significant amount of work is performed by the Clerk's Office staff when generating the data necessary to respond to the bulk data requests and compiling that data. Pursuant to the Cook County Bulk Electronic Data Dissemination Policy, fees are calculated by the Clerk's Office and assessed before the work is done.

In light of the recent fee waivers, I am requesting that, in order to remain equitable to all those who submit bulk data requests and to generate the fees that are necessary to support the process of responding to those very bulk data requests, that in the future fee waivers are granted only in extreme circumstances.

Dear Chief Judge Evans:

In an effort to save costs and due to budgetary constraints, the Office of the Clerk of the Circuit Court of Cook County ("Clerk's Office") has strengthened our charging and collection efforts in charging all news media applicable Clerk's Office fees, including fees for copies of court files.

In order to standardize collection of statutory fees charged and collected by news media outlets throughout the court system, we are requesting your consideration in allowing the media to be charged and our office to collect fees for media bulk data requests.

The Office of the Chief Judge's practice of waiving bulk data request fees incurred by new media outlets has cost the Office of the Clerk of the Circuit Court \$157,600 in waived media bulk data request fees for Fiscal year 2015.

We humbly request your consideration because members of the news media are not exempt from copying, record search, certification, and other fees required under the Clerks of Courts Act.

The news media are on equal footing with other members of the public with respect to the payment of court fees and access to court records. 705 ILCS 105/27.2a; see e.g. <u>Houchins v. KQED, Inc.</u>, 438 U.S. 1 (1978); <u>Saxbe v. Washington Post Co.</u>, 417 U.S. 843, 850 (1974).

In June 2010, the Clerk's Office's Public Affairs Department sent letters to media outlets informing them of our statutory duty to charge them fees under the Clerks of Courts Act, including copying fees. This letter included information concerning the billing process offered by the Clerk's Office's Accounting Department, and stated that the news media will be charged onsite and asked to pay if no billing arrangements have been made.

Since that time, we have had a tremendous and cooperative response from media outlets with regard to paying for copying and record search fees.

We are requesting that the media be charged fees for media bulk data requests as well.

Pursuant to state law (705 ILCS 105/27.2a (r)), the Clerk's Office is required to charge fees, including fees for other services requested by the public and not specifically mentioned in the Clerks of Courts Act.

The Clerk's Office cannot waive these fees without a court order or unless the agency requesting our services is exempted by statute. Due to the fact that news media are not exempted by statute from paying fees, we must collect all fees where applicable.
