In response to your October 20, 2017 letter requesting a list of contracts over \$1 million BOT plans to bring to the Board in fiscal year 2018, please find attached Exhibit A. For each contract, the Exhibit includes a vendor if applicable, the procurement vehicle, the fiscal year 2018 impact, and the funding source(s). Please be aware that dollar amounts are exclusive of spends from other agencies and offices, and that in certain cases the final dollar amount is unavailable because BOT has not yet negotiated the contract or compiled spending forecasts from using agencies and elected offices.

Each of these contracts is essential for meeting the demands of the County's various institutional and public customers and is tied to a strategic schedule that requires that all parties avoid unnecessary delays. The extensions to the reseller agreements are imperative because they support ongoing County modernization projects, such as the Clerk of the Circuit Court's E-Filing initiative, and provide the majority of the County's critical information security tools.
