Hello, my name is Roy Chavadiyil. I am a radiology technician at Stroger Hospital, where I have worked for the last 25 years. I understand that the Commissioners have left a \$206 million hole in the Cook County budget for 2018 after they decided to repeal the Sweetened Beverage Tax. In doing so, they are now seeking a \$27 million cut from the Cook County Health and Hospital System. This is not feasible. At Stroger Hospital, we provide much needed health care to the less fortunate of Cook County. Further service reductions is "cutting off the nose to spite the face." Cuts in health care services will cost us greater in the end with more costly emergency room visits instead of regular care and more missed work due to illness. Health care is a vital investment in the resident's of Cook County and the need for these services is only growing. Patients, staff, and Cook County taxpayers deserve fully-funded health care services. These destructive cuts are the due to the actions of the County Commissioners. I encourage you to rectify this by finding alternative forms of revenue to balance the budget.
