Good evening. My name is Mary McGlynn and I am an administrative assistant for vehicle services at the Cook County Sheriff's Department here in Maywood. I have been an employee of the Cook County Sheriff's Department for 15 years. I assist Cook County residents in locating their vehicles when they are towed and impounded and other property when it is confiscated or recovered. I ensure that residents can quickly locate their vehicle and that they understand what they need to do to get it released. Many of these people are dependent on their vehicles to get to their jobs, to drive their kids to school and to help relatives make doctor's appointments. It's important that people are able to access their property in a reasonable amount of time in order to move on with their lives.

Since the Cook County Commissioners have repealed the Sweetened Beverage Tax and left a \$206 million hole in the County Budget, the Commissioners are now asking departments to cut their budgets by 10%. 10% of the Sheriff's budget is over \$62 million dollars! In light of this, I am here to defend my colleagues and defend my union sisters and brothers. As the frontline workers in the Sheriff's Department we provide great value to the County. We need to protect services and take a long, hard look at management bloat. Of all the civilian positions in the Sheriff's department there is 1 manager (pay grade 20 or higher) for every 2 staff. That is nowhere near an efficient ratio of managers to staff. When it comes to cuts in the Sheriff's budget: Chop from the top!
