#### President Preckwinkle, County Commissioners, Guests:

My name Jim Dunaway, I am the President of AFSCME Local 3486, Cook County Adult Probation Officers Union. Recently we were notified by Chief Judge Timothy Evans that our Local would have to take 15 furlough days to save 31 members jobs' or take 10 furlough days to save 18 members' jobs. Furlough days that would cost my members between approximately \$3,000 and \$6,000 in salaries, and/or layoffs that would further decimate the already overburdened caseload officers and pretrial services staff in our Department.

Commissioners claimed that the \$200 million budget shortfall as the result of their repeal of the sweetened beverage tax could be done with cuts to eliminate the fat in the budget. I'm here to tell the Commissioners that my members are not the fat in the budget! They are the dedicated front-line workers who go into the very dangerous areas of Cook County to supervise the Sex Offenders, Domestic Violence Offenders, Substance Abusers, Batterers, Burglars and Drug Dealers. These are probationers who live in your districts Commissioners!

Many of my members have caseloads that exceed the 120 to 140 workload hours established by the Administrative Office of the Illinois Courts, and to lose more due to layoffs and attrition or through furloughs would jeopardize public safety because even adequate supervision would be impossible. We are already stretched thin as it is.

We acquired a class of 12 new officers only one month ago, the first new hires in 3 years to fill the nearly triple number of vacancies that were the result of attrition.

In April 2011, our membership suffered a loss of 40 Adult Probation Officers. Within a short period of time more and more stories appeared in the media about probationers re-offending, violations of probation were more frequent and caseloads grew to more than twice the number of workload hours established by AOIC. It took 2 years and 8 months of circus plate spinning by my members before we saw one officer hired since the April 2011 layoff. Who knows what toll it took on constituents in your districts.

If you're not committed to public safety or reducing the jail population, then I guess that you'll vote for this budget. But don't call it cutting the fat because it's not. And Commissioners my membership is organized, and we support government officials who support us, the front line, hard working women and men of the Cook County Adult Probation Department.

The Better Government Association (BGA) congratulates the Cook County Board for getting through a challenging budget cycle. It was refreshing to see agency heads publicly pressed on their spending and efficiencies.

In this witness slip, the BGA highlights for commissioners and county officials a few of our continuing concerns:

Commissioners must take the lead in monitoring the effect of these budget cuts and make sure agency heads are acting in good faith, with the proper level of resources needed to meet the public's expectations. In particular, while a leaner government is welcome, commissioners need to oversee the system to ensure that cuts do not damage the county's ability to provide legally mandated services and meet the public's expectation of service quality.

The efforts of the past month addressed an immediate crisis. The BGA urges the board to re-channel their energy and, today, commit to prioritizing the long-term health of the county's budget by:

(1) Renewing efforts to annex unincorporated areas and special districts. Both the Civic Federation and the BGA recently have called on you to revisit these efforts. If unincorporated areas are not annexed, taxes and fees aimed at these locations can better address the cost of servicing them.

(2) Looking again at services that would benefit from more city and county collaboration. As the BGA noted in October, efforts from 2011 to 2013 produced clear benefits, but this work was not sustained on an official level beyond the first few years.

(3) Looking at personnel costs. The Civic Federation pointed out that personnel accounts for 82.9% of the General Fund, much of which is union labor. The BGA supports more transparency in collective bargaining. We call on the county to release more information to commissioners and the public, and sooner, so that we all can understand the tradeoffs and compromises that were made before the contracts are approved.

(4) Reviewing the county's basket of revenues. The Center for Tax and Budget Accountability pointed out that more than 30 percent of FY2017 revenues come from sources that are growing more slowly than inflation. Other sources of revenue, like taxes from cigarettes, are declining because fewer people are making those purchases. Commissioners face the same choice for FY2019 as they did when eight of you voted in the sweetened beverage tax in November of 2016. Identify new sources of revenue, find efficiencies, and/or cut services. That's a conversation that needs to start now.

I am writing on behalf of my colleagues and friends at the Cook County Public Guardian's Office and ask for a moment of your time:

We all have parents, we all were young once, and we all have experienced injustice in our lives. As adults, we are caring for our aging parents, children, or other loved ones and friends. Every day, we juggle our schedule to make sure our elders are safe, our children are thriving, and our loved ones content. We must make difficult decisions about how best to care for our elderly when they are no longer able to care for themselves, raise our children with love and compassion, and still maintain our sanity.

Some of us are luckier than others, we are fortunate to have other people in our lives to help us through trying times and difficult decisions. But every day, there are thousands of vulnerable individuals, young and old, who are suffering because they have been abused or exploited; and they are alone. They have no one to turn to; no one to care for them or look out for their best interests.

The Office of the Cook County Public Guardian serves this very vulnerable, often voiceless population. Whether a child in foster care, a child stuck in a custody battle, an elderly in the community, or an adult with cognitive challenges, the Public Guardian has advocated on their behalf. All the hardworking attorneys, social workers, investigators, support staff, and administration work together tirelessly toward one goal, to provide a safe place to live and thrive, encourage independence in children and adults, and fight for justice against abuse, neglect, exploitation.

The 9-5 day of the Public Guardian's Office consists of interviewing individuals to determine whether a disability renders a need for guardianship, freezing and collecting financial accounts to prevent further exploitation, fixing the roof or replacing a furnace in the elderly individual's home, applying for medical and financial assistance, consenting to major medical procedures after careful deliberation, and making the hard choice between prolonging life or providing hospice and comfort care. It also includes meetings with parents and children to determine custody and visitation. Before 5 p.m. each day, the Public Guardian's Office will have advocated for hundreds of children in foster care, whether in the school setting, foster home, or in court. The day doesn't end at 5 p.m. for the Public Guardian's Office; after hour calls regarding falls, hospitalizations, death, or a flooded bathroom are answered and issues resolved before the next work day begins.

No other Cook County government office does what the Public Guardian's Office does. Each and every day, each of us arrive at the Public Guardian's Office to deal with some urgent medical or financial issue, negotiate, argue, persuade, and advocate. The challenges never diminish, the stress never subsides, and the fight never ends. We come to the Public Guardian's Office each day because we care. We are a government office that cares for the most vulnerable. I urge you to stand with the Public Guardian.

My name is Kristi Kerrigan and I must speak out regarding the proposed budget cuts that Ms. Preckwinkle has proposed for my office, the Cook County Public Guardian. Many of these cuts include what she has labeled "middle management positions."

I have worked with the Public Guardian's Office for nearly 20 years and I am now employed in a "middle management position." While my name was not on the list of employees to be cut, many of my friends and colleagues, who have been employed with the office nearly as long or even longer than I have, weren't so lucky. So I must speak out against this gross mischaracterization of what our "middle management" job entails.

First, I think it is critical to remind you that our office is appointed to represent abused and neglected children as their attorneys and guardians ad litem. Essentially, we are the voices for children. In our downtown office, we serve as guardians for disabled adults. In both instances, we represent the most vulnerable citizens of Cook County.

I have been a GAL III for over 13 years. I can assure you that my job is no office position. I supervise a courtroom of attorneys. I am in court on a daily basis. I not only provide direct supervision to lawyers, I also carry cases of my own. I interview children, attend staffings and mediations. I work hand in hand with child welfare agencies, mental health professionals and foster parents to ensure the health, safety and best interest of children. Most of my colleagues, whose jobs are to be cut, do identical work.

To eliminate the positions proposed would render our office virtually inoperable and certainly much more inefficient. As a result, it would be denying the least among us the quality representation they deserve. Thank you so much.

My GAL was in the courtroom and my dormroom! That level of commitment gave me hope and has been unmatched over my 21 year span in Illinois foster care system.

My GAL ensured I had a fair opportunity to access all available resources to continue my education. I now have my Bachelors degree and Masters degree both in social work and I give credit to my GAL because with their tirelessness work and advocacy I would not have survived foster care or life after foster care!

The Office of the Public Guardian represents the most vulnerable in our county-abused, neglected and dependent children, disabled adults and children in highly contested custody battles. The budget proposals cut a majority of our highly experienced attorneys, claiming they are "middle management." Our office cannot afford to lose even one attorney. I work in the juvenile division as an attorney and guardian ad litem for approximately 135 children. I have been doing this work for almost 15 years. I am not middle management, but my supervisors are available to advocate for my clients when I am in court, or meeting with DCFS, or meeting with clients. The supervisors may not handle their own large caseloads, but they fill in where they are needed, or second chair in court, or provide much needed expertise. Our office has done amazing work to make sure that the children of cook county are safe. Caseworkers often have little training, and often appear overextended. This affects our clients. I cannot count the number of times a caseworker has admitted to never speaking to my verbal clients alone, or a worker has failed to visit, or a worker has failed to provide trauma therapy or any much-needed service. Multiple times a year, our office identifies abuse in foster homes that our clients tell us about; abuse the caseworkers have missed. These are just a few of the things our office does. Our office has been at the forefront in holding DCFS accountable, which is why, I believe, our county has fewer child deaths to report. On behalf of my clients, I am asking that you oppose the president's proposed cuts to my office. It would be devastating to our clients. I am requesting that you approve the budget suggestions from the Chief Judge and the Public Guardian.
