As a real estate practitioner that represents numerous cook county incentive holders and applicants. I am in strongly opposed to this proposed ordinance amendment. There have been numerous recent amendments to the incentive ordinance that have added qualification requirements that are having a chilling effect on the ability of the incentives to attract industrial and commercial businesses to Cook County. For example the addition of the cook county minimum wage requirement to incentives, the expansion of the compliance with laws provision and the expansion of the living wage requirement to tenants (effective 7/1/20) have already created concern about the future viability of the incentives. To now add another hurdle, by requiring that a prevailing wage be paid to construction workers on incentive projects would continue to chip away at the appeal of these incentives. In blighted areas especially building repairs are often done by small mom and pop trades that are able to successfully operate without paying prevailing wages. This amendment would discourage incentive owners from maintaining their properties if needed repairs could not be done cost effectively. The incentives were created to be a simple manner to attract businesses to distressed areas and to allow cook county to compete with neighboring counties with much lower real estate taxes. Over the years we have taken what used to be a simple straight forward process and have made it so expensive and complicated that many prospective investors have already decided to invest their real estate dollars in other counties. The commercial and industrial vacancy rates in the blighted areas are at all time highs. We need to stop making the incentives so unattractive and difficult to qualify for if our intent is for the incentives to be used to revitalize these blighted areas.
