The Workers Center for Racial Justice (WCRJ) is a grassroots organization fighting for Black Liberation, economic justice, and a fair and inclusive society. We strongly support the proposed resolution by the Cook County Board of Commissioners (CCBC) for the Human Relations Committee (HRC) to hold a hearing on the issue of equitable availability of clean, safe and affordable drinking water for all residents of Cook County. WCRJ recognizes fair water access as a human right, and locates the issue at the intersection of racial, economic and environmental justice. Residents of poor and predominantly Black suburbs of Cook County currently pay up to six times as much for drinking water as their wealthy and majority-white counterparts. The inflated prices that Black communities pay, in effect, subsidize the drinking water in white towns and suburbs. This inequity follows a historical pattern in which black communities are systematically exploited of financial resources and denied fair access to public services. In order to ensure equal water access, WCRJ calls for an HRC Hearing on water availability and infrastructure, and recommends greater oversight and regulation of interagency water sales, water billing mismanagement and municipal rate limits.
