Re: Good Food Purchasing Policy- Resolution 18-1650

Cook County Farm Bureau® participated in the Chicago Metropolitan Agency for Planning's Go To 2040 comprehensive planning process and was an active member of the Local Foods Task Force. The Task Force was charged with investigating and drafting the Local Foods section of the Go To 2040 comprehensive plan.

Regarding Resolution 18-1650, the resolution provides that the Good Food Purchasing Standards would emphasize "Environmental Sustainability- support producers that employ sustainable production systems that reduce or eliminate synthetic pesticides and fertilizers; avoid the use of hormones, antibiotics, and genetic engineering; conserve soil and water; protect and enhance wildlife habitat and biodiversity; and reduce on-farm energy consumption and greenhouse gas emissions."

The above provision is admirable, but it raises several concerns, including:

• It's a misconception that farmers overuse synthetic pesticides and fertilizers. Through technology, such as genetic engineering, farmers have been able to reduce the use of crop protectants. Additionally, technology also allows farmers to selectively apply crop protectants to only the areas where they're needed.

• It's also a misconception that farmers overuse hormones and antibiotics. Antibiotics are administered to animals in a similar manner as to when a doctor prescribes antibiotics to humans- only when medically needed. Additionally, when antibiotics are administered the animal cannot be harvested and the milk cannot be used for liquid milk or processed milk products. All meat and milk are tested for antibiotics before they enter the food system. Antibiotics are an important to tool to treat sick animals.

• Genetic engineering is an important tool for farmers. Through genetic engineering farmers reduce the use of crop protectants,

conserve soil and water, reduce on-farm energy consumption, and reduce greenhouse gas emissions.

• Regarding soil and water conservation, farmers are utilizing cover crops to preserve soil, nutrients, and water. These fields also offer wildlife habitat and enhance biodiversity.
