PROPOSED RESOLUTION

COMMENDING THE VALIANT EFFORTS OF SERGEANT ERIK A. ROEDEL AND K9 OFFICER KELLI

WHEREAS, Sergeant Erik Allen Roedel is a lifetime resident of LaGrange Park, Illinois. He graduated from Southern Illinois University in 1993 with a Bachelor of Science in Administration of Justice. Sergeant Roedel resides in LaGrange Park, Illinois with his loving wife of 23 years, three children Julia, Erik Jr., and Abby. In Sergeant Roedel's spare time he looks forward to spending time with his family, hiking with his dogs and watching sports; and

WHEREAS, Sergeant Erik Roedel pursued his passion to obtain a career in law enforcement and started his career as a Cook County Sheriff Correctional Officer in November 1993; and

WHEREAS, Sergeant Erik Roedel enjoyed his job so much that he began to move up the ladder within the sheriff's department. In 1995 Sergeant Roedel received a promotion and became a Sheriff Police; and

WHEREAS, In 1997 Sergeant Erik Roedel was promoted to the Cook County Sheriff's K-9 Unit Emergency Services Bureau, and in 2007 Sergeant Erik Roedel was promoted to Sergeant in this same unit; and

WHEREAS, Sergeant Roedel loves working in the Canine Unit because there is always a different challenge each day. He also enjoys watching the dogs work because their due diligence never waivers after many years of service; and

WHEREAS, Sergeant Roedel is amazed often as to how the dogs can locate the hidden drugs or the people hiding. He jokes during canine demonstrations that he and his peers have the best job; they get paid to play with dogs all day; and

WHEREAS, Sergeant Roedel has been fortunate to work with multiple canines and bloodhounds. The highlight of his work day is, being able to help find missing people with Kelli; and

WHEREAS, Sergeant Erik Roedel's K9 officer partner Kelli was only 6 month old when they joined together in the spring of 2012. He took her under his wings and trained her to search for missing people and criminal offenders. Kelli who is now 6 years of age obtained her name after Kelli O'Laughlin who was murdered in her home in Indian Head Park. Sergeant Roedel worked the case with his first bloodhound Melanie, and when he got Kelli he asked the family if he could name his new bloodhound after her; and

WHEREAS, Sergeant Erik Roedel and K9 officer Kelli have located and saved numerous lives and caught many Criminals; and

WHEREAS, In 2013 and 2015 Sergeant Erik A. Roedel and K9 officer Kelli received recognition and were awarded the Central Warrants Unit Lifesaving Award at the Sheriff's Employee Awards & Recognition Ceremony; and

WHEREAS, In 2013, Erik A. Roedel successfully passed the Sheriff's Police Lieutenant Written Examination; and

WHEREAS, K9 Kelli is a 6-year-old bloodhound who is certified in man trailing by the National Police Bloodhound Association; and

WHEREAS, On May 23, 2018, Sergeant Erik A. Roedel and K9 officer partner Kelli assisted local law enforcement officers in successfully apprehending mother Mikequera Randolph 24, who was charged with aggravated kidnapping, and was accused of taken off with her own baby during a supervised visit on May 14, 2018; and

NOW THEREFORE BE IT RESOLVED, by the Cook County Board President and the Cook County Board of Commissioners shall recognize Sergeant Erik A. Roedel and K9 Kelli for their outstanding services that they have provided in lifesaving tactics throughout the County.

WHEREAS, NLEN launched its first skilled training program moving forward in partnership with CTA, Chicago Trust, and JP Morgan Chase Foundation in 2013. In addition, Sweet Beginnings; Bee Love products were being purchased at O'Hare and Midway Airports through Hudson News and they launched an education program at the Forest Preserve District of Cook County; and

WHEREAS, NLEN has received numerous awards including the First MacArthur Foundation Award for Creative and Effective Institutions, the prestigious Bank of America Neighborhood Award and the MetLife Foundation Community Partnership Award just to name a few; and

WHEREAS, Brenda Palms Barber raised NLEN's profile with extensive national media coverage with segments on CNN, the NBC Today Show, CBS Evening News with Scott Pelley; and

WHEREAS, Do or Die is a rap group from the Westside of Chicago that consist of members, AK and Belo Zero (originally including N.A.R.D. who is pursuing other opportunities to help new artists succeed). Do or Die was originally a dance group inspired to rap by N.W.A., Dr. Dre, Tupac and Biggie Smalls. Visually, Do or Die's stage performance and presence is unparalleled in the rap game; and

WHEREAS, Do or Die initially experienced mainstream success with their first album "Picture This" which included their platinum single which peaked at #22 on the Billboard Hot 100. This album and single became a big hit and sparked the group's signing by Houston's Rap-A-Lot Records. The album was certified Platinum, and launched the group, as well as fellow Chicago rapper Twista, who was featured on the track, into superstardom; and

WHEREAS, Do or Die went on to release several other charting albums throughout the early 2000's, including 2000's Victory, which featured E-40, Ja Rule, and Outlawz to name a few, and 2002's Back 2 the Game, which peaked at #64 on the Billboard 200 and #25 on the Top R&B/Hip-Hop Albums; and

WHEREAS, In 2007, Belo released a solo EP entitled "The Truth." Do or Die was featured on countless projects from various artists, in addition to touring all over the country, and in 2009, they appeared on Twista's single "Yo Body" off his 2009 album, Category F5; and

WHEREAS, AK continues to make Do or Die music launching his own record label Roundtable Records, and was recently featured on VH1's Hip Hop Honors delivering his verse in honor of the legendary success of James Prince the founder of Rap-A-Lot; and

WHEREAS, Do or Die is consistently working their magic on April 15, 2015, Twista and Do or Die announced that they had completed work on a new collaborative EP together entitled Withdrawal (EP). The EP was released on May 19, 2015 and it contains 6 tracks, including a single entitled "Aquafina", for which a video was released; and

WHEREAS, after more than 20 years in the music industry, Do or Die never forgot the conditions that they grew up in or where they are from. Motivated to be of service in their community, Do or Die participates in a variety of community outreach programs such as speaking at schools and prisons, volunteering at churches, faith based organizations with future plans to open a music studio to provide opportunity to up and coming local artist; and

WHEREAS, The Chi-Lites were formed in Chicago in 1959, originally called the Hi-Lites, and consisted of Marshall Thompson, Creadel "Red" Jones, Eugene Record, Robert Lester, and Clarence Johnson; and

WHEREAS, the Hi-Lites changed their name to Marshall & the Chi-Lites, with the "C" being added to reflect the name of their hometown, Chicago; and

WHEREAS, by the end of 1964 Clarence Johnson had left the group, which ten truncated the name to simply the Chi-Lites; and

WHEREAS, during the ensuing four years, Eugene Record slowly emerged as the group's lead singer, songwriter and producer; and

WHEREAS, in 1969, after signing with Brunswick the previous year, "Give It Away" became the Chi-Lites' first USA national hit single attaining No. 10 in the R&B charts; and

WHEREAS, the follow-up release "Let Me Be The Man My Daddy Was" was moderately successful but another major hit was elusive until "Are You My Woman?" climbed into the R&B Top 10 in early 1971; and

WHEREAS, a succession of Top 10 hits followed commencing with their next release "(For God's Sake) Give More Power to the People" which was the first release to crossover into the pop charts, the ballads "Have You Seen Her" and "Oh Girl", both reaching number one in the R&B charts with "Oh Girl" also achieving the No. 1 slot in the pop charts in the spring of 1972; and

WHEREAS, three Top 10 R&B hits followed for the Chi-Lites: "Homely Girl", "There Will Never Be

Any Peace" and "Toby"; and

WHEREAS, in 1980 the group signed to Carl Davis' CHI-SOUND Records label and in 1982 the Chi-Lites single "Hot on a Thing (Called Love)" reached No. 15; and

WHEREAS, the following year the Chi-Lites' next Top 10 hit "Bottoms Up" came after signing with Larc Records; and

WHEREAS, in 2000 the Chi-Lites was inducted into the Rhythm and Blues Foundation; and

WHEREAS, the Chi-Lites' song, "Are You My Woman", was sampled and featured in Beyoncé's hit song Crazy In Love, winning Grammy Awards for Best R&B Song and Best Rap/Sung Collaboration; and

WHEREAS, the Chi-Lites' song, "That's How Long I Love You", is featured on Jay-Z's The Black Album song "December 4th"; and

NOW, THEREFORE, BE IT RESOLVED that the President and the Cook County Board of Commissioners, on behalf of the residents of Cook County, honors the Chi-Lites for their essential contribution to the cultural health and viability of Cook County.
