In accordance with Sec. 2-77 of the Cook County Code of Ordinances, this note is prepared to convey the fiscal impact of item **Ordinance Amendments provided in Chapter 38, Sections 38-109 through 38-148; the fee Ordinance Amendments provided in Chapter 32 Fees, Section 32-1 in regards to Section 38-144.** As a result of this proposed ordinance amendment, please find below estimated revenue:

Revenue projections are based on the following assumptions:

- New fees effective 12/1/18
- Application fee increased to \$100 from \$50 per cremation permit
- Conference Rental fee of \$100 per hour with a minimum booking period of two hours, and one rental per month

As a result of these Ordinance changes, a positive fiscal impact is projected for the Cook County Medical Examiner fee revenues of \$1,021,000 in FY2019. No additional operating costs are expected.
