My name is Miguel Camacho and I am a leader and member of Cambiando Vidas at Access Living. I broke my neck many years ago after a car accident. Due to my accident, I am paralyzed from the chest down and use a wheelchair. As someone with a physical disability, and as an undocumented immigrant, the obstacles that I face are even more difficult to overcome. Because of my status, access to quality health care has always been a huge barrier. I want to express my extreme disappointment after learning about the Public Charge Rule proposed by our federal administration that would have a huge impact on my life and that of my family. Also, other undocumented immigrants with disabilities like myself who are seeking to adjust their status.

My fear, stress and anxiety is heightened when going to seek the supports and services such as the medical attention that I cannot afford to skip; or when I think of my support system not being available to help me continue being independent. For many people with disabilities, this is a life or death situation. Medical care supports and services should be available to all.

I also, fear being separated from my family and not being there for my daughters who need me as they are still young and growing and not being able to be there for them breaks my heart.
