### Introduction:

Good Morning! The Honorable President Toni Preckwinkle and Cook County Board of Commissioners. I humbly thank you for allowing me to speak with you this morning.

My name is George Medellin, III, the President of Medellin & Associates, Inc.

I am a certified MBE firm, who since 1994 has specialized in providing staffing, diversity recruitment/consulting, project management and human resources consulting services to Fortune 1000 companies and government bodies, locally and nationally.

I come before you today to inform you that we were the MBE partner with Nationwide Credit & Collections, Inc., (NCC), on Contract Number: **1490-13840 C (Debt Collection for the Cook County Health and Hospital System)**, awarded January 21, 2015, but were excluded from performing and eliminated from the contract, without notice.

NCC submitted our Letter of Intent with their proposal and the contract was approved by Cook County; our firm was to receive 30% of this revenue generating contract.

Under Section 34-298 of the Cook County Procurement Code (Contract Administration Procedures), "... contractor's cannot...substitute (MBEs) without prior written approval of CCD, in consultation with the CPO and the user agency...contractor's must negotiate with the (MBE) subcontractor to resolve the problem...the final decision to permit or deny the proposed substitution shall be communicated to the parties in writing by CCD."

This was not done.

My firm has received **Zero** revenue and has not participated on the contract. As a result, our firm suffered substantial financial harm

### The facts are:

- NCC held this contract as the primary debt collection agency for The Cook County Health & Hospital System, with ZERO MBE participation, from 1980 to 2004.
- My firm was certified on September 13, 2013. We were recertified on October 29, 2014
- On or about September 01, 2014, I contacted Frank Bertucci, EVP NCC, and presented the opportunity for NCC and M&A to bid on RFP 1490-13840C (Cook County Hospital Debt Collections).
- On or about September 10, 2014, I met with Frank Bertucci and it was agreed NCC and M&A would
  partner to bid on said RFP. NCC would also take the lead in drafting the NCC's Technical Response (CWDC
  RFP 1490-13840).
- On or about October 03, 2014, NCC/M&A submitted its Technical Response to RFP 1490-13840C, which
  included M&A as one its MBE partners.
- On or about Thursday, November 13, 2014, NCC and M&A participated in an Oral Presentation for RFP 1490-13840. No other MBEs were present.
  - The meeting was chaired by Ms. Shannon Andrews, Chief Purchasing Officer, Cook County.
- On or about January 21, 2015, The Cook County Board of Commissioners awarded the team of NCC/M&A
   a Professional Services Agreement to provide Debt Collection Services for The Cook County Health &
   Hospital System. Contract #1490-13840 C. Frank Bertucci signed in behalf of NCC.
- The contract period is: 2/01/2015 to 1/30/2020.

- On or about January 21, 2015, Cook County Compliance Director, Jackie Gomez, also issued an award letter to M&A.
- On or about January 22, 2015, I called Frank Bertucci to inquire as to when NCC and M&A could meet to
  execute its subcontracting agreement. Mr. Bertucci stated: "I'm going on vacation for 30 days. Call me in 1
  month."
- On or about February 22, 2015, I called Frank Bertucci again to inquire about our subcontracting
  agreement, Mr. Bertucci stated: "I can't speak with you. NCC has retained an attorney. You must speak
  with our attorney."
- From February 22, 2015 to February 01, 2016, NCC and its attorney engaged in unprofessional, insulting, unethical, bad faith, delay tactics and abusive behavior, coupled with intentional obstruction of M&A's repeated requests to provide Project Management and/or Human Resources Consulting services. We were told we could not perform these services. We appealed to The Cook County Compliance department to demand NCC's compliance with its Letter of Intent.
- On or about February 01, 2016, Ms. Jackie Gomez, Compliance Director, chaired a meeting with Frank Bertucci, Joe Gallelli and me. It was agreed that the parties would work in good faith to modify the utilization of M&A to include project management and/or other areas agreed to by both parties. (email from Ms. Gomez dated February 10, 2016).
- From February 09, 2016 to February 17, 2016, NCC (Frank Bertucci and Joe Gallelli) and George Medellin
  met to negotiate areas where M&A could perform services. Subsequently, Frank Bertucci prepared a final
  draft of services M&A would perform.
- On or about March 04, 2016, George Medellin and a business advisor, met with Frank Bertucci and Joe Gallelli to finalize M&A's subcontract with NCC. Upon seeing my business advisor, Frank Bertucci said," we can't do business with you" and walked out of the restaurant followed by Joe Gallelli.
- From March 04, 2016 to February 21, 2018, Mr. Medellin's repeated attempts to contact Mr. Bertucci
  were ignored. There were no notices, letters, emails or calls sent from the Cook County Office of
  Contract Compliance to M&A stating that it was considering removing M&A from this contract. Due to
  the lack of communication. I contacted the Chief Procurement Officer (CPO), Shannon Andrews, and
  requested a meeting with her and Ms. Jackie Gomez, Compliance Director, to understand how we should
  proceed.
- On February 21, 2018, Ms. Andrews, CPO, and her attorney chaired a meeting attended by my attorney,
  my advisor and myself. Ms. Gomez was invited but did not attend. We were informed that NCC
  petitioned to have us removed from the contract and the request was granted by the Office of Contract
  Compliance. We were never notified or provided due process.
- The CPO informed us that our only recourse would be a Freedom of Information Request.

### We humbly request the following actions to be taken by the Cook County Board of Commissioners:

- Launch an immediate investigation into the facts and circumstances surrounding NCC's intentional noncompliance and M&A's removal from contract 1490-13840 C (Debt Collection for the Cook County Health and Hospital System).
- Find NCC in non-compliance and order NCC to pay M&A the sum of \$16,785.50 per month (NCC's financial projections) from the contract award date to the present, or 30% of all fees collected by NCC, to date, whichever sum is greater.
- Immediately reinstate M&A on the current Debt Collections contract: 1490-13840 C (Debt Collection for the Cook County Health and Hospital System).

Dear George Medellin, III:

We are pleased to inform you that Medellin and Associates, Inc. has been certified as a Minority-Owned Business Enterprise ("MBE") by the City of Chicago ("City"). This MBE certification is valid until 2/01/2023; however your firm's certification must be revalidated annually. In the past the City has provided you with an annual letter confirming your certification; such letters will no longer be issued. As a consequence, we require you to be even more diligent in filing your annual No-Change Affidavit 60 days before your annual anniversary date.

It is now your responsibility to check the City's certification directory and verify your certification status. As a condition of continued certification during the five year period stated above, you must file an annual No-Change Affidavit. Your firm's annual No-Change Affidavit is due by 02/01/2019, 02/01/2020, 02/01/2021, and 02/01/2022. Please remember, you have an affirmative duty to file your No-Change Affidavit 60 days prior to the date of expiration. Failure to file your annual No-Change Affidavit may result in the suspension or rescission of your certification.

Your firm's five year certification will expire on 02/01/2023. You have an affirmative duty to file for recertification 60 days prior to the date of the five year anniversary date. Therefore, you must file for recertification by 12/01/2022.

It is important to note that you also have an ongoing affirmative duty to notify the City of any changes in ownership or control of your firm, or any other fact affecting your firm's eligibility for certification within 10 days of such change. These changes may include but are not limited to a change of address, change of business structure, change in ownership or ownership structure, change of business operations, gross receipts and or personal net worth that exceed the program threshold. Failure to provide the City with timely notice of such changes may result in the suspension or rescission of your certification. In addition, you may be liable for civil penalties under Chapter 1-22, "False Claims", of the Municipal Code of Chicago.

Please note – you shall be deemed to have had your certification lapse and will be ineligible to participate as a **MBE** if you fail to:

- File your annual No-Change Affidavit within the required time period;
- Provide financial or other records requested pursuant to an audit within the required time period;
- Notify the City of any changes affecting your firm's certification within 10 days of such change;
   or



File your recertification within the required time period.

Please be reminded of your contractual obligation to cooperate with the City with respect to any reviews, audits or investigation of its contracts and affirmative action programs. We strongly encourage you to assist us in maintaining the integrity of our programs by reporting instances or suspicions of fraud or abuse to the City's Inspector General at chicagoinspectorgeneral.org, or 866-IG-TIPLINE (866-448-4754).

Be advised that if you or your firm is found to be involved in certification, bidding and/or contractual fraud or abuse, the City will pursue decertification and debarment. In addition to any other penalty imposed by law, any person who knowingly obtains, or knowingly assists another in obtaining a contract with the City by falsely representing the individual or entity, or the individual or entity assisted is guilty of a misdemeanor, punishable by incarceration in the county jail for a period not to exceed six months, or a fine of not less than \$5,000 and not more than \$10,000 or both.



### **Executive Summary**

### **Brief Overview:**

In 1980, Nationwide Credit & Collection, Inc. was awarded a contract to collect delinquent patient accounts for Cook County Health and Hospitals System by the Cook County Health and Hospitals Governing Commission.

Subsequent contracts were awarded to Nationwide Credit & Collection for Healthcare patient account collection under the auspices of the Cook County Board of Commissioners. Nationwide Credit & Collection provided continuous and uninterrupted collection services to Cook County Health and Hospitals System(s) from 1980 through 2004.

A major factor in the successful undertaking of accounts placed is an understanding of and familiarity with the unique nature of Cook County Health and Hospitals System patient mix, its systems, management, and personnel.
