


# **Budget Overview**

#### FY2019 Operating Budget by Office




#### Office Under the President are 5% of the County's Operating Budget

# **Key Initiatives**


### **Fiscal Responsibility**



We will continue to control costs both for the Offices Under the President and for the County as a whole through strong fiscal management practices.

Due to our management we have succeeded in:

- Decreasing the County's debt by 11% since 2011
- Realizing the smallest preliminary budget gap for FY19 since 2011



We will continue to manage Health Benefits costs through, among other things:


- The upcoming implementation of a new contract for a Pharmacy Benefits Manager
- The new agreement will decrease the overall cost of pharmacy benefits

### **Fiscal Responsibility**



We are working to improve and consolidate our real estate assets to unlock and maximize the value for all County residents.

- Reducing our operational footprint by over 1 million square feet which includes ٠ demolishing buildings on the Department of Corrections campus and consolidating our warehouses
- Maximizing the return on our assets through lease revenue in FY19 for a **58%** • increase since 2014



### **Innovative Leadership**



Our groundbreaking work with the CREATE partnership will alleviate congestion and delays in our rail system.

- Transforming the 75th Street Corridor to dramatically increase reliability and efficiency of the nations rail infrastructure while spurring local economic development
- Leveraging the County's investment of \$78 million with \$396 million from multiple outside partners to produce an estimated \$3.8 billion in new economic benefits





#### **Innovative Leadership**



We are promoting sustainability in both internal and external projects.

- Partnering with suburban municipalities, other external government groups and NGOs for brownfield redevelopment
- Utilizing a Brownfield Revolving Loan Fund of over \$750K from a grant to redevelop and reuse sites in Bellwood, Maywood, Schiller Park, Franklin Park and other South Suburban communities
- Enhancing County buildings to improve our environmental footprint to reduce our Greenhouse gas (GHG) emissions by 80% by 2050 and water usage by 30% by 2025

We will be promoting transparency of County operations with a new Public Dashboard displaying Key Performance Indicators and related Department metrics for our Policy Roadmap.

- Utilizing indicators and metrics to hold the operations of the Offices Under the President accountable to its targets and program goals
- Providing County residents with a window into how Offices Under the President plan and operate

Our new Office of Research, Operations and Innovation (ROI) will implement data-driven, comprehensive solutions to improve County service delivery and increase workplace productivity.

- Collaborating with stakeholders to identify opportunities for improvement
- Conducting analyses and developing innovative solutions that leverage and maximize existing funding and resources across County operations




#### **Improved Services**



Offices Under the President will expand on its public health, safety and welfare of residents of unincorporated Cook County through rigorous inspections.

- Inspecting all rental units in buildings with four or more units
- Targeting over 5,000 apartment rental units
- Ensuring that residents of unincorporated Cook County have access to units that fulfill the basic standards of living

### **Improved Services**



Offices Under the President will be working to expand our services for M/W/VBE vendors.

- Developing a Mentor-Protégé program in 2019 for the benefit of M/W/VBE vendors to be fully implemented in 2020
- Supplying M/W/VBE protégés with support and technical assistance to increase their economic development, experience and long-term capacities
- Providing mentors with credits towards meeting M/W/VBE contract goals when they utilize a protégé
- The program will be modeled after other successful program such as the Illinois Tollway Partnering for Growth
- As a result of this program M/W/VBEs will be able to successfully perform as both prime and sub contractors

In FY19, Offices Under the President will continue fulfilling our mandates and achieving our goals through existing and new initiatives.

Together all the Offices Under the President have made steps towards building a stronger, more vibrant community for County Residents through structural reforms, economic development, criminal justice, and more.
