WHEREAS, Commissioner Boykin was elected to the Cook County Board of Commissioners for the 1st District in 2014; and

WHEREAS, Commissioner Boykin served as a member of the Board's sub-committee on litigation and as chair of the Human Relations Committee, where he held a number of hearings to advocate for human

rights; and

WHEREAS, Commissioner Boykin has advocated to reduce the gun violence issue plaguing the City of Chicago; and

WHEREAS, throughout his years of public service, Commissioner Boykin has been dedicated to the needs and values of the residents of Cook County; and

WHEREAS, a native of Sunflower, Mississippi, Commissioner Butler was brought to the City of Chicago during the Great Migration by his parents who were searching for wartime jobs; and

WHEREAS, Commissioner Butler grew up in Cabrini-Green projects and attended Washburne Vocational High School; and

WHEREAS, Commissioner Butler is a known soul singer, composer and producer who began performing in church and rose to be an award winning artist; and

WHEREAS, Commissioner Butler is affectionately known as the "Iceman" for his smooth and effortless style seen throughout his music; and

WHEREAS, Commissioner Butler's musical career began with a rhythm and blues music group he and

Curtis Mayfield formed called The Impressions; and

WHEREAS, *The Impressions*' hit and gold record, "For Your Precious Love", is a song Commissioner Butler c-wrote; and

WHEREAS, in the 1960s, Commissioner Butler began his solo career where he had numerous hit albums and songs, including "He Will Break Your Heart", "Find Another Girl", "I'm A-Telling You", "Only the Strong Survive", "Moon River", "Need To Belong", "Make It Easy on Yourself", "Let It Be Me", "Brand New Me", "Ain't Understanding Mellow", "Hey, Western Union Man", and "Never Give You Up"; and

WHEREAS, Commissioner Butler was inspired by the impact of the civil rights movement and he transitioned from life as a soul artist to life as a public servant; and

WHEREAS, Commissioner Butler was elected to the Cook County Board of Commissioners in 1985 for the 3rd district, covering areas from Streeterville, Near North, Bronzeville and as southwest as the Auburn Gresham community; and

WHEREAS, Commissioner Butler cares deeply about the injustices that occur with the residents of Cook County, in particular devoting his energy to health care; and

WHEREAS, Commissioner Butler was instrumental in securing the County's 1115 waiver which has been implemented as CountyCare, a health care option available to the residents of Cook County; and

WHEREAS, throughout his years of public service, Commissioner Butler has been dedicated to the needs and values of the residents of Cook County;

WHEREAS, Commissioner John A. Fritchey (12th District) will vacate his seat on the Cook County Board of Commissioners on November 30, 2018 after eight exemplary years of public service to the residents of Cook County and the 12th District; and

WHEREAS, Commissioner Fritchey attended both grammar and high school in Chicago, after which, he received a bachelor's degree in Economics from the University of Michigan, then a Juris Doctor degree from Northwestern University Law School; and

WHEREAS, following law school, Commissioner Fritchey began his public service work as an Illinois Assistant Attorney General, where he represented the state in both state and federal courts, advocating for victims and their families and representing the state in civil rights claims; and

WHEREAS, throughout his distinguished career in public service, Commissioner Fritchey has been dedicated to the needs and values of the residents of Cook County and Illinois and a stalwart advocate for open and honest government;

WHEREAS, Commissioner Jesús G. "Chuy" García (7th District) will vacate his seat on the Cook County Board of Commissioners on November 30, 2018 after five outstanding years of public service to the residents of Cook County; and

WHERAS, at the age of 10, Commissioner García's family moved to Chicago's Pilsen neighborhood and subsequently Little Village; and

WHEREAS, Commissioner García attended St. Rita High School where he first developed interest in

politics after being inspired by speeches from Rev. Martin Luther King Jr. and United Farm Workers Union leader Cesar Chavez; and

WHEREAS, Commissioner García got his first taste of political organizing when he and fellow students threw a picket line around the old, run downed Atlantic movie theater on 26th Street, which was closed and reopened with upstanding conditions; and

WHEREAS, in 1983, Chicago mayor Harold Washington selected Commissioner García to become the city's deputy water commissioner, followed by a successful election as alderman of the 22nd Ward in 1986; and

WHEREAS, in 1992, Commissioner García ran for Illinois Senate and became the first Mexican-American elected to that post; and

WHEREAS, in 1998, after Commissioner García's time as senator came to an end, he founded the Little Village Community Development Corporation, presently Enlace Chicago, a non-profit dedicated to making a positive difference in the lives of Little Village residents by fostering a safe and healthy environment and championing educational and economic development opportunities; and

WHEREAS, in 2010, Commissioner García was elected to the Cook County Board of Commissioners, followed by a re-election in 2014, of the 7th District, which encompasses many community on Chicago's Southwest Side including Little Village, Pilsen, McKinley Park, Brighton Park, Gage Park, Back of the Yards, Vittum Park, Sleepy Hollow, West Lawn, as well as portions of Garfield Ridge and Archer Heights; and

WHEREAS, Commissioner García championed for significant advancements in the areas of immigrant rights, criminal justice reform, and fair labor practices, from establishing landmark legislation that limits the County Jail's cooperation with Immigration and Customs Enforcement, to leading the passage of paid sick leave and starting conversations on bail reform and inequitable property tax assessments, even when it was unpopular to do so; and

WHEREAS, throughout his years of public service, Commissioner García has been dedicated to the needs and values of the residents of Cook County, always advocating for accessibility to resources and accountability from government actors; and
