I am writing you today as a concerned resident of Cook County, I have a middle schooler at Barrington Middle School, Prairie Campus and my youngest child previously attended the Early Learning Center. I understand the Countryside Fire District would like to purchase the home located in the school parking lot. This is absurd! First and foremost, Countryside Fire District does not even serve this area. I understand they are trying to save money by buying this property from an elderly woman who is moving out of state but this is a time to weigh all interests, not only the interests of a fire district saving money. Student's safety should come first. Second, traffic at this school site is already terrible during pickup and drop-off. The firehouse would only add to this problem and the safety of the resident they are heading to help would be at risk because of the traffic situation. Finally, this location couldn't be worse for a firehouse. The noise of trucks going in and out, the space restrictions that exist there and the disruption to the classroom would be awful. Please do not grant Countryside Fire's request to change the zoning at this site to a firestation. Their desire to save money should not outweigh student's safety. Thank you for your consideration.
