I appreciate that the welfare of citizens is a priority for the department but if a similar tool will be utilized in the future, none of the information previously obtained should be included in this new tool and there needs to be complete transparency regarding the what/when/how/why an individual has been categorized as being affiliated with a gang. Officers need to be trained appropriately and efficiently and the training should extend to interacting with black and brown members of the public while "protecting and serving".
