Cook County

In accordance with Sec. 2-77 of the Cook County Code of Ordinances, this note is prepared to convey the fiscal impact of item #19-2843 Establishing Civil Fees and Criminal and Traffic Assessments to be Collected by the Clerk of the Circuit Court of Cook County.

The ordinance amendment sets forth the fees authorized by The Criminal and Traffic Assessment Act and represents a complete restructuring of the criminal, traffic and civil fees in the circuit courts throughout the State of Illinois; the purpose of the legislation was to consolidate fees into unified schedules throughout the State of Illinois,

Below is a table that represents the average current revenue per cast type category and the estimated new revenue per under the unified schedule model that is allocated to the Clerk of the Circuit Court's Special Purpose Funds:

The changes to the Criminal and Traffic Assessment Act represent a complete restructuring of the criminal, traffic and civil fees in the circuit courts. Fees have been increased, reduced or completely eliminated in an effort to consolidate fees into unified schedules. The estimated net increase in General Fund revenue of \$10.7 million is 93% comprised of revenue shifts from the fees below.

These revenues are based on the volume of cases coming through the County's court system. The caseload has been declining in recent years and will change subject to any further legislative changes at the State Level. Hence, as the volume of cases continues to fluctuate, the revenue associated with these fees will follow a similar trend.
