WHEREAS, on April 27, 2019, Almighty God in His infinite wisdom called Dominic DiFrisco from our midst; and

WHEREAS, Dominic DiFrisco was the beloved husband of Carol (nee Loverde) and loving father of Nina (Robert) Mariano; and

WHEREAS, Dominic DiFrisco was the proud grandfather of Pasquale Gianni and fond brother of Carmela Soricelli of New York and Louisa Termini of Texas, and uncle and godfather to many; and

WHEREAS, when the Italian-American community was at risk of losing one of its cornerstones-Our Lady of Pompeii Church-Dominic and other Little Italy community members bound together to raise money to save the church, personally petitioning the late Joseph Cardinal Bernardin to allow the church to remain open; and

RESOLUTION HONORING CHICAGO'S HISTORIC LEGACY WALK

WHEREAS, The Legacy Walk is a dynamic outdoor LGBT history exhibit in Chicago's Lakeview neighborhood; and,

WHEREAS, Along the half mile of the North Halsted Street Corridor, between Belmont Avenue and Grace Street, ten pairs of 25'-tall decorative "Rainbow Pylons" define the nexus of Chicago's LGBTQ community; and,

WHEREAS, Affixed to the pylons are a series of bronze memorial plaques commemorating the life and work of notable lesbian, gay, bisexual, or transgender individuals whose achievements have helped shape the world - but whose contributions, sexual orientation or gender identity have been overlooked, minimized or redacted entirely from most historic texts; and,

WHEREAS, presently there are forty bronze markers on the Legacy Walk - the largest collection of detailed bronze biographical memorials in the world - and every year on National Coming-Out Day

(October 11th) new plaques are added; and,

WHEREAS, Collectively the Legacy Walk serves as an "outdoor classroom" for students who participate in the Legacy Project Education Initiative (LPEI) to boost LGBTQ youth self-esteem and confront the ignorance which fuels anti-Gay bullying; and,

WHEREAS, The Legacy Walk was recently declared a Historic Landmark by the City of Chicago Commission on Landmarks.

NOW, THEREFORE BE IT RESOLVED, that during Pride Month 2019, the Cook County Board of Commissioners commends the work of the Legacy Project - especially its founder Victor Salvo and its board of directors - for creating an iconic installation celebrating the lives and stories of LGBTQ people throughout history.

PROPOSED RESOLUTION

A RESOLUTION REMEMBERING LGBTQ HISTORY IN COOK COUNTY

WHEREAS, the month of June is recognized as LGBTQ Pride Month; and

WHEREAS, the LGBTQ community across the United States remembers and honors the legacy of LGBTQ people at The Stonewall Riots on the 50th Anniversary; and

WHEREAS, there is also a rich and important LGBTQ history in Cook County that must be remembered; and

WHEREAS, the Gerber/Hart Library and Archives located in Chicago is a vital partner in preserving and displaying the history and artifacts of local LGBTQ history; and

WHEREAS, Tracy Baim, long time publisher of Windy City Times and other LGBTQ publications, has been essential in documenting the lives, photographs, and news of the LGBTQ community for decades including in her book, Out and Proud in Chicago: An Overview of the City's Gay Community; and

WHEREAS, Victor Salvo created The Legacy Project and The Legacy Walk, an outdoor history exhibit in the Boystown neighborhood of Chicago to commemorate the lives and work of prominent LGBTQ people who contributions or identities were overlooked by most historic texts; and

WHEREAS, the Society of Human Rights, the first recognized gay rights organization in the United States, was founded in 1924 by Henry Gerber in Chicago, Illinois; and

WHEREAS, prior to the Stonewall Riots in New York, similar raids by law enforcement including Cook County Sheriff Richard Ogilvie, were conducted; and

WHEREAS, one of the most prominent examples was a raid of a well-known LGBTQ establishment called Fun Lounge, located in suburban Cook County, in which 109 patrons were arrested on April 25, 1964; and

WHEREAS, those arrested were paraded in front of newspaper photographers. The names and occupations of those arrested were printed on the front page of local newspaper even though charges of over 90 people were dropped because of insufficient evidence of any kind; and

WHEREAS, the controversial printing of names and occupations led to the firing of many of those that were in teaching and school administrative roles; and

WHEREAS, this raid was a galvanizing moment for LGBTQ people in Cook County to organize politically against those fighting for their right to live openly; and

WHEREAS, in 1968, the North American Conference of Homophile Organizations hosted a conference in Chicago where they drafted the "Homosexual Bill of Rights", which included basic tenants of LGBTQ people being able to live their lives without fear of harassment or retribution; and

WHEREAS, Jim Flint became the first openly LGBTQ person to run for the Cook County Board of Commissioners in 1987; and

WHEREAS, in 1993 the Cook County Board of Commissioners passed an amendment to the Human Rights Ordinance that included sexual orientation as a group protected from discrimination; and

WHEREAS, the Ruth M. Rothstein CORE Center was founded by Cook County Health and Rush University Medical Center in 1998 and has pioneered treatment and care for HIV/AIDS; and

WHEREAS, there are countless other examples of battles fought by the LGBTQ community in Cook County and paths paved by LGBTQ people willing to stand up for their community; and

WHEREAS, all of this history has shaped the LGBTQ community in Cook County and led to advancements of living lives openly and authentically; and

THEREFORE, BE IT RESOLVED, that we, the Cook County Board of Commissioners do hereby honor the LGBTQ community during Pride Month and remember the history of the LGBTQ community in Cook County; and

BE IT FURTHER RESOLVED, that we honor the great contributions that LGBTQ people have done across Cook County; and

BE IT FURTHER RESOLVED, that suitable copies of this resolution are presented to the Gerber/Hart Library and Archives, Tracy Baim, Victor Salvo and Jim Flint.

CELEBRATING THE HONORABLE KIMBERLY A. LIGHTFORD AS THE FIRST AFRICAN AMERICAN FEMALE ILLINOIS STATE SENATE MAJORITY LEADER

WHEREAS, Senator Kimberly A. Lightford was born in Chicago, Illinois on May 10, 1968; and

WHEREAS, Senator Kimberly A. Lightford was raised in Maywood, Illinois and graduated with a bachelor's degree in Public Communications from Western Illinois University and a master's degree in Public Administration from the University of Illinois Springfield; and

WHEREAS, prior to being elected to public office, Senator Kimberly A. Lightford gained extensive management experience working as a Trustee for the Village of Maywood and for State of Illinois departments such as the Illinois Department of Central Management Services, the Illinois Department of Corrections and the Illinois Secretary of State's office; and

WHEREAS, in 1998, Senator Kimberly A. Lightford became the youngest African American female elected to the Illinois State Senate representing the 4th District. Senator Lightford has become a vocal champion for promoting quality education, advocating for quality healthcare, and providing support for working families; and

WHEREAS, Senator Kimberly A. Lightford became Assistant Majority Leader in 2009 and enhanced her role as an advocate for education reform. Senator Lightford has served on the Senate Education Committee as either a sitting member, Vice Chair or Chairman. Her expertise positioned her as a lead negotiator on the legislation that established stronger methods of evaluating teachers and tracking student progress; and

WHEREAS, on January 9, 2019, Senator Kimberly A. Lightford was appointed as the Illinois State Senate Majority Leader, making her the first African American female to hold the position and among the highest-ranking elected officials in state government; and

WHEREAS, Senator Kimberly A. Lightford currently serves as Chair of the Assignments Committee and a member on Committees such as the Committee of the Whole, Education, Energy and Public Utilities, Executive, and Executive Appointments. She is also the Sub-Chairperson for the Special Committees on Government Operations and Charter Schools and a member on the Special Committees on Supplier Diversity and Oversight Medicaid Management Care; and WHEREAS, due to her leadership, Senator Kimberly A. Lightford has helped to pass laws that provides universal preschool programs and makes sure that all children start school at six years old. Senator Lightford has also improved the safety of children by providing specialized bullying prevention curricula and no bullying school zones; and

WHEREAS, Senator Kimberly A. Lightford has worked to improve the quality of life for working families by passing legislation such as the Illinois Equal Pay Act, the African American Equal Pay Act, reforming the Payday Loan Industry, and raising the minimum wage in Illinois to \$15 dollars per hou; and

WHEREAS, in addition to advancing a progressive legislative agenda, Senator Kimberly A. Lightford has led efforts to rebuild The Loretto Hospital in the Austin community. Senator Lightford secured more than \$20 million in funding that helped the hospital build a state-of-the-art emergency department, a pharmacy and remodel all bed space. Due to her efforts, The Loretto Hospital renamed their emergency department to The Kimberly A. Lightford Emergency Department; and

WHEREAS, in the 19th century, libraries were acknowledged to be an indispensable part of community life as promoters of literacy, providers of a wide range of reading for all ages, and centers for community information services. Legislation required local authorities to devote public funds to this cause, and

WHEREAS, librarians, also known as information specialists, use their professional skills to connect resources and information to the public community through reference and research services, collection development, programming, technology and media platforms, and

WHEREAS, Cook County has approximately 205 libraries serving an estimated population of 5.3 million; and

WHEREAS, Cook County's libraries are places of information and have risen "beyond the book." They are an extension of the educational institutions in Cook County and are one of the our most important resources that build communities, provide access, promote literacy, protect individual rights and innovate; and

WHEREAS, every summer, most Cook County libraries have adopted a theme for Summer Reading Club where children, teens and adults win small prizes to encourage reading during the summer months. Summer Reading Club takes place for approximately 8-10 weeks (June - August) and starts when the regular school session ends, and

WHEREAS, libraries offer a variety of weekly themed-programs for all ages and patrons receive points and prizes for reading a certain number of books or for a certain amount of time. On average, 2.5 million patrons read 25 million books and attend over 10,000 summer programs offered by 205 Cook County libraries, and

NOW, THEREFORE, BE IT RESOLVED that the President and the Cook County Board of Commissioners, on behalf of the residents of Cook County, honor Cook County libraries for encouraging youth participation in summer reading clubs and community activities at libraries across Cook County and praise its essential contribution to the communities of Cook County by going "beyond the book" for
