- Thank you Chairman Suffredin and Board of Commissioners
- I want to start by thanking President Preckwinkle for nominating me as Bureau Chief of the Cook County Bureau of Economic Development. I am very grateful for this opportunity and realize that this role carries a significant responsibility to create vital communities where both businesses and residents can thrive.
- 8 years ago, I joined President Preckwinkle's administration and helped establish the Bureau of Economic Development so the County would have a voice at the economic development, planning and policy tables. Since then, I have held a number of senior management positions in the County where I have consistently developed, designed and implemented organizational efficiencies and strategies that have made Cook County government more efficient, transparent and accountable. I have enjoyed serving as the County's internal consultant and have been fortunate to work in an administration that challenges us to assess and reinvent how government functions for our constituents.
- In some respects, returning to the Bureau feels like "returning home."

- This strategy may sound both ambitious and obvious at the same time but will require new crosscutting, integrated and inclusive approaches both within the Bureau, with our partners in communities. We face increasing needs and limited resources. Challenging times requires us to evaluate our current ways of operating and find ways to do things better, more cohesively and more efficiently.

- Inspiring county employees to continuously improve their performance is something that I helped institutionalize through the establishment of the County's new Office of Research, Operations and Innovation. I appreciate the talent and dedication of the Bureau's staff and am excited to embed a philosophy of service and continuous improvement into the Bureau of Economic Development's operations.
- Over the next year and a half, the Bureau will play a key support role in the 2020 Census. We will be assisting the Cook County Complete Count Commission and President Preckwinkle with this vital work that impacts the life of every resident of our County. Census date provides the basis for the allocation and distribution of billions in federal funds to local communities in areas such as transportation, healthcare and affordable housing. An accurate census helps ensure that the County receives its share of the funding to needed to serve our residents. It is important that we all work together to ensure every resident of Cook County is counted.
- I realize that I have an ambitious vision for the Bureau, and I recognize this work cannot be done alone. I look forward to a collaborative partnership with each of you to promote vibrant communities that thrive. I thank you for your consideration of my appointment.
