Additionally, for over 28 years, IHC has operated a toll-free, statewide Hunger Hotline where callers can get assistance in completing applications and redeterminations for SNAP, medical, and other benefits, find local food pantries and meal

programs, and receive information and referrals for other services. The rules set forth by the HRC create clear guidelines for housing providers and applicants to ensure that people with records and their families get a fair and equitable chance in the housing application process. Specifically, the rules provide a three-year lookback period for convictions, a hold on a housing unit during the time that an applicant wishes to dispute a denial based on a background, and a timeline that gives applicants a meaningful opportunity to provide relevant information to the landlord. While Illiinois Hunger Coalition is an anti-hunger organization, we understand that just like access to healthy food is a human right, so is safe, secure, and healthy housing access. On our state-wide Hunger Hotline, we often receive calls from people facing tough times that need help finding access to food and housing. We know that individuals that are reentering the community face extra barriers to finding safe, stable housing. Therefore, the Illinois Hunger Coalition stands in support of Just Housing Amendment as a critical way to break down those barriers.
