On March 22, 2020 I called to check on my mother the nurse Jennifer said she was fine didn't have a fever and she just fed her. That was not true my mother laid in the bed from March 22 -25 2020 didn't; eat while the nurse was lying to me on the phone (I have pictures of my mom laying in the bed) finally I felt something wasn't right when I went to see her at the facility on March 23, 2020 the nurse told me she was sleeping I told them to get her up and let me see her. The corporate nurse Denette brought my mother to front she was crying (which I have a video of her crying) I kept asking what wrong my mother has dementia so she couldn't express herself. I ask the nurse Denette do my mother need to go to the hospital I said to take her to the hospital the nurse Denette say you don't want her to go to hospital where the sick people are, on Wednesay March 25, 2020 I got a call from the nurse telling me that my mother was being rush to Loyola hospital with chest pain. When my mother arrived at the hospital her was fever over 102, heart rate 130 and need oxygen and severe dehydrated. My mother was place on a ventilator for 4 days. The doctor inform me my mother has covid 19 virus. I was furious left in the dark like the other familys members by the Adminstrator Libby Ruskin, Director of Nursing Joe Tejeck and Corporate Nurse Denette Temple and the Infection disease coordinator Kim. This was a malicious act and abuse and neglect torward my mother and the other residents reside at Sava Westchester Health Rehab. I talked to a former nurse from the facility which was working at the faciality at that particular time she informed me that she brought concern about the virus being in the building to the Adminstrator Libby and Director of Nursing Joe which the cna informed her she had symptoms of the virus (which I have a sign and written statatment from her) the nurse brought to the Adminstor Libby attention on March 13, 2020 the cna worked on unit 2 that day and had the symptoms of the virus and Libby told her to let her work and the nurse told her to go home . The nurse was override by the Libby and Joe .The cna had the covid 19 virus was my mother cna as well as the other residents on Unit 2. in result of this nelgient of the Administrator Libby 16 people had died and 43 cases of the Covid 19 virus and growing at Sava Westchester Health and Rehab. I asking for IDPH, State Attorney, Cook County Public Health and

Attorney General to conduct full investigation on the Mangement Staff and the faclity and place Sava Westchester Health and Rehab under recevership and bring in new staff to help the residents at the facility to obtain the proper care and not be nelglect and lived their lives abuse free. The facility is always short staff the resdients is receiving proper showering with resulted in bedsores and rashes and not getting properly feed and not getting the service that Medicare and Medicare or private insurance paying for the service. Sava Westchester Health Rehab in findings from IDPH is more violations and death and abuse and nelgect under this Administration and the Administrator Libby Ruskin.
