Truly, it is during a disaster that the people of this great republic need their representatives doing the job they were elected to do the most. The County Board has the means to meet and conduct business despite hardships caused by the stay-at-home guidance.

In a Sun-Times article, the rationale given by a sponsor of the extension was that said commissioner wanted to make his job easier. "... if all you're doing is doing things in 30-day increments, some of those things are harder to do. I think this is more prudent."

With respect, Commissioner, you were elected to represent the people of your district, not to yield your voice and vote to the President because things got tougher than you anticipated.

There was another quote from a Commissioner which I found disturbing - "Power grabs are fun when having the power makes you really important, but a power grab in a pandemic just gives you more responsibility and stress," Under normal circumstances, I might give the commissioner the benefit of the doubt that this was said in jest, but these are not normal circumstances. Your responsibility, your mandate, comes from your constituents, not through "fun power grabs" that make you "really important".

Please, commissioners, do the jobs you were elected to do. Should you decide to move forward with this extension, you are essentially declaring your role and responsibility in this as "non-essential" which might call into question why you were elected. Yielding your responsibility is also as much a disservice to President Preckwinkle as it would be the people of Cook County. Engage as you should in the dialog and process that is expected of your position. Don't abandon her to carry the burden.
