Because there is no way to know if any person has been exposed, contracted, or could transmit COVID-19, the best practice for all first responders and essential workers is to assume any and every person they encounter could be carrying COVID-19, including their colleagues. Universal precautions will make sure first responders are in the best position to protect themselves and the communities they serve.

Second, this policy has the potential to deter people from seeking care. It is clear the SAFE with First Responders Resolution will cause residents to fear that the state will not only store, but will distribute, their private health information. For communities that have experienced HIV stigma and systemic racism – either separately or in conjunction – this resolution will further erode the little trust in existing systems. This Resolution is another step away from trust for the communities who need care the most right now.

Third, and finally, the SAFE with First Responders Resolution has the potential to harm the civil liberties of every Cook County resident. The collection, storage, and sharing of private information, especially private health information, must be done only for significant public health gains, and implemented with the utmost care and in a limited fashion. This Resolution does the opposite. Sharing this information does not benefit the public, and it has the potential to create further disparities in care and in the impact of the pandemic. We have seen the deadly effects of first responders acting out of fear – especially in Black communities. Passing this Resolution invites a new metric of fear and will augment the harm that Black and Latinx communities experience based on racist assumptions and stereotypes.

We know that our first responders are saving lives and strengthening our communities every day. We also know that their work comes with the potential of both harm and healing – to themselves and others. The proposed resolution does not offer them any greater protection, but it does pose great risk to the safety and privacy of every member of our community. I am writing to you about an urgent issue surrounding public safety in Illinois during this coronavirus outbreak.

I am urging you to immediately amend and/or suspend the HIPAA requirements in order to be notified of a residents' address when they are confirmed to have Covid-19.

As you may know, the Attorney General in Illinois already weighed in on this issue and said that law enforcement is able to receive this information.

I am not asking for any personal information such as names, dates of birth, sex or any other identifiers. All I want released are the addresses where they will be recovering so we can provide a safe environment for our officers and firefighters.

There is an exception to the general rule which states no consent is required if disclosure is necessary to prevent or lessen a serious and immediate threat to the health or safety of a person or the public, and is to a person or persons reasonably able to prevent or lessen the threat, 45CFR.164.512I1I.

The bottom line is disclosure to first responders will enable them to use personal protective equipment (PPE) to reduce the risk of COVID-19 transmission, so the exception we believe absolutely applies.

I am asking you to take immediate action on your executive order to address this issue for the greater public safety in Illinois. I am only asking for this information to be released during the pandemic. Once the pandemic is deemed to have subsided, the rule could be instituted once again.
