Esteemed Commissioners,

My name is Marvin Wickware. I write to you as a member of the faculty of the Lutheran School of Theology at Chicago and a resident of Cook County. I offer testimony in support of the Justice for Black Lives resolution, Resolution 20-2867, encouraging you to pass this resolution.

Here on the South Side, in particular, our communities cry out for their elected leaders to respond to their needs. They cry out for jobs that pay a living wage, for accessible healthcare (including mental healthcare), for affordable and secure housing, for reliable transportation, and for safety. At best, policing and incarceration can address only the last of these needs, and yet the people of our communities cry out most loudly of all to be saved from the systems of policing and incarceration that tear their communities apart.

As Christian theological educators, my colleagues and I find that our faith calls us to respond to those cries. We stand with faith communities and theological schools throughout the county when we amplify the cries of our communities, that those cries might impact public policy. Beyond passing this resolution, then, I urge you to promote safety in our county by passing a budget that moves money out of policing and incarceration, and expands the County government's essential funding for housing, anti-violence programs, and restorative justice.

On a final, personal note, I name that I also write to you as the son of a black man who served for 26 years as an Indiana State Trooper. I witnessed firsthand the kind of compassionate, protective presence that a police officer could have in his community. I am also clear, however, that when my father was at his best as a police officer, caring for the vulnerable and offering compassion to those he encountered, it was despite the policing apparatus that surrounded him, not because of it. Our county is full of fiercely protective, compassionate souls and it is my hope that we will work to give them more opportunities to care for our communities that do not involve tearing our communities apart through policing and incarceration.

Hands To Help Ministries supports taking money out of the Cook County Jail and the Cook County Sheriff's budget and putting that money into public services such as health care, mental health, restorative justice, housing, job creation, etc. As a ministry servicing those who are homeless or at risk of becoming homeless on the Northwest Side of Chicago, we are acutely aware of the lack of funding available for serving those in need of affordable housing, as well as many who suffer from substance abuse and mental health issues. We oppose money flowing into the criminal justice system simply because we do not adequately support those who are in need of social services that have been cut.

In addition, we oppose the systemic racism that exists in this budget that adversely affects the poor and people of color. Policing and incarceration are not keeping our communities safe and are instead causing violence towards Black people and other people of color. The Cook County Jail is mostly used to lock people up who have not yet had their trials and should be considered "innocent until proven guilty" but are kept in cages because they are poor. Many people are jailed because they can't afford to pay the money bails set by judges.

Creating real community health and safety will require funding public services such as health care, mental health, housing, jobs, restorative justice, and more. Cook County Health is the primary provider of health care for low-income people in the county, and the County government also provides funding for housing, anti-violence programs, and restorative justice, so the County could make good use of funding removed from the Sheriff's budget to provide crucial services and investments in communities of color harmed by violence, policing, and incarceration.

Supportive services that promote community health and safety such as mental health care, treatment for substance use disorder, and housing should be provided by the County departments that specialize in those areas – Cook County Health, the Housing Authority of Cook County, and community-based organizations funded through the Justice Advisory Council – and not by the Cook County Sheriff, which has expertise in policing and incarceration, not supportive services. Mental health care should be provided outside of the jail, not inside it.

Hello, I am Rev. Ben Adams and I serve the South Loop Campus Ministry and Holy Trinity Lutheran Church in Chicago and I am offering

testimony in support of the Justice for Black Lives resolution, Resolution 20-2867. It is urgent that the County Board to pass this resolution and then follow through by actually moving money out of policing and incarceration and into the things that actually work to build strong, healthy communities like housing, health care, and good jobs. While the narrative we often hear is that police and prisons are keeping us safe, the reality is that policing and incarceration have destabilized and destroyed our communities through punitive, not restorative measures. In a time when COVID-19 has ravaged our black and brown Chicagoans the most, and with the Cook County Jail being one of the hottest spots in our city for cases of the coronavirus, this is not just a justice issue, it is a racial justice issue. This pandemic has shown us all how interconnected our communal health really is. Years of racist segregation and under-investment in the South and West side have exposed how vulnerable to disaster we are as a county when we write off segments of our community. Therefore, supportive services that promote community health and safety such as mental health care, treatment for substance use disorder, and housing should be expanded and provided by the County departments that specialize in those areas - Cook County Health, the Housing Authority of Cook County, and community-based organizations funded through the Justice Advisory Council – and not by the Cook County Sheriff, which has expertise in policing and incarceration, not supportive services. Mental health care and housing should be provided outside of the jail, not inside it. This expansion is possible through a disinvestment from policing and incarceration and a reinvestment in community. After all, if the jail budget had gone down by the same percentage as the number of people locked up since 2013, the County would have \$117 million to fund health care, housing, jobs, restorative justice, and more. Just think of what \$117 million could have done for our most vulnerable communities!

Illinois Business Immigration Coalition's partnership with the Cook County Recovery Initiative to provide Technical Assistance has since April 2020, delivered \$6.1 M in PPP to 297 minority owned businesses in Suburban Cook with an average grant of \$20,538 for restaurants, barber shops, nail salons, child care centers, mom and pops. Our other partners included the Illinois Restaurant Association, National Partnership for New Americans and Self Help Second Federal Credit Union. IBIC focused on one-on-one outreach, follow-up and coaching in personal calls along with Zoom and Webinars. The County's investment in technical assistance has lifted up small businesses, working families and Black and Brown communities with resources and support to maximize their fair share of lending, grant and contract programs operating with equity requirements. According to the National Bureau of Economic Research, while 22% of all small businesses have closed across the country, 41% of black owned businesses and 32% of latino owned businesses have closed due to covid. Conversely, more than 60% of large firms with sales over \$2 billion expect sales growth to accelerate — 49% expect a significant pickup. Absent targeted and accountable technical assistance exemplified by Cook County's Economic Recovery Initiative, the gap between the rich and poor will grow and black and brown businesses will disappear.

We learned 2 key lessons from the PPP. First, businesses that tend to benefit from government programs are sophisticated, well resourced firms with accountants and attorneys. Poor, less capitalized, un-banked or under-banked, isolated geographically or linguistically are left out. Second, community organizations closest to businesses of color do not have the training or capacity to support these businesses to access government programs. So building a network of community based organizations in a technical assistance infrastructure will be necessary in economic recovery, reducing poverty, and building wealth.

We thank President Toni Preckwinkle, and Director Xochitl Flores for their foresight and leadership to support our most vulnerable businesses and their workers. We hope the commissioners would continue and expand upon this work

My name is Erik Christensen. I serve as pastor to the community and director of worship at the Lutheran School of Theology at Chicago and am a leader in the faith liberation movement of The People's Lobby. I am also a resident of Cook County's 12th district, living in the Albany Park neighborhood of Chicago. I am writing in support of the Justice for Black Lives resolution, Resolution 20-2867, to encourage the Board of Commissioners to pass this resolution.

Having served as a pastor in the city of Chicago since 2006, first in Logan Square and now in Hyde Park, I know the stories of friends and neighbors who have struggled to find work that pays a living wage, who have suffered because they lacked access to quality healthcare, who have been displaced by gentrification and the disappearance of affordable housing, who live in fear of harassment by or violence from those entrusted with public safety.

My faith tradition compels me to seek relief for the poor, release for the captives, and liberation for the oppressed.
