My name is Ben Adams and I am a Pastor in the City of Chicago with Holy Trinity Lutheran Church and the South Loop Campus Ministry. I am writing in favor of the Justice for Black Lives Resolution. As a person of faith I am compelled to proclaim release to the captives, and this resolution is a big step towards that end. We have problems in our city and so far, criminalization and incarceration have not solved them. We need new alternatives, and now with the threat of even more federal troops deploying to our Chicago streets, we are doubling down on violent enforcement with no talk of restorative measures. That is, until this resolution has come up that takes concrete steps to take money away from our institutions that have been hurting our communities more than helping them.

Especially with COVID-19, the Cook County Jail especially has been a place of pain as it has been one of the hottest spots for the virus. That is why I urge the County Board to pass this resolution and then follow through by actually moving money out of policing and incarceration. This money could be then used to create real community health and safety by funding public services such as health care, mental health, housing, jobs, restorative justice, and more.

Cook County Health is the primary provider of health care for low-income people in the county, and the County government also provides funding for housing, anti-violence programs, and restorative justice, so the County could make good use of funding removed from the Sheriff's budget to provide crucial services and investments in communities of color harmed by violence, policing, and incarceration.

We know that the Cook County Sheriff's full budget for 2020 is \$608 million – a 33% increase from 2013. The Cook County Department of Corrections (the jail) budget is \$336 million - an increase of 26% since 2013. This increase in spending is despite the fact the number of people locked up in the jail has gone down by 50% in the last seven years. If the jail budget had gone down by the same percentage as the number of people locked up since 2013, the County would have \$117 million to fund health care, housing, jobs, restorative justice, and more. Thank you for taking to heart my testimony and hope to see this resolution pass on Monday!

My name is Julie, and I am a member of Nikkei Uprising, a Japanese American activist group in Chicago fighting for a future with no cops, no camps, no cages. I am giving this testimony representing Nikkei Uprising in support of Resolution 20-2867, the Justice for Black Lives resolution, to demand that the Cook County Board defund the sheriff's office and Cook County Jail, and redirect that money to resources for the communities most violently impacted by these systems so that they can live safe, healthy, empowered lives.

Many of us at Nikkei Uprising are descendants of Japanese people who were incarcerated during WWII due to white supremacist ideologies that criminalized our community. Over 120,000 Japanese Americans were sent to concentration camps, and 1,500 detainees died in camp due to disease and lack of proper medical care.

The historical trauma of having incarceration of innocent people leading to a death sentence reminds us of the current public health crisis and why we say Free Them All/Defund the Sheriff's office and CCJ; on July 17, the Cook County Jail prison population was at its highest point since March, and growing simultaneously with the number of COVID-19 cases in the state. While the Sheriff is congratulating himself for what he considers tackling the issue, justice has still not been served for loved ones of the inmates who died from COVID-19 in CCJ from lack of safety and medical care in the earlier stages of the pandemic, and people currently incarcerated report that protective equipment isn't being distributed, forcing them to re-wear single use masks.

An outbreak in Cook County Jail was completely preventable. Cook County Jail is mostly used to lock people up pre-trial, who should be considered "innocent until proven guilty" but are kept in cages often because they are Black and poor, and can't afford to pay bail. During May and June, the number of weapons-related offenses was the highest since January 2014, and about a quarter of those people arrested were still in jail pre-trial as of July 14 due to the inability to pay \$3,400 in bond to be released.

Nikkei Uprising stands against putting people in cages, period. The safest communities have the most funding for resources. Cook County has not become safer by locking people up- it will become safer, and a place where people can not only survive but THRIVE, when it puts the hundreds of millions of dollars spent on terrorizing Black and brown communities into schools, childcare, healthcare, housing, restorative justice programs, living wages, and street outreach workers in the most disinvested parts of the city. Because of this, Nikkei Uprising supports the Justice for Black Lives resolution, urging the Cook County Board to redirect funding from the Sheriff's office and CCJ to programs and services that support Black communities and other communities of color.

Madam President and Commissioners of the Cook County Board,

I appreciate this opportunity to provide public comment on Commissioner Johnson's "Justice for Black Lives" resolution. I took particular notice of this resolution and its stated policy goals, both as a constituent of Commissioner Johnson's from the 1st District, and the Executive Director of the Greater Chicago Legal Clinic, a legal services nonprofit dedicated to improving access to justice for residents of underserved communities.

Those of us in the legal aid field are all too familiar with the systemic inequities that Commissioner Johnson's resolution details-especially the structural racism with roots in slavery and Jim Crow that has given birth to generations of implicit bias in policing throughout the nation. The manifestation of this bias in Chicago by Commander Jon Burge and the culture of terror and collusion with prosecutors and the judiciary that allowed him to flourish gives our city and County a particularly dark legacy to confront.

At GCLC, our mission is to work to counteract this dark legacy by increasing access to justice. This means many things for us, including

- Providing a safe space for immigrants to obtain legal advice and representation at a time where they are being targeted and terrorized by the current administration in Washington;
- Providing representation and legal advice at the Leighton Criminal Courthouse for applicants who seek to expunge and / or seal their arrest records and, in so doing, increasing their opportunities for employment and a return to meaningful participation in society.
- Running several free legal advice desks in our courthouses as a resource for individuals who cannot afford an attorney in civil proceedings and are forced to represent themselves against larger, wealthier entities such as banks and corporations.

As anyone who engages in the work of social justice and reform can attest- this is difficult work that requires a commitment for the long haul, in the face of inevitable setbacks and challenges. That is why experienced and long term advocates of criminal justice reform and social policies are so valuable in this fight.

That is why, in weighing this resolution and the ambitious agenda it sets forth for the redirection of resources toward lessening the impact of violence and incarceration in Black and Brown communities, I urge the President and the Board not to overlook the voice and the record of the Cook County Sheriff's office under the leadership of Tom Dart.

While correctly noting the history of violence and unsafe conditions at Cook County Jail, it's also critically important to note Sheriff Dart's role in confronting these conditions head on and implementing significant reforms, often in the face of stiff resistance.

Commissioner Johnson's resolution importantly points to the fact that mere incarceration is inadequate to address the root causes of violence. In seeking to make progress in the area of restorative justice, he and his colleagues would do well to confer with Sheriff Dart on the restorative justice programming he has implemented in Cook County Jail.

Commissioner Johnson's resolution also highlights the urgent need for prioritizing and investing in mental health. If President Preckwinkle and the Board of Commissioners are looking for a partner to strengthen the nexus between our criminal justice system and a durable, impactful mental health infrastructure in Cook County, they should start by solidifying and deepening their partnership with Sheriff Dart, a national voice for mental health awareness.

It is hard to overstate the impact of the County's chief law enforcement officer acknowledging, as Sheriff Dart has done repeatedly over his tenure, that the Cook County Jail is in fact one of the nation's largest mental health facilities. And he has taken steps to address this reality by developing a network of mental health service providers in the jail and setting the intention of treating the individuals in the jail as patients rather than inmates. These steps have been taken with the ultimate goal of reducing the jail's population and preventing recidivism.

Finally, as the Executive Director of an organization that serves immigrants, I would be remiss if I did not caution the Board and Board President, in this time of economic crisis and fiscal constraints, about the unintended consequences for immigrants that could result if, in the name of defunding law enforcement, the County decided to take steps to eliminate certain suburban branch courthouses. While COVID-19 may have taken the media focus off of the plight of undocumented individuals in our community and country, they continue to live in an atmosphere of terror and confusion, brought on by an administration that has made targeting immigrants its primary policy priority.

At GCLC, we believe real access to justice means, in part, access to courts in or near the community where you live. The closure of a branch courthouse not only means the possible forcing of a litigant with limited travel options to attend court downtown at the Daley Center- it also can mean forcing an undocumented individual or family to do something that for us might seem simple, but for them is

truly terrifying- getting on a train or bus and coming downtown. The perception in many of these communities is that a trip to Downtown Chicago increases the chances of exposure to law enforcement generally, and ICE specifically.

Again, as the Executive Director of an organization whose clients deal daily with the issues raised in Commissioner Johnson's resolution, I appreciate the opportunity to share the above thoughts and concerns. I applaud the Board for considering these issues in a meaningful way. And as we seek to shift our law enforcement model from a punitive system to a restorative system, I urge the President and the Board to confer and collaborate with the one elected official who has been working to accomplish this shift for decades- Sheriff Tom Dart.

As a resident of Chicago's Rogers Park neighborhood, which has experienced consistent upticks in crime during my time living here, I am acutely aware that a strategy of incarceration is not the answer to solving our community's concerns. The lack of prospects facing many of these young people gives them few if any good alternatives to gang and drug-based lifestyles. An increase in policing only serves to erode young people's already flimsy trust of the powerholders in our neighborhood. When young adults are locked up, they are likely to return to the streets upon release. It's a cycle I've seen repeat many times as a volunteer for local nonprofits seeking to build opportunities for the disinvested. Only by shifting financial resources away from policing strategies and reinvesting them in schools, community centers, mental and physical health centers, and job training programs (which have taken a hit with the closing of the Howard Area Community center) will we have a chance of living in a safer, more diverse and overall prosperous community.

It is abundantly clear that policing and incarceration are not keeping our communities safe and instead actively causing and perpetuate violence towards Black people and other people of color.

Creating and investing in real community health and safety requires funding public services such as health care, mental health, housing, jobs, restorative justice, and more. These services should be provided by the County departments that specialize in those areas – Cook County Health, the Housing Authority of Cook County, and community-based organizations funded through the Justice Advisory Council – and not by the Cook County Sheriff, whose expertise is in policing and incarceration, not supportive services. HANA Center supports the Justice for Black Lives resolution 20-2867. HANA Center is a part of the coalition that aims to guarantee that the Cook County Public Defender has the funding necessary to create a dedicated immigration unit to protect immigrants from deportation and family separation. Accordingly, we support and urge the County Board to redirect funds from the Cook County Sheriff and the County Jail to be used instead to fund services and programs that promote community health and safety, particularly in Black, Brown, and immigrant communities.

Both locally and nationally, Black, Brown, and immigrant communities are calling on elected officials to redirect resources and funds from carceral institutions back into communities that have been disinvested for decades; we believe this resolution is a great starting point in laying the foundation of our shared values towards this united goal. We need to allocate public funds and resources that promote community health and safety in order to engage in restorative processes that address harm and generate needed accountability of law enforcement while working to heal Black, Brown, and immigrant communities impacted by violence.

In addition, we agree with President Preckwinkle that "the tremendous investments we make are not in the relatively modest sheriff's police, they're in the jail...we have to try to move resources to community-based organizations that are doing the important work of keeping people out of the jail" and we believe that shifting funding from the Sheriff's Department to the Public Defender, for example, would be a significant step in achieving our shared goal of protecting Black, Brown, and immigrant communities.

In fact, Cook County annually allocates more than \$600 million for the Sheriff's budget, consisting of funding for the Sheriff's police force, the Cook County Jail, and more. Despite the number of people incarcerated in Cook County Jail decreasing by more than 50% since 2013, the budget for the jail has actually increased by more than 25%, meaning that \$117 million are available for services if the County Board made changes to the Sheriff and County Jail's budget to reflect changes in the jail population. Why is it that the County Jail continues to see increases in funding all the while the jail population has decreased, thereby requiring less funds and resources that can instead be used for better purposes?

According to Commissioner Brandon Johnson, "as spending on police and incarceration has gone up over the last decade, Black and Brown people actually feel less safe." The growing distrust of the police force demonstrates the need for supporting pillars of public services such as housing, health care, mental health, restorative justice, legal representation, public transit, job creation, and increased opportunities for minority/women business owners. When a department so spectacularly fails to deliver on its promise of protection, service, and safety, it is time to reevaluate.

By undertaking the Justice for Black Lives resolution, Cook County has an opportunity to be a national and local leader in providing a framework that addresses systemic racism and champions justice for all. We urge the County Board to support this resolution.

After a period of enduring lynching in the black community and Jim Crow laws in the South the Kennedy administration and continued in the Johnson administration commissioned a study of the black community to determine how the federal government could positively impact the plight of African Americans in light of the Civil Rights Movement.

Elizabeth's Hinton book From the War on Poverty to the War on Crime, The Making of Mass Incarceration in America gives us insight on how the criminalization of communities of color began.

There were two reports, the Kerner report stated the following; "White society," the presidentially appointed panel reported, "is deeply implicated in the ghetto. White institutions created it, white institutions maintain it, and white society condones it." The nation, the Kerner Commission warned, was so divided that the United States was poised to fracture into two radically unequal societies—one black, one white.

The Moynihan report concluded that the structure of family life in the black community constituted a 'tangle of pathology... capable of perpetuating itself without assistance from the white world,' and that 'at the heart of the deterioration of the fabric of Negro society is the deterioration of the Negro family. It is the fundamental source of the weakness of the Negro community at the present time.' Also, the report argued that the matriarchal structure of black culture weakened the ability of black men to function as authority figures. That particular notion of black familial life has become a widespread, if not dominant, paradigm for comprehending the social and economic disintegration of late 20th-century black urban life.[8]

Based on the Moynihan report Johnson used federal dollars to initiate a war on crime rather than a war on poverty.

Starting with George Bush's war on terror in the 1990's we find that, between 1998 and 2014, the dollar value of military hardware sent to police departments skyrocketed from \$9.4 million to a startling \$796.8 million.

The murder of George Floyd has unfortunately allowed the world to see what we have experienced all are lives, "We Can't Breathe." It is time to dismantle military police structures and invest in communities of color that will demonstrate with the resources going to the right places and institutions that we are not pathological and put that lie to bed!

My name is Lindsey Hammond and I am the Associate Director of State Policy at the Community Renewal Society, a 137-year-old faith-based organization that works with communities to address issues of racism and poverty. We represent 55 member congregations across Cook County.

This testimony is in support of the "Justice for Black Lives" resolution, Resolution 20-2867. We urge the Cook County Board of Commissioners to pass this resolution and act swiftly to divest money from policing and incarceration and, instead, invest money in public services that promote community health and safety.

Our current system is broken. Policing and incarceration are not keeping our communities safe and are instead causing violence towards Black people and other people of color. Almost all of the people in the Cook County Jail are awaiting trial and; thus, presumed innocent under the law. Why are they in jail? Many of them do not have access to money to buy their freedom. Those who cannot afford to pay can be jailed for days, months, and even years. Poverty is not a crime, yet courts use money bonds as the deciding factor in determining whether someone remains in jail before the outcome of their case. Money bonds disproportionately impact Black and Brown people, who are targeted by policing practices and more likely to be convicted and serve time in prison.

From 2013 to 2020, the number of people incarcerated in Cook County Jail per day decreased from more than 10,000 to fewer than 5,000. Despite that massive reduction in incarceration, Cook County Jail's \$336 million budget is 26% higher than it was in 2013. The Sheriff's overall budget is now \$608 million, a 36% increase from 2013. If the jail budget had gone down by the same percentage as the number of people locked up since 2013, the County would have \$117 million to fund health care, housing, jobs, restorative justice, and more.

Correcting the historic disregard for Black lives requires the County Board to defund the Cook County Jail and redirect resources from the jail's budget to public services not administered by law enforcement that promote community health and safety equitably across the County, but especially in Black and Brown communities most impacted by violence and incarceration.

Now is the time to invest more resources in restorative justice programs that repair the harm done to survivors of violence, focus on prevention, and engage in community accountability rather than just punishing people. Cook County should expand mental health care outside the jail and ensure that first responders for people in crisis are trained mental health professionals, not the police. Additionally, health care should be expanded with equitable accessibility in Black and Brown communities. Cook County should also invest in large-scale resources to expand high-quality affordable housing and create living-wage jobs.

Undoing the scope of economic and social damage caused by the expansion of incarceration and policing will take a concentrated effort. A large scale shift in public spending priorities is needed. An equitable public safety strategy will realign Cook County spending priorities to invest in communities that have been most harmed. We urge you to take this bold action and invest in our communities.

My name is Sarah Gad, and I am the Founder and President of Addiction 2 Action (A2A), a 501(c)(3) incorporated in Chicago, Illinois that is devoted to expanding access to life-saving medication-assisted treatment for the treatment of opioid use disorder in correctional facilities. Since its inception in 2018, A2A has spearheaded medication-assisted treatment (MAT) pilot programs in over two-dozen correctional facilities, in which the post-release overdose rates have declined between 61%-75%. By helping to ensure continuity of care upon release, our organization has also helped reduce relapse and recidivism rates among inmates with substance abuse disorders. A2A is submitting this statement today in support of the "Justice for Black Lives" resolution proposed by Commissioner Brandon Johnson.

Substance abuse is universally and unequivocally regarded as a chronic brain disease within the medical and treatment communities, and it has no place in our criminal justice system. Just like any other disease, substance abuse disorders respond to treatment and medication—not deterrents like jail time. But thanks to the "War on Drugs," our criminal justice system has spent the last several decades rejecting science in favor of draconian drug policies that have yielded nothing but casualties. Every year, hundreds of thousands of people with substance abuse disorders wind up confined in facilities where they receive no treatment, concern, compassion, or empathy for their disease. The ineffectiveness of incarceration as a deterrent is evident from the sheer statistics alone: without treatment, 95% of substance abusers will relapse within one month of their release from jail, and 68% will wind up reincarcerated within a year.

The racial motivations behind the "War on Drugs" are well-known and documented. "You want to know what this was really all about?" John Ehrlichman, Nixon's Chief of Staff, said, referring to Nixon's declaration of U.S. drug war. "The Nixon White House had two enemies: the antiwar left and black people. . . We knew we couldn't make it illegal to be either against the war or black, but by getting the public to associate the hippies with marijuana and blacks with heroin, and then criminalizing both heavily, we could disrupt those communities. We could arrest their leaders, raid their homes, break up their meetings, and vilify them night after night on the evening news. Did we know we were lying about the drugs? Of course we did."

The U.S. drug war has been dubbed the "biggest policy failure of all time," sparking seemingly endless public health crises and a harmful legacy of mass incarceration. Since the advent of the U.S. drug war in 1971, the number of people incarcerated in the United States has skyrocketed by over 700%. Today, there are currently more people incarcerated today for just drug offenses than there were for any offense in 1980. By no coincidence, Black Americans comprise 14% of the U.S. population, and 40% of its incarcerated population. In Cook County, Black people comprise 75% of the jail population, but only 25% of the general population. Indeed, drug offenses are the most common reason for arrests in Cook County.

The drug war did not create institutional racism or disregard for Black life in the U.S., but it feeds and bolsters the racist structures that snuff out Black life daily. With George Floyd, Breonna Taylor, and countless others before them, drug involvement— whether perceived or real—has provided a convenient excuse for law enforcement to undermine the sanctity of human life. Breonna Taylor drew her last breath in the hallway of her apartment where police fired 22 rounds during a forced-entry drug raid of the wrong unit. George Floyd drew his last breath after one police officer knelt on his neck for eight minutes and 46 seconds, and another taunted "Don't do drugs, kids!" to a crowd of onlookers. Invoking drug use as a warning to bystanders and later as pretext for Mr. Floyd's death is unconscionable, considering that the real cause of his death was his brutal mistreatment at the hands of police who repeatedly ignored not only his desperate pleas for mercy but also those of bystanders.

Evidently, the real danger is not drugs, but the ways in which the color of one's skin makes them a target for harassment, violence, and, far too often, death by law enforcement. Under the false pretense of keeping America "drug free," law enforcement casually continues to target Black Americans for harassment and arrest, leading to encounters that too often end in death. This call to "defund the police" being echoed across the country in response to the police murders of George Floyd, Breonna Taylor, and far too many others, is our last call. We are no longer willing to stand idly by and watch these morally corrupt and racist institutions target our communities, inflict violence on our neighbors, and undermine decades of countervailing efforts to improve their chances of success and level the playing

Cook County spends more than \$600 million each year supporting racist institutions that predictably and unnecessarily blight thousands of disadvantaged Black lives. In 2011, Cook County was considered the largest jail in the country, averaging a total daily inmate population of 10,000. However, the incarceration rate in Cook County has declined upwards of 50% since 2013. This dramatic decline can be attributed to numerous community organizations, among them being A2A, the Chicago Urban League, the Shriver's Center, and the Chicago Community Bond Fund. By using evidence-based approaches, these and other like-minded community organizations have helped successfully reduce both rates of pretrial detention and recidivism.

Considering the absurdly high cost of incarcerating one person in Cook County (right around \$40,000 per person/year) one would imagine that the historic decline in the number of people in Cook County Jail would coincide with a similar decrease in the Sheriff's budget. But, it hasn't. Despite the Cook County Jail's drastic population decline since 2013, its operational budget has increased by 26%. If the jail's budget had actually decreased in proportion to decarceration, there would be \$117 million available in funding for other public services in Cook County to benefit its most marginalized residents.

Recognizing and acknowledging the racist and destructive legacies that we have allowed to flourish for half a century—which bear an uncanny resemblance to slavery and Jim Crow (hence the drug war's nickname "the New Jim Crow")—is a moral and ethical responsibility of our public officials. Fortunately, jurisdictions across the country of all sizes have taken heed and begun to reevaluate the role that law enforcement plays in their communities; many have already taken dramatic steps to try to rectify the wrongs perpetrated on people of color by our legal system and law enforcement. It is time for Cook County to do the same. Considering that Cook County is home to the second-highest total number of Black Americans nationwide, the Cook County Board of Commissioners should naturally be reevaluating the county's budget priorities with respect to policing, criminalization, and incarceration.

Righting the wrongs of this unjust system requires, at minimum, channeling funding previously used to desecrate Black communities and channelling them towards resources that actually strengthen Black communities. It requires restitution; rehabilitation, mental and physical health support; compensation, both monetary and resource-based, which includes a meaningful transfer of wealth; satisfaction, acknowledgement of guilt and an apology; and guarantees of non-repeat. Divesting from the Cook County Jail and investing in the communities most harmed by mass incarceration is only a starting point, but in doing so, the Cook County Board of Commissioners can finally begin repairing the harms inflicted by a harmful legacy of racism and oppression and jumpstart a healing process that is centuries overdue.

To the Honorable Members of Cook County Board of Commissioners,

My name is Manny Rodriguez, and I am the Executive Director of Revolution Workshop, a nonprofit workforce development agency located in East Garfield Park in Chicago's West Side. Revolution Workshop runs a 10 week pre-apprenticeship program for underserved adults, mainly Black and Brown people interested in gaining a career in construction. We are also a social enterprise, make wood furniture items such as tables, benches and cutting boards, and sell them to consumers with all the proceeds going back to support the organization's mission. I am providing this testimony to support the Justice for Black Lives resolution, Resolution 20-2867.

The events of the past few months have shown a bright light on the disinvestment and systemic oppression that communities of color have had to face in this country. Cook County has been no different. In fact, in some ways we have been worse. The violence that our county continues to see especially in Chicago's West and South Side is a symptom of a much larger problem. We have decided that policing and incarceration of young Black and Brown people is the only way to cure the problem. Since 2013, Cook County has increased its budget to the Cook County jail and sheriff's department despite a 50% decline in the Jail population. Meanwhile, at every level of government, we continue to cut funding for much needed services, such as education, housing and mental health.

Well, I am here to tell you that there is no better way to prevent violence and crime than to provide people with opportunity to better themselves and their families. Revolution Workshop provides training in construction because there are family sustaining career pathways for our trainees. We have been able to have our alumni achieve various socio-economic gains through this work. The work has allowed our alumni to change their lives. Supporting organizations like ours that provide career training and placement and our partners who provide critical support services in housing, mental health and substance abuse is the way we reinvest in our communities to make them healthy and whole. I implore you to take advantage of this moment, this movement and really show that you are serious about Black lives, that you are serious about Brown lives and begin to undo the damage done by decades of failed policy. Dear Cook County Board Commissioners:

We, the undersigned organizations representing a coalition of more than 40 immigrant organizations and advocates for criminal justice reform, present this letter in support of the Justice for Black Lives resolution 20-2867. Our coalition aims to guarantee that the Cook County Public Defender has the funding necessary to create a dedicated immigration unit to protect immigrants from deportation and family separation. Accordingly, we support and urge the County Board to redirect funds from the Cook County Sheriff and the County Jail to be used instead to fund services and programs that promote community health and safety, particularly in Black, Brown, and immigrant communities.

Both locally and nationally, Black, Brown, and immigrant communities are calling on elected officials to redirect resources and funds from carceral institutions back into communities that have been disinvested for decades; we believe this resolution is a great starting point in laying the foundation of our shared values towards this united goal. We need to allocate public funds and resources that promote community health and safety in order to engage in restorative processes that address harm and generate needed accountability of law enforcement while working to heal Black, Brown, and immigrant communities impacted by violence.

In addition, we agree with President Preckwinkle that "the tremendous investments we make are not in the relatively modest sheriff's police, they're in the jail...we have to try to move resources to community-based organizations that are doing the important work of keeping people out of the jail" and we believe that shifting funding from the Sheriff's Department to the Public Defender, for example, would be a significant step in achieving our shared goal of protecting Black, Brown, and immigrant communities.

In fact, Cook County annually allocates more than \$600 million for the Sheriff's budget, consisting of funding for the Sheriff's police force, the Cook County Jail, and more. Despite the number of people incarcerated in Cook County Jail decreasing by more than 50% since 2013, the budget for the jail has actually increased by more than 25%, meaning that \$117 million are available for services if the County Board made changes to the Sheriff and County Jail's budget to reflect changes in the jail population. Why is it that the County Jail continues to see increases in funding all the while the jail population has decreased, thereby requiring less funds and resources that can instead be used for better purposes?

According to Commissioner Brandon Johnson, "as spending on police and incarceration has gone up over the last decade, Black and Brown people actually feel less safe." The growing distrust of the police force demonstrates the need for supporting pillars of public services such as housing, health care, mental health, restorative justice, legal representation, public transit, job creation, and increased opportunities for minority/women business owners. When a department so spectacularly fails to deliver on its promise of protection, service, and safety, it is time to reevaluate.

By undertaking the Justice for Black Lives resolution, Cook County has an opportunity to be a national and local leader in providing a framework that addresses systemic racism and champions justice for all. We urge the County Board to support this resolution.
