During this time I was concerned with the lack of medical resources for our community. I worked closely with other Cicero community members and Congressman Garcia to open the school based clinic. I became part of the first board to ensure the uninsured and under-insured students had medical resources available to them. Several students and their children have been able to receive medical services without missing school days. The Cicero based Clinic is the only clinic our students are able to utilize during school. Cicero, is a low income Environmental Justice community where our families are overwhelmed with pollution. This causes several health adverse impacts like asthma, cancer, COPD, and other illnesses. We live next door to the largest wastewater facility in the world. The Stickney Plant emits noxious gaseous odors everyday. Cicero, is also a hot spot for lead recently we learned that Cicero's drinking water has lead. There is no safe level of lead for our families lead can bring irreversible brain damage to our young children.

Now with the pandemic Cicero is a hot spot for COVID-19 with 15.48% positivity cases. Cicero, has the second highest COVID-19 cases in suburban cook county. This is not the time to eliminate resources for our low income communities during a pandemic. Our communities of color are racially impacted creating health injustices for our students. You must not shut down this clinic taking away health resources from are already vulnerable communities.

I propose the board utilize the \$1 million given to Cicero from the Cares Act to keep the clinic open. Where is the accountability from board members to the students of Cicero?

The School Based Health Center should not have services interrupted as it will have a lasting impact on the school and community as a whole. I served as a Nurse's Aide for three years as a high school student between my sophomore and senior years. Many students in the school system are low income, and this may be their only access to healthcare (albeit a limited capacity). My experience with the School Based Health Center is one of the main reasons I am in pursuit of joining the healthcare field as a dentist. My name is Carmen Vergara, I am a Registered Nurse and serve as the COO of Esperanza Health Centers, a Federally Qualified Health Center serving Chicago's West and Southwest Sides. I am writing to offer my support of the CountyCare health plan and the important funding allocated to the Cook County Health system.

Esperanza is one of 14 safety-net providers that comprise the MHN ACO, an accountable care organization that works closely with CountyCare. Our MHN ACO organization is owned by 11 Federally Qualified Health Centers and 3 Health Systems, spanning Cook County.

At our each of our four locations, located in what have been medically under-resourced and predominantly Latino communities, Esperanza delivers culturally appropriate primary care that is close to home. Our relationship with CCH, CountyCare, and the MHN ACO has been a catalyst to advancing our mission and to better serving our community. Over the course of our 7-year partnership, Esperanza has worked tirelessly to advance our comprehensive care model and today Esperanza is a national leader in healthcare quality, having earned a prestigious National Quality Leader Award from the Health Resources and Services Administration for the fourth time this year since 2016.

I have seen our communities grow and change. I grew up in Little Village and now have the privilege to continue to work in the area, and more importantly, to see the impact our work has on health outcomes in our community. At Esperanza, we deliver compassionate, quality care every day to patients who are ineligible for health care coverage, in many cases, these individuals rely on the excellent team at CCH for any specialty needs we cannot meet in the primary care setting. These services are truly life-saving.

Esperanza also serves almost 9,000 patients that are beneficiaries of the CountyCare health plan. These individuals from our community, rely on the CountyCare health plan for coverage and the dignity that comes with access. In many ways, CountyCare is the most progressive Medicaid insurance plan in the State and the one that is making the greatest impact on improving the relationship between patients and primary care – improving outcomes and reducing the cost of care. Through our partnership with CountyCare and MHN ACO, Esperanza has advanced patient care through practice level programming. As an RN, I have worked with patients firsthand that are looking for guidance, support, and someone who will listen to their concerns

and accommodate their unique needs. From families with Asthma concerned about the COVID-19 crisis, to patients requiring emergency care after serious accidents, I have had the privilege of working with CountyCare patients to connect them to the right care at the right place—and to work with them to get the resources they need and deserve. This dignity is one of the primary successes of CountyCare and it ties perfectly to our mission which is to deliver health and hope for Chicago's often overlooked communities.

Together, through our work with the MHN ACO, we have made great strides in improving the relationship between patients and primary care, improving outcomes, and reducing the overall costs of patient care. Through our partnership in MHN ACO, Esperanza has contributed to the approx. \$50million in earned savings, shared between the health plan and the ACO providers. This model also promotes strong patient relationships; today, MHN ACO has 34% more primary care visits and 24% higher member retention than the rest of the CountyCare health plan. Together, we are leading the charge in transforming into a system that works for our shared service population.

As a leader who has also put in the work, I can see the patient outcomes as a result of the relationships care teams are developing with their patients – and I have been able to build programs and processes that better serve our patients. Thanks to CountyCare, Esperanza has been able to embark on true journey to Practice Transformation – better serving our patients and our community.

I'd like to close with a patient story that exemplifies the value of the partnership between Esperanza and the CCH system. J, a 40 y/o patient with County Care, was diagnosed with HIV in February. His Esperanza care team promptly referred him to the CORE Center for treatment, but in April, he lost stable housing after a conflict with his partner. As the city responded to the global pandemic, and many services became difficult to access, J did not have a safe place to stay and was struggling with limited cellphone service. Stefany Campos, J's Care Manager, responded with thoughtful outreach and helped J sign up for a free phone, and coordinated efforts between care teams at Esperanza and the CORE Center. J was connected with safe housing and meals during the pandemic and has been able to continue his treatment and regular care through telehealth and in person visits at CORE and Esperanza. County Care and the CCH system made that possible.

We at Esperanza are grateful for this transformative partnership and to the commissioners of Cook County for seeing the value of our partnership and of the CountyCare plan.

My name is Anngell Jones MD FACS, Director of Surgical services at Provident Hospital. I am a board-certified General Surgeon and Breast Oncology Surgeon at Provident Hospital for Cook County Health. I joined Cook County Health in July 2019 because of its mission to provide high-quality, state of the art care for the most vulnerable communities regardless of a patient's ability to pay.

As a surgeon who specializes in diagnosing and treating women with breast cancer, it is important to be able to provide the latest diagnostics and surgical services directly to patients where they live. Having patients travel out of their communities to receive this care is neither fair nor safe.

Breast cancer death rates in the U.S. are 40% higher among black women than white women. Black women are more likely than white women to get triple-negative breast cancer, a kind of breast cancer that often is aggressive and comes back after treatment.

It is critical for Cook County Health to be able to provide a fully comprehensive program for breast disease in our Black and Brown communities. We need to be able to provide ongoing breast cancer screenings, diagnostics, and treatments right in the community. Establishing a clinic at Provident has helped to facilitate that outreach.

At Provident, we have a breast imaging center with the latest digital mammography equipment. We are trying to offer more comprehensive services such as stereotactic and ultrasound guided breast biopsies. I currently perform benign breast surgeries at Provident but would like to expand that to surgeries for malignancy. This would entail adding on site radiologists who would perform breast mass localization procedures to facilitate lumpectomies. This would also include expansion of nuclear medicine capabilities to enable sentinel lymph node biopsies. Our goal is to provide the same excellent oncologic care that is provided at our main hospital, John H. Stroger, Jr. Hospital. Currently there is an abundance of resources and potential at Provident hospital. We need your support to expand and continue that success.

Thank you, President Preckwinkle, Cook County Commissioners and Cook County Health leadership, for understanding the great need to offer these services at Provident.

I am Dr. Jacqueline Harrison and I am an attending Colon and Rectal surgeon at Stroger Hospital. I worked previously at Provident Hospital of Cook County for 7 years.

Colorectal cancer is the second deadliest cancer in the U.S. and disproportionately affects the Black community. African Americans are 20% more likely to get colorectal cancer and about 40% more likely to die from it than most other groups.

This disease is ravaging the Black community and it is as important as ever that everyone have access to recommended screenings so we can prevent the disease or find it at an early, more treatable stage.

We are grateful for the commitment to Provident Hospital by investing in the campus, programs and services and particularly the commitment to starting a colon cancer program.

African Americans experience greater obstacles to cancer prevention, detection, treatment and survival including systemic racial disparities that are complex and go beyond the obvious connection to cancer. We need to remove any obstacles that prevent our patients from the care they deserve and need.

Provident Hospital is more important than ever given its location on the near South Side of Chicago, an area where the safety net network is in danger. We take care of a number of patients seen at Sengstacke outpatient clinic at Provident, diagnosed with cancer there, or who are initially seen there and who undergo further workup, followed by treatment at Stroger. These are patients whose care is facilitated by being able to have their care provided closer to home. One patient we recently treated first went to an outside emergency room on the South Side. Because he was uninsured at that time, he was referred to Provident, where he was diagnosed with colon cancer at the age of 46. He subsequently had treatment and is in remission. This patient illustrates the type of work that we do for this underserved community. Provident Hospital of Cook County understands this community and is committed to continuing serving it.

I write today with strong reservations concerning the Cook County budget. Budgets are about choices – choices based on morality and financial capability. Often we need to evaluate the budget as a whole and determine our priorities before we make decisions.

First, I would like to address savings resulting from the Clerk's Office and Recorder's Office merger. The voters want this merger, but they also did not want front line employees laid off and did not want service reductions. The Clerk's office submitted a budget savings of \$1.45M this year. However, those numbers do not add up. In Fiscal Year 2020, the Recorder's Office has a salaries budget of \$7.625 Million. If the intent of the Clerk is to transfer over 60-65 frontline employees; then the salaries cost would be \$3,705,000 for unionized personnel. If the Clerk's Office, as they mentioned in testimony last week intends to keep only 5 of the 28 non-union employees; then the salaries cost would be at maximum \$700,000. The Fiscal Year 2021 costs for Recorder salaries in the Clerk's Office would be \$4.305 Million.

The reduction from \$7.625 Million in employee salary costs to \$4.305 Million in employee salary costs would save Cook County \$3.320 Million in Fiscal Year 2021.

Clerk Yarbrough is reporting that the employee salaries savings will only amount to \$1.45 Million instead of \$3.320 Million.

We urge Commissioners to examine the Clerk's budget very carefully to ensure that additional patronage employees do not creep into the Clerk's budget over the 5 non-union positions the Clerk's office testified is their intent to create to manage the unionized Recorder's staff coming into the Clerk's Office.

Second, the recommended budget reductions presented by the CCH Board are the wrong way to approach the CCH budget. The Cook County Health and Hospital System is the safety net for all Cook County residents. We see Cook County healthcare services as vital. That is why CCH employees risk their lives during the COVID pandemic to show up for work every day. They are not receiving pandemic pay like their colleagues at other health systems. The employees continue to come to work each day because they know patients cannot seek services elsewhere.

Instead of closing clinics, restricting access to emergency services, privatizing healthcare services and laying off essential workers; this Health and Hospitals Board should seek to expand services in an effort to reach more patients.

The proposed closures of the Cook County Near South clinic at 35th and South Michigan and Cook County Woodlawn Clinic at 63rd and Woodlawn, the reduction of services at Provident Hospital at 51st and Martin Luther King Dr. cannot be looked at solely through the lens of the CCHHS budget. The closures of Michael Reese, the announced closure of Mercy Hospital and the unsustainable financial situations of the Advocate Trinity, South Shore, and St. Bernard Hospitals create the possibility of a large healthcare desert on Chicago's near South Side.

Furthermore, the privatization of the Morton East clinic is a mistake. Public services should be delivered by public employees. Private companies delivering healthcare and support services inside the CCHHS system have proved to be disastrous.

Cook County Health and Hospital System should be expanding mental, behavioral and general health services instead of cutting services that poor, uninsured, underinsured, and Black and Brown communities rely upon.

SEIU Local 73 members urge the members of the Cook County Board to restore the clinic services portion of the Cook County Health budget and resist the urge to cut other healthcare services in the midst of the COVID-19 global pandemic.

Good afternoon,

my name is Pia Kanoy and I am the Director of Veteran Services at the nonprofit organization The Inner Voice, Inc. and a 30-year Army veteran. Our agency assists Chicago's homeless citizens in various ways. My team helps homeless and unemployed veterans find work, refer to partner services as needed and assist the veteran in becoming self-sufficient and a member of society again. In May 2019, Inner Voice partnered with the Cook County jail's Tier 2B in Division VI (which houses veterans). My staff and I would conduct weekly or bi-weekly visits to discuss employment opportunities for justice involved veterans as well as offer a four-hour quarterly employment readiness workshop, the first ever offered to veterans at Cook County jail.

The response from the Tier 2B veterans was positive, and more than 30 veterans sought employment and partner service assistance once released from jail. The overwhelming response indicated how much our program is needed at the jail to give inmates hope, choices and an opportunity to return to work.

Unfortunately, the pandemic ended our visits since March, but I stay in contact with Officer John Coddington, who is the veterans' liaison officer. We currently discuss to conduct a virtual workshop for interested veterans seeking employment.

Having observed first hand the positive impact our program, as well as many other veteran specific programs have at the jail inspired me to write to you and request continuous funding for such programs. Inner Voice is proud to give people a second chance and would welcome the partnership with Cook County jail's Tier 2B extended.

My name is Cindy Eigler, and I am one of the Co-Executive Directors of the Chicago Torture Justice Center. Today I am offering testimony in strong support that the Budget for Black Lives be fully funded in the County's 2021 budget. I urge the County to immediately start the process to move County dollars out of policing and incarceration and into the resources that allow our communities to thrive as detailed in the Budget for Black Lives.

The Chicago Torture Justice Center (CTJC) was created out of the Reparations Ordinance passed by City Council in 2015. The Ordinance acknowledged the need for repair and healing following decades of police torture under Chicago Police Commander Jon Burge. CTJC is the first and only center of its kind in the country. We seek to address the traumas of police violence and institutionalized racism through access to healing and wellness services, trauma-informed resources, and community connection.

Working day in and day out with survivors of police torture, police violence, and family members whose loved ones have been killed by the police, we attend to both the seen and unseen wounds. The individuals we work with suffer from trauma, depression, and deep levels of anxiety. Many continue to experience nightmares and flashbacks of their encounters with the police, returning them to a desperate state of fighting for their lives. Further, many are re-traumatized at the sight of a police vehicle or officer, causing their blood pressure to rise or to break out in a sweat, leaving them with paralyzing feelings of fear and distrust.

The vast majority of the individuals we work with were not only harmed at the hands of the police, but also experienced incredible harm and loss in the courts, in the jails, and in decades of incarceration. As we witness at the Center, and as corroborated by psychological experts, the trauma experienced as a result of policing and incarceration impacts entire families and seeps into the community.

We at CTJC call for accountability to these multiple systems that serve to control, harm, disappear, and kill Black and brown individuals. We know that 400+ years of racialized violence and killing will not be absolved by the arrests nor the firings of individual police officers, nor will the closure of one prison. We demand accountability that is grounded in a radical call to action. We demand not just apologies for harm done, but repentance and real change that can end and repair harm. We see the violent results of an excessively funded and over-militarized policing system. We demand our communities are provided with the resources and access they need to flourish.

Our budgets are values documents, and the hundreds of millions of dollars of the County budget that currently go to detaining and locking up Black and brown people do not represent our values. If the jail budget had been reduced to reflect the decrease in the number of people locked up since 2013, the County would have \$117 million to fund health care, housing, jobs, restorative justice, and more. That represents what we stand for.

We ask that you FULLY fund the Budget for Black Lives, and ensure that the County's budget reflects the values and priorities of its communities.

When I was in high school, I would wake up with anxiety every day and would stay home from school at least once a week. There were multiple times that I had panic attacks during class and would need to go the school-based health center to calm down so that I could return to class. I had a rough time in high school, and if it weren't for the school-based health center's behavioral health services, I probably wouldn't be here to give this testimony. I know that high school can still be rough for a lot of students, and like me, I want people to be able to get the help that they need.

Now that I'm 22, I still go to the school-based health center for my behavioral health services because Maria and Diana have been so great. I tried to see another social worker at another clinic, but it wasn't the same. I like the relationship that I have with the current social workers because they know my history, understand what's going on, and I like the techniques that we're using in my treatment. If the school-based health center was no longer sponsored by Cook County Health and Hospital System, I would have to find a new social worker and open up to a stranger, which would be really difficult. It would also be very difficult because I am currently unemployed and in school, so I would have to work hard to find a place that takes the insurance that I have so that I can afford my services. Finally, the school-based health center is very close to my house and easy to access, and I don't want to have to find a new location.

Please keep sponsoring the school-based health center at Morton East so that I can continue my services with the providers I currently have, and so that others can benefit from the services, too.
