HONORING ANTHONY SIMPKINS, NEWLY SELECTED PRESIDENT AND CEO OF NEIGHBORHOOD HOUSING SERVICES

WHEREAS, Anthony Simpkins, will officially join the Neighborhood Housing Services (NHS) on November 16, 2020 as the newly selected President and CEO; and

WHEREAS Anthony has held multiple roles serving the City of Chicago as Managing Deputy Commissioner of the Department of Housing, he also oversees housing and community policies, programs, and strategic investments. He previously serves as Deputy Commissioner for the City of Chicago Department of Planning and Development focusing on asset management, intergovernmental affairs, housing preservation initiatives and economic development policy; and

WHEREAS Simpkins earned his law degree and a Master's in Political Science from Loyola University and began his legal career as a Skadden Foundation fellow at the Legal Assistance Foundation and Lawyers Committee for Better Housing; and

WHEREAS Anthony graduated with a B.A. in Political Science from the University of Illinois, he worked for the Leadership Council for Metropolitan Open Communities, the Chicago fair housing organization founded by Rev. Martin Luther King, Jr.; and

WHEREAS, In 2014 Anthony was appointed a Judge of the Circuit Court of Cook county by the Illinois Supreme court and served until 2016; and

WHEREAS Anthony always maintains an active civic life as well. He is a board member and past-president of the Muslim Bar Association of Chicago, the first association of Muslim lawyers organized in the United States, a former board member of the Cook county Bar Association, the country's oldest organization of African American lawyers, as well as a board member of the Downtown Islamic Center, the RTW Veterans Center and former Managing Editor of the Journal of Islamic Law and Culture; and

WHEREAS Anthony is married to Tamaria (Tammy), who is an internationally accomplished Jazz vocalist, curator and educator along with their four children; and

HONORING MR. REUBEN LEE NORRIS 85TH BIRTHDAY

WHEREAS, On February 17, 2020, Mr. Reuben Lee Norris of Chicago, Illinois celebrated his 85th birthday surrounded by family and friends; and

WHEREAS, Mr. Norris received an Athletic Scholarship to play football at Knoxville College in, Knoxville Tennessee where he became a member of the Omega Psi Phi Fraternity, Inc. and received his degree; and

WHEREAS, after graduation Ruben Norris was drafted into the military and upon completion received an honorable discharged and later migrated in Chicago, IL in 1960; and

WHEARAS, For more than 30 years Mr. Reben Lee Norris was employed with the Chicago Park District and served in various capacities including: Weekend Rec Leader, physical instructor, Playground Supervisor, Park Supervisor of Douglas and Avalon Park, Physical Activity Supervisor of areas 1 and 2, Area Supervisor of 36 parks and then Host Park Manager until his retirement in 1992. After retiring from the park district, Ruben Norris began a full-time position with the Chicago Public School System at King High School for than 20 years until his retirement for CPS in 2016;and

WHEREAS, Ruben Norris is a kind gentle man whose faith is deeply rooted in the Lord. He is a faithful member of 25 years of St. Thomas Episcopal Church where he serves as a Deputy Warden ; and

WHEREAS, Ruben Norris served as a basketball official for 43 years traveling the country. He is known throughout the State of Illinois but especially in Chicago as the God Father of basketball officials. He has officiated former President Barack Obama in a private game in Chicago as well as Michael Jordan. In addition, from 1972-1992 he coached/and managed" The Chicago Boston Shoot Out Team" which provided visibility to many NBA Players and coaches such as Doc Rivers, Mark Aguirre, Juan Howard and Hersey Hawkins just to name a few. He has also served as an NBA observer and scout of officials for 20 years; and

WHEREAS, Ruben Norris is the First African American to enter the All American Soap Box Derby in 1940; First Women's Professional Basketball League Championship official in 1981 in Chicago, IL; First African American from CPS League to officiate in the IHSA Tournament in 1987; First African American to officiate the State Finals game in 1988; and

WHEREAS, Ruben Norris has received numerous awards and recognition's but not limited to the following: 1994- Black Role Model Habilitative System Inc; 1994 Chicago Basketball Coaches Association (Official); 1999- Illinois Basketball Coaches Association) Official 2014 Illinois High School Association 40-year Recipient Awardee.

WHEREAS, Sister Michelle returned to Illinois, serving as dean of students at Rosary College (now Dominican University) in River Forest; and

WHEREAS, Sister Michelle has been credited with saving Trinity High School, which was at the brink of closure in 1992 when she decided to accept the position as president at the River Forest school; and

WHEREAS, upon assuming her role as president, Sister Michelle built strong relationships with alumnae and the community, touted the school's all-female identity despite market pressures to become co-ed, and implemented block scheduling to allow for more collaborative learning, rightfully believing that her students would thrive in this environment; and

WHEREAS, under Sister Michelle's leadership, Trinity instituted the prestigious International Baccalaureate program, resulting in being featured in *Newsweek* in 2017 as one of the best International Baccalaureate programs in the United States; and

WHEREAS, Sister Michelle's spirit and determination were contagious as reflected in Trinity seniors' one-hundred percent college acceptance rate; and

WHEREAS, Sister Michelle's love of Chicago sports and commitment to having a well-rounded student body propelled her to undertake large projects, such as the construction of an athletic facility, a health and fitness center, and a technology center; and

WHEREAS, in her final days, Sister Michelle was surrounded by many members of the Trinity community as well as her beloved Sinsinawa Dominican Sisters; and

WHEREAS, Sister Michelle's larger-than-life personality leaves a legacy that will only grow with time.
