# HONORING JOHN PLANTE ON HIS RETIREMENT FROM THE METRA BOARD

**WHEREAS**, John Plante, a strong proponent of railroad safety during his long career at the Chicago Transit Authority and Metra, is leaving the commuter rail agency's board after serving seven years; and

**WHEREAS,** Plante was appointed to the Metra Board in 2013, not long after the board was rocked by an embezzlement scandal and subsequent years of turmoil. During his tenure on the board, he served as board treasurer and chairman of the Safety Committee; and

WHEREAS, Plant is best known for his regional approach to transportation and his concerns about safety. "Safety is our most important issue, and Plante raised the bar in that area," said former chairman Norm Carlson, who remains on the board. Plante took Metra's safety efforts "to a whole new level," said Don Orseno, former Metra executive director who was recently appointed to the board. Plante has been a "strong advocate" for safety and is well-known for his efforts in the railroad industry; and

WHEREAS, Carlson also praised Plante for taking a regional approach to issues facing Metra. In Plante's words, "We are a mass transit system ... serving an entire region. That perspective is important." He added that in the "bad old days" Metra and the other transit agencies used to fight over funding, but "we resolved that;" and

**WHEREAS,** Plante, 75, told *Trains* News Wire that his proudest accomplishment was helping bring credibility back to Metra's board: "There was a lot of bad history there. We were able to put together a group of people (on the board) who were dedicated and took the job seriously"; and

**WHEREAS**, John's career followed a lifelong interest in trains. Prior to his service on the Metra board, Plante worked for 35 years at the CTA. He retired in 2013. He began his tenure as a trial attorney, and then moved to trial supervision and then managing attorney for the claims department, risk management, and senior manager of emergency preparedness; and

WHEREAS, Plante also has served on the American Public Transportation Association (APTA) Board of Directors and as chairman of the APTA Risk Management Committee. He continues to serve as a member of the Risk Management Committee and all the APTA Security Emergency Management Standards Committees.

# HONORING HIS EMINENCE WILTON DANIEL CARDINAL GREGORY ON THE OCCASION OF HIS ELEVATION TO CARDINAL IN THE ROMAN CATHOLIC CHURCH

**WHEREAS,** it has come to the attention of the Cook County Board of Commissioners that Archbishop Wilton Daniel Gregory was elevated to the rank of Cardinal Priest on November 28, 2020 at the Vatican by His Holiness Pope Francis; and

WHEREAS, Wilton Daniel Gregory was born in Chicago, Illinois and attended St Carthage Grammar School. He attended Quigley Preparatory Seminary South and Niles College in Chicago and St. Mary of the Lake Seminary in Mundelein; and

WHEREAS, Wilton Daniel Gregory was ordained to the priesthood by John Cardinal Cody on May 9, 1973; and

**WHEREAS,** Wilton Daniel Gregory performed pastoral work in Glenview at Our Lady of Perpetual Help and at Mary, Seat of Wisdom Parish in Park Ridge, Illinois. He also taught at Saint Mary of the Lake Seminary and served as a Master of Ceremonies under Cardinals Cody and Bernardin; and

WHEREAS, Wilton Daniel Gregory was appointed Auxiliary Bishop of Chicago and Titular Bishop of Oliva on October 31, 1983; and

WHEREAS, on December 29, 1993, Pope John Paul II appointed Wilton Daniel Gregory the seventh Bishop of Belleville; and

**WHEREAS,** from 2001 to 2004, Wilton Daniel Gregory served as the president of the United States Conference of Catholic Bishops, the first African American to head an episcopal conference, and served as Vice President from 1998 to 2001 as well as chairman of several committees, and

**WHEREAS,** Pope John Paul II, in one of his last episcopal appointments before his death, named Bishop Gregory the seventh Archbishop of Atlanta on December 9, 2004, and

WHEREAS, on April 4, 2019, Pope Francis named Wilton Daniel Gregory Archbishop of Washington; and

**WHEREAS,** during Cardinal Gregory's Presidency of the United States Conference of Bishops, the American bishops issued the "Charter for the Protection of Children and Young People", and

WHEREAS, Cardinal Gregory is the first African American Cardinal from the United States; and

WHEREAS, Cardinal Gregory has worked tirelessly throughout his career to address many of the significant social and economic issues that affect all Americans and has sought a role for the Catholic

Church in finding solutions to problems that burden those who are less fortunate in our society; and

**WHEREAS**, Cardinal Gregory has written extensively on church issues, including pastoral statements on the death penalty and social justice issues. Cardinal Gregory has published numerous articles on the subject of liturgy, particularly in the African American community; and

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Commissioners of Cook County that the Board does hereby offer its heartfelt congratulations to His Eminence Wilton Daniel Cardinal Gregory and wishes him much success in his important role as Cardinal in the Roman Catholic Church; and
