The Latino Policy Forum appreciates the opportunity to provide testimony to the Legislation and Intergovernmental Relations Committee of the Board of Commissioners for Cook County. My name is Sarah Cartagena, and I am the Immigration Policy Analyst for the Latino Policy Forum. The Latino Policy Forum is a statewide non-profit advocacy organization that promotes Latino participation and social action in public policy discussions. The Forum actively advocates for policies that support the successful political, social, and economic inclusion of Latino immigrants in their new communities, in addition to policies that protect and defend the equality, dignity, and basic liberties of all immigrants.

The Forum stands in full support of the proposed resolution filed by Commissioner, Alma Anaya, which calls upon the federal government to implement policies to protect the immigrant community and strengthen the current immigration system in the United States. In alignment with the Latino Policy Forum's principles, we would like to direct our remarks to sections (1), (3) and (4) of the proposed resolution.

We particularly call attention to provision (1) "the immediate rescission of the numerous executive orders, proclamations, and other policy changes that the previous federal administration used to confuse, intimidate, exclude and remove immigrants." The public charge rule is a prime example of a policy stance that adversely targeted immigrants based on their legal status, wealth, and level of social integration. The Migration Policy Institute noted that between 2018 and 2019, when the public charge rule was highly publicized, participation in SNAP, TANF, and Medicaid declined twice as much for noncitizens as for U.S citizens. This study highlights the fear, confusion and consequential chilling effect the public charge rule had, and continues to have, on our immigrant communities.

The Forum supports provision (3), the call for inclusive "access to adequate healthcare, affordable housing, and vital social services by removing restrictions that have excluded vulnerable segments of the immigrant community." Since the start of the COVID-19 pandemic, high-immigrant, Latino and Black communities have been particularly hard hit. Eleven of the 15 most impacted zip codes in Illinois are Latino majority areas, most with high numbers of immigrants. Nine of those zip codes are located within Cook County. This exemplifies the pressing need for immigrants to have fair access to healthcare and social services, particularly during and after the COVID-19 pandemic. In addition, as of January 2021, 2 million children with Social Security numbers whose parents are undocumented continue to be excluded from federal emergency relief, as do 9 million undocumented individuals; despite their faithful federal and state tax contributions.

The Forum endorses provision 4(b), "legislation prioritizing path to citizenship for the undocumented population in the United States." Immigrants have faced roadblocks and dead ends on their path towards citizenship. DACAmented individuals, for example, have been in a limbo for almost a decade. Moreover, the estimated 437,000 undocumented individuals in Illinois have been left with no other option but to remain in the shadows.

We similarly support provision 4(c), "the separation of the criminal justice system from the immigration system." A more progressive and objective dialogue would be encouraged; one where immigration cases are not analyzed through a criminal lens and immigrants are considered as people before they are labeled as criminals. This action aligns well with the Cook County's recent initiative to fund a public defender immigration unit.

The Latino Policy Forum appreciates Cook County's leadership in putting on the record their commitment to support sound federal policy efforts that help us materialize our shared mission to uphold the rights of immigrants and empower them to thrive.

We have endured 8 years of a broken promise by Obama and then 4 horrible years under Trump. We have just 2 years of this Biden Administration where the Democrats will continue to fight for citizenship for all, once all our families can come out of the shadows and 2 million deportees will be able to return home.
