Subject: Fiscal Impact Note on Item #20-4163 Cook County Medical

Examiner's Ordinance Amendment.

In accordance with Sec. 2-77 of the Cook County Code of Ordinances, this note is prepared to convey the fiscal impact of item #20-4163 Cook County Medical Examiner's Ordinance Amendment.

Ordinance #20-4163 proposes that beginning December 1, 2020, the cremation permit fee collected by the Cook County Medical Examiner's Office (CCMEO) increase from \$100 to \$200 per permit. The increased revenue would support the CCMEO's operating fund.

Over the past four years, the CCMEO has seen a rise in cremation permits being issued ranging from 3 - 10%. The increase in permit cost is a 100% change, resulting in an estimated revenue increase between 106% and 120% in Fiscal Year 2021, amounting to an increase in revenue between \$2,120,000 and \$2,400,000. The table below estimates the forecasted change in revenue between fiscal years 2020 and 2021, with the increase in volume of permits estimated at 6.5%.
