conditions for correctional staff, making for a better work environment for what is an incredibly difficult job; and

WHEREAS, before joining the Sheriff's Office, Dr. Jones Tapia was the Chief Psychologist at Cermak Health Services, which provides the onsite medical mental health care for detainees at the Jail; and

WHEREAS, Dr. Jones Tapia has a decorated academic career, earning her bachelor's degree in psychology from the University of North Carolina at Chapel Hill, her master's degree in clinical psychology from East Carolina University, and her doctoral degree from the Virginia Consortium Program in clinical psychology; and

WHEREAS, countless fire departments, police departments, first responders, government officials, workers, emergency medical personnel, and volunteers responded immediately and heroically to those horrific events; and

WHEREAS, the Fire Department of New York suffered 343 fatalities, the Port Authority Police Department suffered 37 fatalities, and the New York Police Department suffered 23 fatalities as a result of the terrorist attacks; and

WHEREAS, the impact of that day on public health continues through 2018, as nearly 90,000 people are at risk of or suffering from negative health effects as a result of the events of September 11, 2001, including 14,000 workers and 2,400 community residents who are sick, and tens of thousands of others whose health is being monitored; and

WHEREAS, 17 years later, the people of the United States and people around the world continue to mourn the tremendous loss of innocent life on that fateful day; and

WHEREAS, 17 years later, thousands of men and women in the United States Armed Forces remain in harm's way defending the United States against those who seek to threaten the United States; and

WHEREAS, on the 17th anniversary of this tragic day, the thoughts of the people of the United States are with all of the victims of the events of September 11, 2001 and their families; and

WHEREAS, in 2009, Congress and the President joined together to designate September 11 as a National Day of Service and Remembrance under the Serve America Act (Public Law 111-13; 123 Stat. 1460); and

WHEREAS, September 11th will never, and should never, be just another day in the hearts and minds of all people of the United States.
