Rothstein CORE Center has received funding and collaborated with the Chicago Community Trust, Design Industries Foundation Fighting AIDS, Chicago Department of Public Health, Gilead's HIV Focus, Blue Cross and Blue Shield of Illinois, Grant Healthcare Foundation, Michael Reese Health Trust and the Polk Brothers Foundation.

WHEREAS, in 1930 the Mount Prospect Woman's Club established Mount Prospect's first library in a one-room schoolhouse; and

WHEREAS, in 1943 a referendum enabling a tax-supported village library was approved, and the Chicago Public Library began a twenty-year relationship of giving the new library start-up assistance; and

WHEREAS, in 1944 the library moved to a paint store at 115 South Main Street; and

WHEREAS, in 1950 the first library building was constructed at 14 East Busse Avenue on land purchased with money donated by organizations and individuals; and

WHEREAS, between 1962 and 1965 two additions were made to the building, tripling the floor space; and

WHEREAS, a new library opened on the site of the old Central School on December 6, 1976; and

WHEREAS, in 1993, as the library celebrated in 50th anniversary, many new services became available to library patrons, including the Readers' Advisory, a drive-up book drop, and the Internet; and

WHEREAS, a \$20.5-million referendum was approved in 2002, and in 2004 construction of the new library building on Emerson Street was completed; and

WHEREAS, annual circulation hit one million for the first time in 2009; and

WHEREAS, in 2013 the library received a 3-star rating from the Library Journal and was selected as one of the Chicago Tribune's Top 100 Workplaces for 2013, an honor it would continue to receive annually; and

WHEREAS, throughout 2018, in honor of its anniversary, the library has offered celebratory programming for all ages and interests.

HONORING THE 150TH ANNIVERSARY OF THE LINCOLN PARK ZOO

WHEREAS, the Lincoln Park Zoo was established in 1868 with the gift of a two (2) pairs of swans from New York City's Central Park; and

WHEREAS, starting in 1888 Cyrus DeVry supervised the construction of new structures to house many new animal species, including monkeys and elephants; and

WHEREAS, the first three (3) decades of the 20th Century saw construction of Café Brauer, Bird House, Lion House and Primate House, all landmark structures that grace the grounds of the zoo today; and

WHEREAS, Marlin Perkins became Zoo Director in 1945, bringing the animals and their individual stories into homes through NBC's *Zoo Parade*; and

WHEREAS, the year 1959 saw the foundation of The Lincoln Park Zoological Society by philanthropists and civic leaders; and

WHEREAS, Dr. Lester Fisher became Zoo Director in 1962, beginning a 30-year tenure that oversaw the society raise over \$400 million for new exhibits and improved animal care; and

WHEREAS, in 1976 the most advanced habitat for great apes opened, which was later named for Dr. Fisher. Kevin J. Bell was also hired in 1976 as Curator of Birds at Lincoln Park Zoo; and

WHEREAS, with just two (2) staff members the Conservation and Science department launched in 1989, forming the foundation of one of the nation's largest and most effective wildlife conservation and science programs; and

WHEREAS, in 1992, Kevin J. Bell was promoted to Assistant Director; and in 1993, was appointed Director at Lincoln Park Zoo; and

WHEREAS, the year 1995 saw the Lincoln Park Zoo and Chicago Park District enter a 30-year agreement shifting the zoo to self-governance, the same year saw the Zoo Society's Board of Trustee's adopting full-time management of zoo operations; and

WHEREAS, after the zoo was privatized in 1995, Kevin J. Bell was also named President and Chief Executive Officer (CEO) of the Lincoln Park Zoological Society, which manages and operates Lincoln Park Zoo; and

WHEREAS, 1995 launched the five-year "Heart of the Zoo" campaign, raising over \$50 million for new and renovated animal habitats including the Regenstein Small Mammal-Reptile House; and

WHEREAS, the Davee Center for Epidemiology was created in 2001 to bridge the gap between population biology and veterinary medicine through the study of epidemiology, and was expanded in 2005 to incorporate endocrinology research, making it the Davee Center for Epidemiology and Endocrinology; and

WHEREAS, the first decade of the 21st century saw the opening of three major new exhibits in the Regenstein Center for African Apes, the Regenstein African Journey and the renovated Pritzker Family Children's Zoo; and

WHEREAS, in 2008 the Urban Wildlife Institute was founded, becoming the most comprehensive urban wildlife conservation and science program in the country and one that has been adopted by over ten cities nationwide; and

WHEREAS, the year 2011 saw the Zoo enter into a partnership with the City of Chicago and the Chicago Park District to unveil the Nature Boardwalk, a complete refurbishment and restoration of The South Pond; and

WHEREAS, 2016 saw the announcement of the \$125 million "The Pride of Chicago" campaign which has already resulted in the opening of the Regenstein Macaque Forest, the Walter Family Arctic Tundra and the Robert & Mayari Pritzker Penguin Cove; and

WHEREAS, in 2017 the Zoo unveiled plans for its new visitor center to better serve guests as the Zoo welcomes the 3.7 million annual visitors; and

WHEREAS, in 2018 the Zoo announced one of the most ambitious capital projects in their 150 year-history as they conduct a complete overhaul of the Kovler Lion House; and

WHEREAS, the Lincoln Park Zoo remains the nation's only privately managed free admission zoo in the United States of America.

RECOGNIZING OCTOBER AS BREAST CANCER AWARENESS MONTH

WHEREAS, the month of October is recognized as Breast Cancer Awareness Month; and

WHEREAS, in the United States about one (1) in eight (8) women will develop invasive breast cancer over the course of her lifetime; and

WHEREAS, in 2018, an estimated 266,120 new cases of invasive breast cancer were expected to be diagnosed in women in the U.S., along with 63,960 new cases of non-invasive (in situ) breast cancer; and

WHEREAS, about 2,550 new cases of invasive breast cancer were expected to be diagnosed in men in 2018. A man's lifetime risk of breast cancer is about 1 in 1,000; and

WHEREAS, Breast cancer incidence rates in the Unite States began decreasing in the year 2000, after increasing for the previous two decades. They dropped by 7% from 2002 to 2003 alone; and

WHEREAS, one theory is that this decrease was partially due to the reduced use of hormone replacement therapy (HRT) by woman after the results of a large study called the Women's Health Initiative were

published in 2002. These results suggested a connection between HRT and increased breast cancer risk; and

WHEREAS, about 40,920 women in the United States were expected to die in 2018 from breast cancer, though death rates have been decreasing since 1989, with larger decreases in women under the age of 50. These decreases are thought to be result of treatment advances, earlier detection through screening, and increased awareness; and

WHEREAS, for women in the United States, breast cancer death rates are higher than those for any other cancer, besides lung cancer; and

WHEREAS, white women are slightly more likely to develop breast cancer than African-American women. However, in women under 45, breast cancer is more common in African-American women than white women. Overall, African - American women are more likely to die of breast cancer. Asian, Hispanic, and Native-American women have a lower risk of developing and dying from breast cancer; and

WHEREAS, in 2018, there are more the 3.1 million women with a history of breast cancer in the United States. This includes women currently being treated and women who have finished treatment.

NOW, THEREFORE, BE IT RESOLVED, that the President and Members of the Board of Commissioners, on behalf of more than 5.2 million residents of Cook County, do hereby take this opportunity to acknowledge Breast Cancer Awareness Month; and

COMMEMORATING THE EXCEPTIONAL LIFE AND MANY TRAILBLAZING ACCOMPLISHMENTS OF EVANSTON MAYOR LORRAINE HAIRSTON MORTON

WHEREAS, Lorraine Hairston Morton, dedicated community advocate, lifelong educator, groundbreaking teacher and principal and much beloved mayor of the City of Evanston died at the age of 99 leaving behind a devoted family, countless friends and a community profoundly enriched for having known her; and

WHEREAS, Lorraine H. Morton was the beloved mayor of Evanston, who served from 1993 to 2009, she was also the city's first African-American mayor, she was the city's first Democratic mayor and was the longest-serving mayor; and

WHEREAS, Lorraine H. Morton was born in Winston-Salem, North Carolina, the youngest child of Keziah Hairston, a schoolteacher, and William Patrick Hairston, a prosperous businessman who helped found the Winston Mutual Life Insurance Company, which is still operated as the Golden Gate Insurance Company; and

WHEREAS, Lorraine H. Morton received a bachelor degree in education from Winston-Salem State University and a master's degree in education from Northwestern University. She met her husband, Dr. James T. Morton, Jr., as a graduate student at Northwestern University. After she was married, she and her husband moved to Tuskegee, Alabama, where he worked with the Tuskegee Airmen; and

WHEREAS, she moved back to Evanston in 1953, when her husband began working as a clinical psychologist with the Veteran's Administration and at Evanston Hospital; and

WHEREAS, Lorraine H. Morton will long be remembered for spearheading the desegregation of Evanston's public schools as a teacher and school principal. She was one of the first teachers to break the color barrier at Nichols Middle School, at a time when Evanston was integrated statistically, but not geographically. She championed desegregation efforts and demanded equity in all Evanston's schools. She was the first African-American principal at Haven Middle School. Under her watch, Haven was a pioneering school for educational enrichment. As principal, the school thrived and she developed a national reputation for her wisdom and leadership; and

WHEREAS, Lorraine H. Morton was appointed and then elected Alderman of the Fifth Ward, a position she held for nearly a decade. As a member of the Evanston City Council, she tirelessly served on countless committees and was later elected Evanston's Mayor; and

WHEREAS, one of her chief goals as a Northwestern alum was to improve the town-gown relationship between Northwestern University and the greater population of Evanston. She worked very hard and successfully forged a close friendship with Northwestern University president Henry Bienen; and

WHEREAS, Lorraine H. Morton's time as mayor ushered in a new era for Evanston, one that improved the community immeasurably. She was the model of respect and principled leadership and the community became a more welcoming and inclusive place because of the example she set. On the night she was elected she noted: "First of all, I think my victory shows that this town will support a person without regard to race or sex..."My immediate response will be to set a tone that will bring people together." She did; and

WHEREAS, Lorraine H. Morton, as Mayor, viewed Evanston as a classroom and she was the town's Principal; and

WHEREAS, Lorraine H. Morton was regularly singled out for recognition by institutions of higher learning and had scholarships named in her honor. Winston-Salem State University created the Lorraine Hairston Morton Endowed Scholarship in 2010 for students majoring in education who are committed to community service and Northwestern University provides a scholarship in her name for the Master of Science in Education Program in the School of Education and Social Policy; and

WHEREAS, Lorraine H. Morton received countless community awards and recognitions. Northwestern presented her with an Alumni Merit Award and bestowed an honorary doctorate upon her. She also held an honorary doctorate for public service from Kendall College. In addition, she held the position of Vice President of the Evanston Historical Society and received community service awards from Saint Francis Hospital of Evanston and the Evanston Arts Council; and

WHEREAS, through her long life Evanston treasured Lorraine H. Morton and she was often publicly thanked for her many contributions. One of her more visible recognitions and one of the most lasting took place in 2009 when Evanston's civic center was renamed for her when she retired; it is now known as the Lorraine H. Morton Civic Center; and

WHEREAS, in June of this year, more than a hundred people gathered with Lorraine H. Morton at the Northwestern University Segal Visitors Center to celebrate the premier of the film documentary "Lorraine H. Morton: A Life Worthwhile." The film takes its title from one of Morton's last quotes in the movie, advice from her father, who helped guide her in life and one which she exemplified: "Only a life of service is a life worthwhile."; and

WHEREAS, Evanston has lost a great friend and champion in Lorraine H. Morton and her loss will be felt deeply. She is survived by her daughter, Elizabeth Morton Brasher, and two granddaughters, Elizabeth Keziah Brasher and Constance Moriah Brasher.

WHEREAS, Riveredge celebrated its 55th anniversary in 2018 and will continue in its crucial mission for many years to come.

NOW, THEREFORE, BE IT RESOLVED, by the President and the Cook County Board of Commissioners that the doctors, nurses, staff and leadership team at Riveredge Hospital are congratulated on the occasion of 55 years of providing quality mental health treatment and thanked for the good work they do in the greater Chicagoland area, western suburbs, and throughout the state of Illinois.
