Petitioner injured his left wrist while restraining a combative detainee.


Commissioner Deer, seconded by Commissioner Goslin moved Approval. The motion carried.

ADJOURNMENT


A motion was made by Commissioner Moody, seconded by Commissioner Tobolski to adjourn the meeting. The motion carried by the following vote:
