CONGRATULATING JORGE RAMIREZ ON HIS RETIREMENT FROM THE CHICAGO FEDERATION OF LABOR

WHEREAS, this June, Jorge Ramirez will be retiring from his position as president of the Chicago Federation of Labor (CFL) and as vice president of the American Federation of Labor and Congress of Industrial Organizations (AFL-CIO); and

WHEREAS, Jorge Ramirez was elected president of the CFL, an organization with 320 affiliates representing workers from pilots to doctors to zookeepers, in 2010, having previously served as secretary-treasurer. Prior to joining the CFL in 2006, Ramirez was elected vice president and served as executive director of Local 1546 of the United Food and Commercial Workers International Union, representing nearly 30,000 members in Chicago and throughout Illinois; and

WHEREAS, since 2008, Ramirez has served on the Cook County Health and Hospitals System Board of Directors as Vice-Chairman. In 2012, he was named to the Chicago Infrastructure Trust board and the Cook County President's Council of Economic Advisors. He currently serves as a member of the UNITED STATES Department of Labor's Labor Advisory Committee, the Chicago Convention and Tourism Bureau Board of Directors, the Navy Pier, Inc. Board of Directors, the Chicago Cook Workforce Partnership and

is co-chairman of the City of Chicago Labor Management Cooperative Committee (LMCC) and on the Federal Reserve Bank of Chicago's Board of Directors; and

WHEREAS, Jorge also serves as co-chairman of the Chicago Manufacturing Renaissance Council and member of the National Manufacturing Renaissance Campaign design team and a director of the Lincoln Academy of Illinois. Ramirez also serves on the Mercy Home for Boys and Girls Board of Regents, the United Way of Metropolitan Chicago Board of Directors and a number of other boards and commissions; and

WHEREAS, in 2012, Jorge was named one of Chicago Magazine's 100 most powerful Chicagoans, a great testament to his influence and dedication to the Labor movement and residents of the Chicagoland area; and

WHEREAS, as the son of Mexican immigrants, Jorge understood the struggles his father, a meat packing worker in Chicago's Back of the Yards neighborhood, and his fellow workers endured to unionize their workplace in the 1960s. Their fight for a living wage and better conditions motivated Jorge in his career serving working men and women in organized labor.

RECOGNIZING THE MEN AND WOMEN OF COMED THAT VOLUNTEERED TO RESTORE ELECTRICITY TO PUERTO RICO

WHEREAS, originating from a tropical wave that the National Hurricane Center began monitoring on September 13, Maria developed into a tropical storm on September 16 strengthening just a couple of days later to a Category 5 hurricane, sustaining wind speeds of up to 160 mph and making the 2017 season the first since 2007 to feature two (2) Category 5 hurricanes; and

WHEREAS, with winds of 155 mph, Maria made landfall in Puerto Rico on September 20, 2017, making this hurricane the strongest to hit the territory since the 1928 San Felipe hurricane; and

WHEREAS, hurricane Maria hit Puerto Rico and the UNITED STATES Virgin Islands just 14 days after hurricane Irma skirted the island, damaging the electrical grid, compounding problems for all Puerto Ricans; and

WHEREAS, all of the 3.5 million residents of Puerto Rico lost power following hurricanes Irma and Maria and in the nearly nine (9) months since hurricane Maria made landfall in Puerto Rico, more than 40,000 people are still without electricity; and

WHEREAS, Puerto Rico is experiencing the longest blackout in UNITED STATES history and second-longest in world history, forcing Puerto Ricans to live, work, cook, attend school and live life in the dark; and

WHEREAS, 146 ComEd employees raised their hand and volunteered to travel to help their fellow Americans in Puerto Rico facing unfamiliar and treacherous terrain on the island's mountains and in its rainforests; and

WHEREAS, these employees, along with utility workers from the five (5) other Exelon utilities, spent over 50 days in Puerto Rico visiting some of the areas hit hardest by the hurricane and installing 376 poles, 267 transformers, and more than 108 miles of cable thus helping more than 11,000 residents in the affected areas.

NOW, THEREFORE, BE IT RESOLVED, that the President and the Cook County Board of Commissioners, on behalf of the residents of Cook County, do hereby recognize the invaluable humanitarian effort by the men and women of ComEd who volunteered to help our fellow Americans in the Island of Puerto Rico; and

WHEREAS, the Honorable George Neves Leighton, née Leitão, was born on October 22, 1912 in New Bedford, Massachusetts to Ana Silva Garcia and António Neves Leitão; and

WHEREAS, the Honorable George N. Leighton's surname was changed to Leighton after an elementary school teacher claimed she could not pronounce Leitão; and

WHEREAS, the Honorable George Neves Leighton was raised in New Bedford and Cape Cod, Massachusetts, where as a child he worked picking cranberries and blueberries with his parents; and

WHEREAS, agricultural work limited his educational studies, only completing up to the 7th grade before leaving at the age of 17 to work on an oil tanker sailing to the Dutch West Indies; and

WHEREAS, despite never completing high school, the Honorable George N. Leighton used his free time reading and also attended night school; and

WHEREAS, with great perseverance and skills, he won a scholarship competition and was admitted to Howard University in 1936, graduating magna cum laude four years later; and

WHEREAS, in 1940, he was drafted into military service where he became Captain of Infantry before being relieved of active duty in 1945; and

WHEREAS, upon his return, he attended Harvard University Law School and earned a Bachelor of Laws degree in 1946; and

WHEREAS, soon after graduation, the Honorable George N. Leighton and his wife, Virginia Berry Quivers, moved to Chicago, Illinois; and

WHEREAS, after passing the Illinois Bar exam in 1947, he quickly rose within the legal and African-American community as an attorney who fought for equality in voting rights, the school system and housing; and

WHEREAS, one of his most notable civil rights cases was advising an African-American family it was their constitutional right to move to a predominantly white neighborhood in Cicero, Illinois; and

WHEREAS, the case sparked a race riot and shed light on housing inequalities the African-American community faced; and

WHEREAS, in 1951, he co-founded Moore, Ming, and Leighton which became one of the largest predominantly African-American law firms in the nation; and

WHEREAS, in 1969, he was assigned to sit as a judge on the United States Court of Appeals in Illinois' First District; and

WHEREAS, in 1976, President Gerald Ford nominated him to serve as a United States District Court judge; and

WHEREAS, after retiring from the United States District Court, he continued working at the firm Langdon Neal until his retirement at age 99; and

WHEREAS, on June 29, 2012, the Cook County courthouse located at 26th and California was renamed "The Honorable George N. Leighton Criminal Court Building" in honor of his legal career as a civil rights attorney; and

WHEREAS, the Honorable George N. Leighton was an exemplary leader, judge, humanitarian and civil rights advocate who contributed to the improvement of the community in Cook County and everywhere he went; and

WHEREAS, the Honorable George N. Leighton passed away on June 6, 2018 in Brockton, Massachusetts; and

WHEREAS, he is survived by two (2) daughters, Virginia Anne and Barbara Elaine, five (5) grandchildren and eight (8) great grandchildren; and

WHEREAS, the Honorable George N. Leighton will be sorely missed by friends, family and colleagues throughout Cook County.

HONORING REVEREND LESLIE SANDERS AND HOPE PRESBYTERIAN CHURCH 121ST YEAR ANNIVERSARY

WHEREAS, on Sunday, August 25, 2018, Hope Presbyterian Church will celebrate its 121st Anniversary; and

WHEREAS, Hope Presbyterian was organized in 1897 under the direction of Reverend I.W. Nicholson and a few members of the Cumberland Presbyterian Church who moved from Bowling Green, Kentucky to Chicago and settled in the West Englewood community who felt that Presbyterian witness should be organized in this area; and

WHEREAS, the first installed Pastor was the Reverend George Washington Camp in 1909 and with hard work and various fundraisers, the members were able to purchase lots at 61st Street and Loomis Boulevard. Ground was broken for the present edifice in 1911 and the building was completed in 1913. The members actually built the church; and

WHEREAS, in 1911, the congregation called the Reverend C. Lee Jefferson and moved in the present building with the financial assistance of the Presbytery. Through World Wars I and II and the Great Depression, Hope Church continued to grow and develop; and

WHEREAS, in early 1941, the church called the Reverend Herbert W. Jones who's long and successful tenure ended in June of 1980. Under his leadership, the church began to show new life and growth. Tragedy struck in November 1967 when the Sanctuary was severely burned, but the congregation was determined to rebuild and refurbish the Sanctuary in one year. With the great desire to progress, the congregation also erected the beautiful, multipurpose Christian Education Center at the cost of \$250,000.00; and

WHEREAS, in February 1986, Reverend Dr. Floyd N. Rhodes recommended the Reverend Leslie Sanders to Hope Church. In March 1987, Reverend Sanders was installed as Pastor and brought a dynamic style of preaching, a unique leadership ability, and an abundance of energy and enthusiasm. Under his leadership the church is experiencing rapid growth spiritually, numerically and financially; and

WHEREAS, in July 1983, Pastor Bonds was elected Moderator of Salem Baptist District Association making True Vine the first church of the district. He faithfully served three successful years in that office; and

WHEREAS, collaboratively the First Ladies, Danielle Ashley Group, and Walgreens initiated an HIV/AIDS Task Force which culminated in the formation of the Walgreens First Ladies Health Day; and

WHEREAS, the First Ladies Health Day which is the largest health day in the nation of its kind is held annually in Chicago, Illinois, Gary, Indiana, Los Angeles, Orange County, California, and Cincinnati, Ohio. The program begins with a luncheon that's attended by nearly 200 pastor's wives, who hear information from medical professionals on how to educate their communities about various illnesses; and

WHEREAS, since 2009 the First Ladies Health Day has provided free health screening to over 30,000 people throughout Chicago, surrounding states and now California; and

WHEREAS, on May 20, 2012 The Inaugural First Ladies Los Angeles Health Screening Day took place; and

WHEREAS, in June of 2014, the Danielle Ashley Group was the only African American, women-owned agency at the Public Relations Society of America Ceremony in New York City. Mrs. Tracey Alston was awarded the Silver Anvil Award of Excellence, in the public service (Partnerships) category for developing the First Ladies Health Initiative in Chicago and Los Angeles; and

WHEREAS, in 2015 The First Ladies Health Initiative, had enabled more than 75,000 individuals to get screened for illnesses. The effort has expanded to now include Gary, Indiana, Los Angeles, Orange County, California, and Cincinnati, Ohio; and

WHEREAS, in 2016 in Chicago, three (3) predominately Hispanic house of worships: Christian Fellowship Flock South, Iglesia Bautista Casa Degracia, and Rebano Church became a part of the First Ladies Health Initiative Program; and

WHEREAS, the result was the First Ladies Health Initiative which has expanded tremendously-starting with the wives of 13 pastors in Chicago to 172 First Ladies across all denominations between the ages of 31-83 from Chicago, Gary, Los Angeles, Orange County, and Cincinnati; and

WHEREAS, Tracey Alston, the founder of Danielle Ashley Group and the executive director of the First Ladies Health Initiative says she's proud to be a part of a true sisterhood of organized women working together for the health of the community; and

WHEREAS, Walgreens Corporation support of the First Ladies Health Initiative started when it launched; and, today, they continue to share a common mission of creating healthier communities; and

WHEREAS, on June 16, 2018 we recognize and celebrate the 10th year anniversary and officially kickoff the First Ladies Health Initiative for 2018.

NOW, THEREFORE, BE IT RESOLVED, that the President and Cook County Board of Commissioners congratulates, and recognize the outstanding achievements of the First Ladies Health Initiative for nearly saving hundreds of thousands of lives; and

BE IT FURTHER RESOLVED, that this Resolution is spread upon the permanent record of Proceedings of the Board of Commissioners of Cook County, and that a suitable copy of this Resolution will be prepared and presented to the First Ladies Health Initiative.

WHEREAS, Isaac "Redd" Holt was a member of the Ramsey Lewis Trio. A group that achieved a gold record, and won a Grammy Award for "In Crowd"; and

WHEREAS, Isaac "Redd" Holt later formed the group Young-Holt Unlimited that performed internationally in Singapore, Malaysia, Indonesia, and Hong Kong. The group performed for eight (8) years in top jazz clubs, at concerts, and producing great Jazz albums; and

WHEREAS, Young-Holt Unlimited was awarded a Gold Record for their recording of "Soulful Strut"; and

WHEREAS, Isaac "Redd" Holt has over 50 years of dedication to the music of jazz. Performing in concert with other jazz greats such as Duke Ellington, Count Basie, Miles Davis, Nancy Wilson, Max Roach, Cannonball Adderley, B. B. King, Aretha Franklin, Tito Puente, Oscar Brown, Jr., James Brown, Nina Simone, and many others; and

WHEREAS, the song Wack-Wack by Young-Holt Unlimited was the opening song for the motion picture "Trial Run"; and
