HONORING THE LIFE OF RAQUEL GUERRERO, COMMUNITY ADVOCATE AND FOUNDING MEMBER OF THE ASOCIACIÓN PRO DERECHOS OBREROS

WHEREAS, Raquel Guerrero was a leader, organizer, and activist in Chicago's Pilsen neighborhood for over 40 years; and

WHEREAS, her efforts to support education, culture, and social justice will continue to have a long-lasting impact on her community; and

WHEREAS, in the late 1960's, she played an instrumental role in the boycott and occupation of Froebel High School, then a satellite branch of Harrison High School; and

WHEREAS, these actions were meant to protest against the lack of resources for the school and led to historic walkouts organized by both African-American and Mexican-American students; and

WHEREAS, these walkouts started an education reform movement in Pilsen between parents, clergy, and activists that led to the efforts towards the first public high school in the neighborhood; and

WHEREAS, as a result, in 1972, Mrs. Guerrero and hundreds of other community members delivered petitions to the Chicago Board of Education and made a case for a public high school which is now known as Benito Juarez Community Academy; and

WHEREAS, Mrs. Guerrero's education efforts continued as she organized residents and advocated for funding to establish Pilsen's local branch of the Chicago Public Library, which was named for critical community figure, Rudy Lozano; and

WHEREAS, Raquel Guerrero also contributed to establishing Fiesta del Sol, one of the largest summer festivals in the Midwest which has drawn visitors for over 45 years and is emblematic of the Mexican-American community in Pilsen; and

WHEREAS, additionally, Mrs. Guerrero was a founding member of Asociación Pro Derechos Obreros, a workers' rights organization with an important history as a resource for the community; and

WHEREAS, Mrs. Guerrero arrived to the United States from Mexico in the 1960's and made Pilsen her home until her passing on February 1, 2019; and

WHEREAS, Raquel Guerrero was the beloved mother of nine (9) children, grandmother to 36 grandchildren and great-grandchildren, and devoted spouse to the late Jose Acosta Guerrero; and

WHEREAS, known for her strength and compassion, Raquel Guerrero's legacy will live on through the lasting impact her work will have on the Pilsen community for generations to come.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners does hereby honor the life and work of cherished community leader Raquel Guerrero; and

HONORING THE LATE BISHOP CARLIS L. MOODY, SR.

WHEREAS, Bishop Carlis L. Moody, Sr. was born December 16, 1934 to Mr. Booker T. and Geneva Moody, in the city of Tifton, Georgia; and

WHEREAS, as Bishop Moody was married to Mary Alice in September 1955, and their union was blessed with one (1) daughter, Missionary Sideary King, three (3) sons, Pastor Carlis Moody, Jr., Bishop Anthony Moody, Sr., and Minister Jeffrey Moody; and

WHEREAS, Bishop Moody had a total of 12 grandchildren and three (3) great grandchildren and was revered in the community as a father to the fatherless, a mentor, and surrogate parent to many; and

WHEREAS, Bishop Moody accepted the call to preach in July 1946 in the city of Waukegan, Illinois, and was ordained four (4) years later by the late Church of God in Christ (COGIC) Bishop W. M. Roberts. At the age of 16, he established a small church in Waukegan on Market Street and incorporated that congregation into St. James Temple Church of God in Christ in North Chicago, Illinois, where he served as youth pastor and district Sunday School superintendent from 1952 until 1957; and

WHEREAS, in 1956, Mother Sadie Adams and her son Bishop Eugene Adams went to Bishop L. H. Ford and asked him to send Bishop Moody to Evanston, Illinois to open Faith Temple on January 7, 1957. And, since that time, the congregation to grew from six (6) persons to over 200 families, and over 500 members; and

WHEREAS, after attending Moody Bible Institute in 1970, Bishop Moody began to minister in over 38 countries; and

WHEREAS, Bishop Moody served as vice president of the Black Ministers Alliance of Evanston for two (2) years. He also served as a member of the Curriculum Council for the Evanston Township High School for one (1) year; and

WHEREAS, in 1975, Bishop Moody was appointed COGIC's International President of the Home and Foreign Missions Department, which reaches into over 57 countries. In that capacity, he headed all mission work of the COGIC in foreign countries as well as in the United States and served as the Jurisdictional Bishop of Germany; and

WHEREAS, in 1976, he was elected to serve as a member of the Advisory Committee of the Pentecostal World Conference where he served for 27 years; and

WHEREAS, while maintaining his missionary work around the world, Bishop Moody stayed active in Evanston as well. In addition to leading hundreds each Sunday in church, Bishop Moody established a Nursing Home Ministry, Food Pantry, and Prison Ministry to service the community. He offered Faith Temple Church as a home church for 11 years to the Drug Rehabilitation Centers in Evanston and Chicago, helping men and women fight addiction and reduce recidivism. The Faith Temple congregation ministered in their community through radio for 13 years and on television for the past 10 years; and

WHEREAS, in September 1980 Bishop Moody established "Faith Christian Academy," now serving students in kindergarten through eighth grades. He spearheaded the Academy as a means to enrich the lives of young people in the Evanston north shore area and to foster respect, compassion, honesty, and service; and

WHEREAS, in 1982, Bishop Moody was consecrated as Missionary Bishop in the Church of God in Christ; and

WHEREAS, in January 1996, and in recognition of Bishop Moody's leadership and outstanding service to humanity, the City of Evanston designated a portion of Dewey Avenue as Honorary Bishop Carlis L. Moody Avenue; and

WHEREAS, on the May 7, 2005 Bishop Moody was bestowed an Honorary Doctor of Divinity by the Interdenominational Theological Center and Charles H. Mason Theological Seminary in Atlanta, Georgia; and

WHEREAS, on January 29, 2007 there was a service held for the renaming of the J.W. Markham District to the Bishop Carlis L Moody District. This District comes under First Jurisdiction of Illinois Church of God in Christ; and

WHEREAS Bishop Carlis L. Moody made his transition on January 12, 2019 bringing to completion an exemplary life of service, dedication, and faith to the people of Cook County, the State of Illinois and many municipalities across the nation and around the world.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Cook County, on behalf of the 5.2 million residents of Cook County takes great pleasure in honoring and celebrating Bishop Moody's life of service and monumental contributions to humanity, and herewith honors Bishop Moody for bettering the lives of the citizens of Cook County, Illinois and throughout the word; and

HONORING DR. LENA J. McLIN

As Paul the Apostle, teaches about individual responsibility he says these words in Ephesians 5:19, "Speaking to yourselves in psalms and hymns and spiritual songs, singing and making melody in your heart to the Lord"

WHEREAS, Dr. Lena J. McLin was born September 5, 1928 in Atlanta, Georgia, to the union of Benjamin J. Johnson and Bernice Dorsey. Where Dr. McLin's close childhood friends were Martin Luther King, Jr. and his sister Christine King Farris; and

WHEREAS, Dr. Lena J. McLin at the tender age of five, was sent to Chicago to live with her uncle, Thomas A. Dorsey, better known as the father of gospel music; where she attended McCosh Elementary School and served as a young accompanist for her uncle's famed Pilgrim Baptist Church choir; and

WHEREAS, Dr. Lena J. McLin, moved back to Atlanta, Georgia and graduated from Booker T. Washington High School in 1947, then enrolled at Spelman College, and earned her Bachelor of Music degree in 1951. She later returned to Chicago and studied at the American Conservatory of Music, Roosevelt University, and Chicago State University; and

WHEREAS, Dr. Lena J. McLin, began her teaching career at Julius H. Hess Upper Grade Center in 1959. She transferred to Hubbard High School in 1960. Moving forward she founded "The McLin Ensemble" and the "McLin Opera Company". She went on to teach at John Marshall Harlan High School from 1963 to 1970, leaving to go teach at the new Kenwood Academy. During her tenure at Kenwood Academy, Dr. McLin created a pilot curriculum that included all genres of music, from classical to popular, which helped to launch the careers of Chaka Khan, Mark Rucker, Nicole Heaston Lane; jazz singers Maggie Brown and Tammy McCann; Tony Award and Emmy Award winner Mandy Patinkin.

REMEMBERING REV. JAMES BASS

WHEREAS, Almighty God, in His infinite wisdom, has called Reverend James Bass of Chicago from our midst on November 27, 2018; and

WHEREAS, Reverend James Bass was born May 7, 1920 in Ruleville, Mississippi. He was the oldest of six (6) children born to the union of Frank and Hattie Bell Bass; and

WHEREAS, Reverend Bass was called into the ministry at the age of six; the children from neighboring farms gathered in one house on Sunday evenings to play church; he would conduct the services rendering the sermon, praying and singing; he ministered at the funeral of "anything that died" and was repeatedly referred to as the "The Preacher Boy"; he accepted Christ as his personal Savior on a Tuesday in August 1929 and was baptized in the Sunflower River; he became a faithful and dedicated young man as he grew in wisdom and knowledge; and

WHEREAS, on December 7, 1941, Reverend Bass was drafted into the United States Army, where he served his country for three (3) years during World War II; he continued his ministry during this time, speaking and teaching to fellow soldiers. He was promoted to Corporal in 1944 and was sent with his division to the South Pacific, India and New Guinea, where his division was joined by the 92nd infantry amidst fierce fighting; he became the chaplain on the field and conducted worship services and delivered the mail; he was discharged on June 7, 1945 and received an array of medals; and

WHEREAS, Reverend Bass began his freshman year at Tugaloo College in 1948, majoring in History; he attended the Mississippi Seminary in Jackson, Mississippi in 1951 and became the Pastor of the Mt. Israel Baptist Church in Clarksdale, Mississippi, where he sponsored a broadcast for the senior citizens, the sick and shut-ins; and

WHEREAS, in December of 1955, Reverend Bass conducted a revival at Mt. Canaan Baptist Church in Detroit, Michigan; he made a stop in Chicago to visit his brother Harry, and his sister, Mamie; he preached at the Greater Door Baptist Church; and

WHEREAS, in August of 1956, a small mission was started and rapidly grew in numbers; the Mt. Olive Missionary Baptist Church of Chicago was organized in September of 1956; in February 1957, Reverend Bass returned to Chicago; he commuted between Chicago and Mississippi twice a month, but soon permanently relocated to Chicago; he served six (6) years as a Pastor in Mississippi; and

WHEREAS, in 1967 Reverend Bass married Helyn Maxcine Julius; the couple was blessed with a son Vincent and a daughter Vikkeda; and

WHEREAS; Reverend Bass served as the Pastor of Mt. Olive for 45 years and would quote this scripture; "I am crucified with Christ; Nevertheless, I live; yet not I, but Christ liveth in me; and the life which I now live in the flesh I live by the faith of the Son of God. HONORING THE REDEDICATION OF EBENEZER PRIMM TOWERS IN EVANSTON, AND HONORING THE LEGACY OF REVEREND JACOB S. BLAKE

WHEREAS, Ebenezer Primm Towers was the first church sponsored federally funded housing project in a major suburban area. It was rededicated on Sunday, July 30, 2017. At its rededication, the community honored the Reverend Jacob S. Blake's pivotal role in making Ebenezer Primm Towers a reality and the powerful legacy of Reverend Blake and Ebenezer African Methodist Episcopal (AME) Church; and

WHEREAS, for decades, prior to arriving in Evanston, Reverend Blake was a leader and a major force for good in the region battling profound injustices, such as redlining, housing discrimination, education inequity and busing. In Evanston, in addition to so many other issues, he worked tirelessly to establish affordable housing for the senior citizens in Evanston, where rents were rising rapidly. The result was the establishment of Ebenezer Primm Towers, which has a proud history that is a reflection of Reverend Blake and his intense determination and strong leadership; and

WHEREAS, Ebenezer Primm Towers came about in an unprecedented real estate deal with Northwestern University. Reverend Blake and Ebenezer AME Church purchased land owned by the university at 25% below market value for \$75,000.00 According to university officials, Northwestern sold the land to the church to foster good community relations and to dispel the notion that the university only expanded in black communities. The Northwestern Black Student Union, the Black Ensemble of Northwestern and the African American Community in Evanston put pressure on the University to sell the land. But there was a catch to the deal, if construction didn't start within 24 months of the sale, Northwestern University could buy the property back. With the clock ticking, funds were raised via several sources. The church got a loan to buy the land and received a grant from the United States Department of Housing and Urban Development to help finance the \$500,000.00 construction project. The rest was raised by the community that pulled together to make the dream a reality; and

WHEREAS, Joseph Levy, owner of a Buick car dealership at the time, donated a brand new Buick to be auctioned off to raise money for the project. The church held fundraisers which included selling dinners, hosting basketball tournaments, and events at the Ebenezer AME Church 90th Anniversary Gala. To ensure that housing for the elderly remained a priority in Evanston, John Young, Urban Planner of Evanston at the time worked with a committee to create a special zoning district for that purpose. Ebenezer Primm Towers was dedicated July 1973 and residents moved in soon after; and

WHEREAS, Reverend Blake's widow Patricia G. Blake and sons Justin S. Blake and Jacob S. Blake Jr. were in attendance at the rededication of Ebenezer Primm Towers along with members of Ebenezer AME Church, other family members and friends; the community honored Reverend Jacob S. Blake's crucial role in making Ebenezer Primm Towers a reality.

WHEREAS, Langford practiced law throughout the State of Illinois, defended civil rights workers in the 1960s and joined Dr. Martin Luther King, Jr.'s Chicago civil rights marches. In 1963 and 1964, she provided free legal services in many areas, including the State of Mississippi; and

WHEREAS, the estimated annual incidence of heart attack in the United States is 720,000 new attacks and 335,000 recurrent attacks with Americans suffering a heart attack approximately every 40 seconds; The average age at the first heart attack is 65.6 years for males and 72.0 years for females; and

WHEREAS, although some progress has been made, it's important to make sure all Americans have access to quality care and as a country we should continue to focus on "Life's Simple 7," which refers to the American Heart Association's seven goals of eating a healthy diet, exercising regularly, avoiding excess weight, not smoking, and keeping blood pressure, cholesterol and blood sugar within a healthy range; and

WHEREAS, nearly half of all non-Hispanic black adults have some form of cardiovascular disease, 47.7 percent of females and 46.0 percent of males; and

WHEREAS, by 2035, more than 130 million adults, or 45.1% of the United States population, are projected to have some form of cardiovascular disease and total costs of CVD are expected to reach \$1.1 trillion in 2035, with direct medical costs projected to reach \$748.7 billion and indirect costs estimated to reach \$368 billion; and

WHEREAS, hospitals and health systems around the country celebrate American Hearth Month by helping to raise awareness in their communities about heart disease, with staff wearing red and volunteers knitting or crocheting pint-sized red hats for newborns, as well as holding free screenings and heart health awareness events; and

WHEREAS, it was in Memphis that Sue became very active as a civil rights advocate as Memphis was racially segregated at the time and Sue was very involved in the organized boycotts and sit-ins as a member of the National Association for the Advancement of colored people (NAACP), Urban League and other civil rights organizations; and

WHEREAS, in 1965, her husband passed away after a battle with lung cancer and Sue and her daughter Etta Sue returned to her parents' home in Chicago, Illinois, and at the age of 45, Sue began a career with the City of Chicago as an Assistant Director of several Neighborhood Service Centers, which was an outgrowth of the Model Cities Program; and

WHEREAS, under the direction of Erwin France, Sue became an exceptional manager and enjoyed working in the various communities assisting residents that needed social services. A RESOLUTION HONORING JERRY T. JONES FOR HIS DISTINGUISHED LIFE AND CAREER

WHEREAS, Jerry T. Jones (born JT Jones) was born on March 25, 1936 in Sledge, Mississippi by way of a midwife; and

WHEREAS, Sledge was predominantly white and more affluent than Falcon where his mother lived, and which was occupied almost entirely by Black people; however, businesses in Falcon were Black owned including a cotton gin, in fact his father in addition to being the man in charge of the local cotton gin operation also owned a restaurant called a "juke joint" and the differences between the two towns had a profound influence on Jerry's perception of life; and

WHEREAS, when JT was eight (8) years old, his uncle gave him a battery powered radio and he was immediately fascinated by the ability to listen to music and other programs from places as far away as Helena, Arkansas; his interest was so great that at the age of eight (8), he declared that he was going to make radios when he grew up; and

WHEREAS, in the summer of 1949, JT and his parents migrated from Sledge to Chicago because JT, at the age of 12, had endured an increasing amount of threats from the white community on his life; and

WHEREAS, when JT made it to Chicago, he enrolled at Wendell Phillips high School, located on Chicago's South Side at 39th Street and Prairie Avenue, which served as a bedrock education for JT and he graduated at 16 years old in 1952 as the youngest person in his class; and

WHEREAS, in the fall of 1952, JT enrolled at the University of Illinois at Navy Pier, which was only a 2-year college at that time, so after finishing there, JT enrolled in night school at the Illinois Institute of Technology's Chicago campus to continue his education; and

WHEREAS, throughout his college years, JT landed several jobs that were very instrumental to his life; his first job was as a draftsman at Western Electric, which was a subsidiary of AT&T; after a year, JT was able to apply for a job at Argonne National Laboratory, which is owned by the United States Department of Energy, but is operated by the University of Chicago; and

WHEREAS, after working for two (2) years in the Chemical Engineering Division at Argonne Laboratory, he was offered a job at the Illinois Institute of Technology Research Institute (IITRI) and while working at IITRI's Chemical Engineering Division and later their Physics Division, JT received his degree from the Illinois Institute of Technology (IIT) with concentrations in physics and electrical engineering; and

WHEREAS, during JT's time at the IITRI, he also became active in the civil rights movement, including participating in the historic march from Selma to Montgomery, Alabama and he also became active in local politics, becoming a precinct Captain in the neighborhood he lived; and

WHEREAS, one of JT's main objectives was to provide jobs for Black men and women on the South Side of Chicago, and so in March of 1966, JT started Sonicraft, an engineering and manufacturing company on the Chicago's South Side; JT's dreams began to come into focus and in 1970, Jerry was awarded the Illinois Small Businessman of the Year award and later would go on to win the largest government contract ever awarded to a small business in 1982 with an estimated value of approximately \$300 Million; and

WHEREAS, while President and Chief Executive Officer (CEO) of Sonicraft, JT also sat on the Board of Trustees at IIT, the National Business League, formerly the National Negro Business League, which was founded by Booker T. Washington in 1900, the Advisory Board of the United States Secretary of Treasury, the Regional and National Advisory Board of the United States Small Business Administration, the Advisory Council of the NCAAP, and was also a founder and chairmen of the National Association of Black Manufacturers, which sought to create and foster the development of Black owned businesses, later joining the Board of the National Association of Manufacturers and became a board member of the Chicago Association of Commerce; and

WHEREAS, beginning in the basement of JT's house, Sonicraft was truly a family affair as Jerry's step father Robert worked at Sonicraft until he retired; JT's son Jerome worked in Sales and Business Development; His son Bretrand worked in Legislative Affairs and Business Development, while his daughter Lara was employed in Human Resources Management, and together they helped grow the company to employ over 500 people; and

WHEREAS, JT currently lives in Lynwood, Illinois in the 6th Cook County District and remains active in the community.

NOW, THEREFORE, BE IT RESOLVED, that the President and Members of the Cook County Board of Commissioners proudly honors Jerry T. Jones for his distinguished and trailblazing career and for his service to the community, the City of Chicago and to Cook County; and

HONORING THE FOUNDERS AND CO-OWNERS OF VEE-JAY RECORDS, VIVIAN CARTER-BRACKEN, JAMES BRACKEN AND CALVIN CARTER

WHEREAS, Vee-Jay Records was one of the first black-owned American independent record label established in 1953 in Gary, Indiana; and

WHEREAS, its principal office, and longest tenancy, was located at 1449 South Michigan Avenue, today a historic landmark site for that very reason; and

WHEREAS, Vee-Jay Records label name was derived from the first name initials of the husband and wife team of Vivian Carter-Bracken (Vee) and James Bracken (Jay); and

WHEREAS, the Brackens along with Vivian's brother, Calvin Carter, prospered Vee-Jay Records into a successful black-owned independent record company specializing in blues, jazz, gospel, rhythm and blues (R&B) and rock and roll; and

WHEREAS, Vee-Jay Records produced major acts on the label in the 1950s including blues singers Jimmy Reed, Memphis Slim, and John Lee Hooker, and rhythm and blues vocal groups the Spaniels, the Dells, and the El Dorados; and

WHEREAS, in the 1960s, Vee-Jay Records became a major soul label with Jerry Butler and the Impressions, Gene Chandler, Dee Clark, and Betty Everett having hit singles on both the pop and R&B charts; and

WHEREAS, Vee-Jay Records was also the first label to nationally issue a record by The Pips, who eventually became Gladys Knight and the Pips in 1962 when they moved to Fury Records; and

WHEREAS, Vee-Jay Records had significant success with pop/rock and roll acts, such as the Four Seasons (their first non-black act) and the Beatles; and

WHEREAS, Vee-Jay Records acquired the rights to some of the early recordings by the Beatles through a licensing deal with EMI, as the EMI American affiliate Capitol Records was initially uninterested in the group; and

WHEREAS, Vee-Jay Records was the only American label willing to give the Beatles an opportunity in the United States and became the first United States record company to release recordings by the Beatles including "Twist and Shout", "Please Please Me", "From Me to You", "Do You Want to Know a Secret", and "Love Me Do"; and

WHEREAS, in the mid-1960s, Vee-Jay Records signed the former successful child singer Jimmy Boyd, known for the hit "I Saw Mommy Kissing Santa Claus", ventured into folk music with Hoyt Axton and New Wine Singers, and also picked up Little Richard who re-recorded his special hits and recorded (1965) "I Don't Know What You've Got (But It's Got Me)", an R&B success with Jimi Hendrix, Don Covay, Bernard Purdie, Ronny Miller, and Billy Preston; and

WHEREAS, Vee-Jay Records' jazz line accounted for a small portion of the company's releases, recording artists such as Wynton Kelly, Lee Morgan, Eddie Harris, and Wayne Shorter; and

WHEREAS, Vee-Jay Records also had a major gospel line, recording such acts as the Staple Singers, the Argo Singers, Swan Silvertones, the Caravans, Dorothy Love Coates and the Gospel Harmonettes, and Maceo Woods; and

WHEREAS, Vee-Jay Records even released comedy on LPs, with records by Dick Gregory, and Them Poems, Mason Williams' early nightclub act recorded with a live studio audience in 1964; and

WHEREAS, Vee-Jay Records were pioneers who contributed immensely to black art and culture, entrepreneurship, black pride, diversity, and gave opportunities to all the persons it recorded, released and employed including those who received Grammys, American Music Awards and are Inductees in the Rock N Roll and Blues Hall of Fame.

NOW, THEREFORE, BE IT RESOLVED, that the President and the Cook County Board of Commissioners, on behalf of the residents of Cook County, honor Vivian Carter-Bracken, James Bracken, and Calvin Carter, Founders and Owners of Vee-Jay Records and praise their contributions to the African-American art and culture of Cook County.

HONORING DR. LYN HUGHES, FOUNDER OF THE NATIONAL A. PHILIP RANDOLPH PULLMAN PORTER MUSEUM

WHEREAS, Dr. Lyn Hughes, a former international entertainer - now an activist and scholar - moved to Chicago in the late 1980s; and

WHEREAS, in 1990, she began speculating real estate on Chicago's south side and discovered the Pullman historic district; and\

WHEREAS, after discovering an important slice of African American history, in 1995 Dr. Hughes founded The National A. Philip Randolph Pullman Porter Museum (NAPRPPM), a public museum located in the National Park Service-Pullman National Monument on the south side of Chicago; and

WHEREAS, not only is the museum about history, it's founding also made history by being founded by an African American female with predominantly private funds, and to this day operates on an entrepreneurial model; and

WHEREAS, NAPRPPM is the first Black Labor History Museum in the United States that exclusively tells the story of A. Philip Randolph, a New York magazine publisher, turned union organizer and civil rights leader, who after organizing the Pullman Porters in 1925, became founder of the Brotherhood of Sleeping Car Porters; and

WHEREAS, the Brotherhood of Sleeping Car Porters was the first African American labor union in America to be chartered under the American Federation of Labor, and the first to win a collective bargaining agreement with a major U.S corporation, the Pullman Company; and

WHEREAS, the museum presents and interprets content intended to educate the public on the impact the Brotherhood of Sleeping Car Porters union had on organized labor and on America's modern day civil rights movement; and

WHEREAS, the registry garnered the interest of Amtrak, who partnered with the National A. Philip Randolph Pullman Porter Museum and developed a national program using the registry to locate, acknowledge and honor surviving members of the union, in ceremonies nationwide; and

WHEREAS, Dr. Hughes's dedication and efforts to illuminate the museum's existence and its thematic content has resulted in global recognition in the tourism industry, for its unique interpretation of this significant component of American history; and

WHEREAS, the museum attracted the attention of the SHOWTIME network and inspired the creation of the 2003 docudrama, *10,000 Black Men Named George*, yielding an interest in history, of an entirely new generation; and

WHEREAS, the interest in the history Hughes excavated continued, and garnered the attention of ABC's Good Morning America, who was prompted to bring their crew to Chicago to the boutique museum and film a segment on the Pullman Porters; and

WHEREAS, in 2014, Dr. Jon Jarvis, then, director of the National Park Service also made his way to Chicago to see the museum and meet Dr. Lyn Hughes; and

WHEREAS, in February 2015, President Barack Obama designated the historic Pullman District a national monument; and

WHEREAS, the museum has now made history again by becoming a historical black history site in Chicago's national park service.

NOW, THEREFORE, BE IT RESOLVED, that the President and the Cook County Board of Commissioners, on behalf of the residents of Cook County, honor Dr. Lyn Hughes, founder of the National A.
