WHEREAS, Crystal Carbellos was a proud and dedicated employee of the Cook County Public Defender's Office for almost twenty years; and

WHEREAS, Crystal Carbellos passed away on February 22, 2019; and

WHEREAS, Crystal Carbellos earned her bachelor's degree from University of Minnesota and worked as a Certified Public Accountant; and

WHEREAS, she earned her Juris Doctorate from Chicago-Kent College of Law Illinois Institute of Technology in 1995 and was admitted to the Illinois Bar in 1997; and

WHEREAS, as a law student Crystal Carbellos worked at the Chicago-Kent Law Offices as a clinic student defending those accused of crimes under the tutelage of Professor Richard Kling and found her calling to be the voice and a shield for the accused; and

WHEREAS, after getting her law degree, Crystal Carbellos joined the Cook County Public Defender's Office as an assistant public defender in May 1997 and dedicated herself to finding justice for her clients; and

WHEREAS, Crystal Carbellos worked in the Traffic Division, Juvenile Justice Division, and Felony Trial Division of the Cook County Public Defender's Office as an assistant public defender, before joining the special Homicide Task Force Division, where she worked for almost ten years; and

WHEREAS, Crystal Carbellos worked tirelessly to advocate for her clients, became the voice and a shield for her clients, and was a formidable trial attorney for her clients. Her dedication to ensuring equity and justice for her clients was steadfast and her compassion unquestionable; and

WHEREAS, Crystal Carbellos maintained relationships with her former clients, was a mentor to many other assistant public defenders, and was respected by her colleagues for her leadership, advocacy, and compassion; and

WHEREAS, Crystal Carbellos served her fellow assistant public defenders as the Treasurer for American Federation of State, County and Municipal Employees (AFSCME), Council 31, AFL-CIO, Local 3315 for almost eight years; and

WHEREAS, Crystal Carbellos was born on September 6, 1947 in Fort Dodge, Iowa to Richard F. Nekvinda and Olga M. Rubos. Crystal was an avid and loyal Minnesota Vikings and Prince fan; and

WHEREAS, Crystal Carbellos was a mother to four children: Nicole (Carley), Samuel, Reuben, and Adrienne; a grandmother to eight grandchildren: Jacquez, Samarah, Summer, Wynnston, Savannah, Ayden, Isabella, and Rubianna; and

WHEREAS, Crystal was loved and respected by her family, her clients, friends, and colleagues for her compassion, empathy, kindness, grace, strength, creativity, humor, positive spirit, loyalty, commitment to justice, and faith in humanity.

RECOGNIZING THE EAGLE STAFF AS THE FIRST FLAG OF THE AMERICAS

WHEREAS, the Eagle Staff, considered the first flag of the Americas, represents the stature and honor of a particular Native American tribe or tribes; it commonly looks like a shepherd's staff, wrapped in either otter skin or buffalo skin, and featuring eagle feathers; pre-dating colonization, the Eagle Staff was the indicator of a tribe's accomplishments in battle and the integrity and honor of its people; and

WHEREAS, today the Eagle Staff is used to represent tribal communities, Native American and First Nation organizations, or a member of an honor society or service veterans; and

WHEREAS, the Eagle Staff represents tribal sovereignty, unity, and tradition, and reflects the honor bestowed upon an individual, tribal organization, or tribal elder; the Eagle Staff is typically carried by

Native American veterans of the United States Armed Forces; Native Americans have served in greater numbers per capita than any other ethnicity across all branches of the military; and

WHEREAS, the Eagle is a proud legacy of the Native American people and is the embodiment of the warrior and of enduring fortitude, which together have enable the tribes to survive policies intended to extinguish their race and culture; and

WHEREAS, the Eagle Staff is adorned with eagle feathers symbolizing the remembrance of fallen warriors because eagles and eagle features are highly revered and federally protected, and only a few federal agencies and enrolled native people may carry them, the eagle feather is the highest award that can be given by a tribe to its people; and

WHEREAS, the Eagle Staff is recognized by all Native American tribes, First Nations, and other Native American organizations and the Eagle Staff is welcomed into all communities, including Native American and First Nation communities with a flag song or victory song and is always presented ahead of any other flag; and

WHEREAS, the Eagle Staff is formerly recognized by all branches of the Canadian Armed Forces and the Canadian Department of National Defense; and

WHEREAS, the Eagle Staff is recognized and honored by the National Congress of American Indians, the State of Illinois, the Illinois Secretary of State Veterans' Advisory Council, and the McCormick Foundation Veterans Program; and

WHEREAS, the Eagle Staff is honored at Chicago Blackhawks games during the playing of the National Anthem; and

WHEREAS, the Eagle Staff is recognized by the Trickster Art Gallery, a Native American art gallery and museum in Schaumburg.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioner recognizes the Eagle Staff as the first flag of the sovereign Native American tribal nations and the First Nations; and

BE IT FURTHER RESOLVED, that the Cook County Board of Commissioners renews its commitment to cooperate with tribes, inter-governmental tribes, and Native American organizations, including Native American veterans' organizations and the Trickster Art Gallery, to encourage programs promoting cultural education of the significance of the Eagle Staff; and

BE IT FURTHER RESOLVED, that the Cook County Board of Commissioners is committed to inclusiveness for all Native Americans, the traditions and symbolism of the Eagle Staff; and

BE IT FURTHER RESOLVED, that the Cook County Board of Commissioners encourages all Cook County departments to incorporate these principles into the policies and practices.

WHEREAS, Dr. Winfree would go on to be named vice president of community and economic development in 2007, and served in that capacity until she was selected as president in 2013; and

WHEREAS, on behalf of the college, Dr. Winfree has served in leadership positions with numerous organizations including the Illinois Council of Community College Administrators, The Chicago Southland Chamber of Commerce, The Chicago Southland Convention and Visitors Bureau, and has served as a member of The Chicago Southland Economic Development Committee; and

COMMEMORATING THE 20TH ANNIVERSARY OF DENIM DAY

WHEREAS, April is National Sexual Assault Awareness Month; and

WHEREAS, according to national statistics from the Centers for Disease Control and Prevention (CDC), 1 in 5 women and 1 in 71 men in the United States (U.S.) are survivors of sexual assault; and

WHEREAS, the Illinois Crisis Centers serves an average of 10,000 survivors of sexual violence each year; and

WHEREAS, a survey from the National Center for Injury Prevention and Control from the CDC reported that 43.6% of women in the United States experienced some form of contact sexual violence, and 23 million women in the United States are survivors of completed or attempted rape at some point in their lifetime; and

WHEREAS, according to the Department of Justice's Bureau of Justice Statistics National Crime Victimization Survey: only 230 of every 1,000 rapes are reported, only 46 of every 1,000 rapes lead to arrest, and only 5 of every 1,000 rapes lead to conviction in the United States; and

WHEREAS, for the past 20 years, Peace Over Violence, a sexual and domestic violence prevention center headquartered in Los Angeles, California, has hosted the Denim Day campaign on a Wednesday in April in honor of Sexual Assault Awareness Month; and

WHEREAS, the Denim Day story begins in Italy in 1992, when an 18-year old girl was raped by the 45-year old driving instructor who was taking her on her very first driving lesson. He took her to an isolated road, pulled her out of the car, removed her jeans and raped her; and

WHEREAS, after she reported the rape, the perpetrator was arrested, prosecuted, and convicted of rape and sentenced to jail; and

WHEREAS, years later, that conviction was overturned by the Italian Supreme Court using the "jeans alibi" - according to the justices, the woman was wearing tight jeans, therefore she must have helped the person who raped her remove her jeans, thereby implying consent; and

WHEREAS, the following day, the women in the Italian Parliament came to work wearing jeans in solidarity with the survivor; and

WHEREAS, the Denim Day campaign became official in the United States in 1999 where people wore denim in solidarity with women in the Italian Parliament; and

WHEREAS, since then, wearing jeans or other denim apparel on Denim Day has become a symbol of protest against erroneous and destructive manners about sexual harassment, abuse, assault and rape; and

WHEREAS, in this sexual violence prevention and education campaign, community members, elected officials, businesses and students are asked to make a social statement by wearing denim on this day as a visible protest against the misconceptions that surround sexual violence.

NOW, THEREFORE BE IT RESOLVED, that the Cook County Board of Commissioners recognizes Wednesday, April 24, 2019 as the 20th Annual Denim Day; and

WHEREAS, AAFS was established in 2001 by Itedal Shalabi and Nareman Taha and was registered with the State of Illinois in January 2001; and

WHEREAS, the philosophy of AAFS is to help participants find solutions and to build a culture of learning and sharing that empowers individuals, families, local leadership, and institutions, as well as to reduce the cultural, religious, and linguistic barriers that limit Arab Americans from accessing services and opportunities for personal growth; and

WHEREAS, in early 2001, they opened a one-room office at 64th and Pulaski in Chicago with just enough space for two desks and filing cabinets; They started showing up at every community gathering and government agency meeting they could find and went to mosques and churches and schools and hospitals, even sitting down with families in the parks and in their homes to listen to their concerns and learn of their needs, and during these meetings, they experienced the intense suffering and fear in many Arab and Muslim women and asked how AAFS might help; and

WHEREAS, Itedal and Nareman began helping women to complete immigration forms, finding domestic violence shelters for those abused, providing parents with translation services at school meetings, and advocating for services with government agencies, striving to provide services based on client eligibility and proper legal procedures; and

WHEREAS, their work conducting awareness programs for government officials and agencies, as well as other mainstream organizations to combat negative imagery and to help agency personnel understand, respect, and learn to work with the cultural and religious differences of Arabs and Muslims gained AAFS a reputation as a "bridge builder" between Arab and Muslim-Americans and mainstream society; and

WHEREAS, today, AAFS is headquartered in Worth, IL, in the 6th District, the heart of the Arab and MuslimAmerican community in the southwestern metropolitan Chicago area and since their founding, AAFS' programs and services have expanded dramatically to meet the needs of Arab and Muslim-Americans, as well as thousands of people from mainstream society residing within their service areas as AAFS does not discriminate in providing services on the basis of race, religion, gender, sexual orientation, age, national origin, or disability; and

WHEREAS, AAFS provides services to over 30 communities in the South Suburban Chicagoland area and in 2018 worked with 15,144 families and 59,285 individuals were served in various areas of their programs; and

WHEREAS, the agency reaches out to more than 160,000 Muslims and individuals of Arab descent, as well as mainstream audiences, living primarily in southwestern Cook County, northern Will County, and eastern DuPage County; and

WHEREAS, the population AAFS serves today is 92% Arab American, 3% Asian, 2% African American, 2% Caucasian (non-Arab), and 1% Hispanic; 60% are female, 85% are immigrants, 30% are youth under the age of eighteen, 10% are elderly age sixty-five or older, and 5% are people with disabilities; 75% percent

of AAFS' clients have identified themselves as Muslims, while 25% have stated they are Christians and AAFS estimates that 92% of their clients live below the federal poverty line; and

WHEREAS, AAFS staff and volunteers are culturally sensitive, most are Arabic speaking and skilled in meeting the special needs of the Arab-American community; languages include each of the various dialects found in the 22 Arab nations and is the only social service agency in the southwest suburbs that provide immigration or translation services to Arabic speaking immigrants and the only provider of domestic violence services for the Arab population in the Midwest; and

WHEREAS, the members of the Cook County Board of Commissioners are pleased to celebrate Arab American Heritage Month by highlighting the good work of AAFS.

WHEREAS, Dandria "Dani Jo" Williams is the director of A&R at Quiet Kingdom Recordings, an independent music label headquartered in Chicago overseeing the artist development and careers of numerous recording artists, while producing and writing songs for them as well.

HONORING GEORGE FREEMAN AND JAZZ APPRECIATION MONTH

WHEREAS, jazz guitarist George Freeman was born April 10, 1927 on Chicago's South Side and has been a lifelong resident of Cook County; and

WHEREAS, George's father was a police officer on the South Side of Chicago and worked at the station at 48th and Wabash where he met many jazz musicians, including Louis Armstrong, Earl Hines and more. He would bring the musicians home to the Freeman household for a meal and to spend time with his family; and

WHEREAS, growing up, as the youngest of Chicago's first family of jazz, the Freeman brothers, along with tenor sax master Von Freeman and mainstay Chicago drummer Eldridge 'Bruz' Freeman, George attended DuSable High School and studied music under the legendary music teacher and band leader, Captain Walter Dyett. Later on, George said "I still have the original piano that was in my home as a child. It moved everywhere we did"; and

WHEREAS, at 12 years old, George became a busboy at the Sherman Hotel on 39th Street and he would go downstairs to the ballroom and listen to the big bands. "It would bring tears to my eyes," said George. "The music from the Sherman Ballroom would be broadcast on radio and my mom had the radio on all the time. You could hear music from The Grand Terrace with big bands like, Count Basie, Duke Ellington, Tommy Dorsey and Anita O'Day and Gene Krupa," and

WHEREAS, in 1950, George recorded with bebop giant Charlie Parker, "In Chicago, Live at the Pershing Hotel." He soon became a sideman with tenor sax man Gene Ammons and went to New York where he played until he got homesick for Chicago and returned. During that time he recorded, "Lowe Groovin'" with Johnny Griffin which became the first hit single for Atlantic Records; and

WHEREAS, George recently said, "Jazz music still excites me. The creativity still excites me".

NOW THEREFORE BE IT RESOLVED that the President and the Cook County Board of Commissioners, on behalf of the residents of Cook County, honor George Freeman for his essential contribution to the rich musical Jazz culture and congratulate him on his 92nd birthday; and

BE IT FURTHER RESOLVED, that the County Board recognizes April as Jazz Appreciation Month.

WHEREAS, Almighty God in His infinite wisdom called Martha Ramos from our midst on February 20, 2019; and

WHEREAS, Martha, a Puerto Rican-American Chicago native, dedicated her life to helping others in any capacity she could, always striving to leave a positive impact on everybody with whom she worked. She was a strong, courageous, kind, and generous with her time, neighbor and friend to many; and

WHEREAS, Martha Ramos was the daughter of Daniel and Iris Ramos, sister to Analicia, Dulce, Mirca and Iris Ramos. Loving mother to Coraliris Echevarria, grandmother to Eliel and Leonel Soto, and lifetime companion of Rey Colón; and

WHEREAS, Martha helped her father purchase the Puerto Rican Parade Committee building, which was paid in full upon the completion of his term as President and ultimately, named after him. Martha became the Executive Director of the Puerto Rican Parade Committee and organized the Puerto Rican Pride Parade and festival which continues to be an annual City of Chicago celebration; earning her "Business Woman of the Year" award by the Puerto Rican Chamber of Commerce in 1989; and

WHEREAS, Martha graduated from DeVry Institute of Technology where she received her Bachelor's of Science degree in Accounting and was elected DeVry Accounting Society President in 1994; and

WHEREAS, Martha's many accomplishments in her long career in the private sector include: Budget Management for the YMCA of Metropolitan Chicago's Corporate Office, aiding 25 YMCA locations as Assistant to Director of Treasury, Program Services and Staff Development from 1991 to 1994; supervisor of the final bankruptcy reclamation process at Montgomery Ward's National Office from 1998 to 2000, where she managed \$1.3 billion in payables and \$60 million in receivable accounts while maintaining good relations with over 7,500 vendors at 300 locations; coordinator of Transit Advertising and manager of a \$30 million budget in 24 international markets as the National Business Operations Manager for Obie Media Incorporated from 2001 to 2003; among others; and

WHEREAS, Martha served as Region Manager Assistant at the Chicago Park District from 1994 to 1997 where she conducted regular site visits teaching 72 Park Supervisors and over 400 staff best practices in community outreach. She managed numerous projects and special events for the Region Manager, Finance Manager and 5 Area Managers. Martha was awarded 1997 Chicago Park District P.R.I.D.E. Employee of the Year; and

WHEREAS, Martha recruited corporate sponsors, community leaders and non-profit organizations to create the Boulevard Community Arts Network and produced the first Milwaukee Avenue Arts Festival from 2001 to 2006. It is a thriving annual event to this day; and

WHEREAS, after her father suffered a major stroke, Martha put aside her own career and ambitions to run his company "Ramos & Daughters Movers" named after his 5 daughters; and

WHEREAS, Martha served as Chief of Staff for 35th Ward Alderman Rey Colón from 2006 to 2015 providing outstanding city services. She loved turning complaints, problems and issues into solutions and often said it was the job she favored, mostly due to the high volume of very demanding constituents; and

WHEREAS, Martha was a crime fighter. In 2007 she received a Chicago City Council Bravery Recognition and 2007 Cook County Honorable Citizen Award for catching the Edgewater Slasher; and

WHEREAS, Martha created partnerships with city, state and federal government elected officials, businesses, schools, nonprofit organizations, chambers of commerce and other institutions to acquire resources to benefit her community. One of the many projects was the resurrection of the Logan Square's business district along Milwaukee Avenue; and

WHEREAS, until her untimely passing, Martha continued working as a public servant in the Chicago Public Schools, The Puerto Rican Arts Alliance, the service offices of Chicago Alderman Milly Santiago and, last, for Cook County Commissioner Luis Arroyo Jr; and

WHEREAS, Martha Ramos left this world a better place. The northwest side of Chicago has lost a neighbor, friend, tireless community worker, wonderful mother and grandmother to her family and an overall beautiful soul. She will be greatly missed.
