WHEREAS, during her life, Dorothy Gregory was known as a kind, tenderhearted, and giving individual who gave to the less fortunate. She opened her home to community residents that were displaced or who sought temporary housing. She also served food to the residents in need and volunteered at William H. Ryder Math and Science Specialty School; and

WHEREAS, Dorothy Gregory's faith was central to her life. She was called to the Oakdale Covenant Church and served under the leadership of Reverend Dr. Willie B. Jeminson. In 1970, Reverend Jeminson named her President of the Usher Board Committee where she faithfully served the congregation. She continued her spiritual service under the direction of Reverend Dr. D. Darrell Griffin and was loved by all in the church who met her; and

WHEREAS, Dorothy Gregory enjoyed spending quality time with her family. She is survived by her sons, George Kenneth (Linda), Ray Anthony (Vicki), three (3) grandchildren, one (1) great grandchild, and a host of nieces, nephews, and cousins.

WHEREAS, Timothy Noonan is a native of the North Beverly neighborhood of Chicago's South Side; and

WHEREAS, Timothy Noonan graduated from Marist High School in 1981 and attended Marquette University where he obtained a Bachelor of Science degree in Computer Science; and

WHEREAS, for the past 22 years, Timothy Noonan has worked for various corporations such as Exelon, Arthur Andersen, EMC Documentation, Hewlett Packard, Sierra Systems, EMC Kazeon-Electronic Discovery, and The Sedona Conference providing knowledge and expertise in developing enterprise-wide solutions addressing matters of compliance, discovery, strategic records management, and cyber security from mobile devices to the cloud; and

WHEREAS, since 2012, Timothy Noonan has served as the Director of Information Governance for Autotech Corporation. In this role, Timothy has led digital forensic investigations by case planning, acquisition, examination, data analysis, presentation and disposition; and

WHEREAS, during a walk with his children, in the Forest Preserves of Cook County, Timothy Noonan discovered the abandoned monument dedicated to the mothers of fallen World War I soldiers. Timothy became inspired to take action, and shortly thereafter, founded The Chicago Council of Gold Star Mothers (CCGSM), a nonprofit organization dedicated to the restoration and rebuilding of the memorial located in the Dan Ryan Woods; and

WHEREAS, Timothy Noonan hosted a community meeting at Ridge Park in May 2017 to explore ways for the monument to be restored. Based on this meeting and continuous advocacy efforts, the Forest Preserves of Cook County hosted a decommissioning ceremony at the memorial in November 2017; and

WHEREAS, under Timothy Noonan's leadership, CCGSM successfully restored the Gold Star Mothers monument. A rededication ceremony was hosted in November 2018, before Veteran's Day, and the 100-year anniversary of Armistice Day. During the rededication ceremony, Timothy Noonan and CCGSM were recognized for its efforts to restore the site; and

WHEREAS, the Beverly Area Planning Association (BAPA) named Timothy Noonan the grand marshal of the BAPA's Beverly/Morgan Park/Mt. Greenwood 2019 Memorial Day Parade. The honor of grand marshal was given to Timothy Noonan due to his tireless dedication in restoring the CCGSM in the Dan Ryan Woods.

CELEBRATING THE CAREER OF THE LEGENDARY HOUSE MUSIC DJ JESSE SAUNDERS

WHEREAS, Jesse Saunders was born on March 10, 1962 in Chicago, Illinois; and

WHEREAS, Jesse Saunders took an early liking to music and started to play the piano at 5 years old. He excelled academically with a musical gift and talent for making people dance. He was selected to perform and tour in the Chicago Children's Choir at 10 years old; and

WHEREAS, while attending Kenwood High School, Jesse Saunders would be mentored in the art of DJing by his older stepbrother, DJ Wayne Williams. In 1977, he would become a founding member of the Chosen Few DJs and began spinning at high school dances and house parties; and

WHEREAS, after graduating from Kenwood High School, Jesse Saunders enrolled at the University of Southern California studying Communications and Film. After his first year in college, Jesse Saunders returned back to Chicago to become a full-time house music DJ; and

WHEREAS, upon his return to Chicago, Jesse Saunders began his career DJing at Chicago nightclubs such as The Playground and DaVinci Manor. He would become part of two records which debuted house music on vinyl records. In 1983, he wrote and recorded the single "Fantasy" for Mitchell Records. Later that year, Jesse Saunders founded Jes Say Records, the world's 1st house music record label and released the single "On and On," in 1984; and

WHEREAS, Jesse Saunders, place in house music history, was further solidified by writing and producing one of the most covered and biggest-selling house records, "Love Can't Turn Around", which topped the charts in more than 20 countries; and

WHEREAS, in 1986, Jesse Saunders signed the first major label recording contract for a house music DJ with Geffen/Warren Bros. Records. During this 10-year tenure, he produced and remixed such records as De La Soul's "Me, Myself and I"; Paula Abdul's "Vibeology", and Simple Pleasure's chart-topping "Where Do We Go From Here." Jesse Saunders went on to work for a variety of labels including JIVE Records where he worked with top selling artists such as Mr. Lee and DJ Pierre; and

WHEREAS, Jesse Saunders capitalized on his success as a house music DJ and business owner to form the Just Say family of companies that specialized in productions in music, television, film, and even print. He has worked beside and influenced other DJs including Grammy Award winner Roger Sanchez, Marshall Jefferson, DJ Pierre, Farley "Jackmaster Funk" Williams, Steve "Silk" Hurley, and Frankie Knuckles; and

WHEREAS, Jesse Saunders continues to promote music through the Music and Arts Society, a non-profit dedicated to the preservation and education of house and electronic dance music. He has also spoken at conferences, colleges, and universities around the world spreading his musical expertise such as the Red Bull Academy, Amsterdam Dance Event, and Winter Music Conference; and

WHEREAS, Jesse Saunders contributions to house and electronic dance music have been recognized by proclamations from the Mayors of Chicago, Seattle, San Francisco, and Albuquerque.

WHEREAS, Domestic Violence Awareness Month is held throughout the month of October to raise awareness and unite, in solidarity and support, across the nation to end domestic violence; and

WHEREAS, Domestic Violence can happen to anyone at any point in a relationship, and happens in every community and affects people of all races, genders, and backgrounds; and

WHEREAS, one (1) in three (3) women will experience intimate partner violence, whether physical or emotional, in their lifetime, according to the World Health Organization; and

WHEREAS, more than half of women (69.5%) and men (53.6%) who have been physically or sexually abused or stalked by a dating partner, first experienced abuse between the ages of 11-24, according to the National Center on Domestic and Sexual Violence; and

WHEREAS, on average, three women are killed by a current or former intimate partner every day in the United States, according to the Bureau of Justice Statistics; and

WHEREAS, victims of domestic violence experience immediate and long-term negative outcomes, including detrimental effects on mental and physical health; and

WHEREAS, personal safety and economic security are often inextricably linked for victims of domestic violence, according to the National Network to End Domestic Violence; and

WHEREAS, victims of domestic violence may not leave because of financial needs, family pressures, believing children need a second parent, or the fear that abusers will follow through on threats to harm children or gain custody, according to the Journal of Social and Personal Relationships; and

WHEREAS, domestic violence is the third leading cause of homelessness among families in the United States, according to the American Civil Liberties Union Women's Rights Project; and

WHEREAS, significant numbers of women living in poverty are battered, and the violence they experience can make the climb out of poverty unattainable, according to the National Council of Juvenile and Family Court Judges; and

WHEREAS, millions of children are exposed to domestic violence each year; and

WHEREAS, children who observe parental conflict, hostility, and violent behavior are more likely to use abusive behaviors toward their significant others in both adolescence and adulthood, according to the National Council of Juvenile and Family Court Judges; and

WHEREAS, only 60 percent of domestic violence and intimate partner violence incidents are ever reported to the police, according to National Center on Domestic and Sexual Violence; and

WHEREAS, lesbian, gay, bisexual, transgender and questioning (LGBTQ) domestic violence victims face barriers unique to their status, such as lack of access to domestic violence shelters, according to the National Coalition of Anti-Violence Programs; and

WHEREAS, African American females experience intimate partner violence at a rate 35% higher than that of white females, and about 2.5 times the rate of women of other races and are less likely than white women to use social services, battered women's programs, or go to the hospital because of domestic violence, according to the Bureau of Justice Statistics and the Feminist Majority Foundation; and

WHEREAS, 63% of victimized Latinas experience multiple acts of victimization, Latino victims are less likely to tell health care workers, and Latino victims report seeking local shelters less than women from other ethnic/racial groups due to language barriers and fear of immigration enforcement; and

WHEREAS, victims of domestic violence who worked with advocates experienced less violence over time, reported higher quality of life and social support, and had less difficulty obtaining community resources over time, according to the National Resource Center on Domestic Violence; and

WHEREAS, staff and volunteers of domestic violence shelters and community providers serve thousands of adults and children throughout Cook County; and

WHEREAS, crisis hotlines serving domestic violence victims operate 24 hours per day, 365 days per year, and offer important crisis intervention services, support services, information, and referrals for victims; and

WHEREAS, law enforcement officers and first responders put their lives at risk each day by responding to incidents of domestic violence, which can be among the most volatile and deadly disturbance calls.

THE HONORABLE TONI PRECKWINKLE, PRESIDENT OF THE COOK COUNTY BOARD OF COMMISSIONERS

CELEBRATING THE LIFE AND ACCOMPLISHMENTS OF THE LATE UNITED STATES REPRESENTATIVE ELIJAH EUGENE CUMMINGS

WHEREAS, Elijah Eugene Cummings was born on January 18, 1951, in Baltimore, the son of sharecroppers Ruth Elma (née Cochran) and Robert Cummings, and third of seven (7) children; and

WHEREAS, Elijah Cummings, when he was 11 years old, showed an early sense of social justice when he was among a group of friends who worked to integrate a segregated swimming pool in South Baltimore; and

WHEREAS, Elijah Cummings graduated with honors from the Baltimore City College High School in 1969, then attended Howard University in Washington, D.C., where he served in student government as sophomore class president, student government treasurer and later student government president; and

WHEREAS, Elijah Cummings became a member of the Phi Beta Kappa Society and graduated in 1973 with a Bachelor's Degree in Political Science; and

WHEREAS, Elijah Cummings graduated in 1976 from the University of Maryland School of Law, receiving his Juris Doctor degree, and was admitted to the Maryland State Bar Association later that year; and

WHEREAS, Elijah Cummings practiced law for 19 years before first being elected to the United States House of Representatives in 1996; and

WHEREAS, Elijah Cummings received 12 honorary doctoral degrees from universities across the United States, most recently an honorary doctorate of public service from the University of Maryland, College Park, in 2017; and

WHEREAS, as a member of the United States House of Representatives, Elijah Cummings rose through the ranks of the Democratic Party caucus to positions of leadership; and

WHEREAS, Elijah Cummings was widely praised following the 2008 congressional hearings on steroids. While investigating the use of steroids in sports, the panel called numerous baseball players to testify, including former single season home run record holder Mark McGwire. After McGwire answered many questions in a vague fashion, Cummings demanded to know if he was "taking the Fifth." McGwire responded by saying, "I am here to talk about the future, not about the past." The exchange came to epitomize the entire inquiry and Cummings was hailed for his direct and forthright questioning; and

WHEREAS, in 2010, Elijah Cummings was elected by his caucus as the ranking Democratic member, and later chair, of the powerful House Committee on Oversight and Government Reform because of his proven aggressive legislative and debating skills, a position in which he was widely respected and which he held until his untimely death; and

WHEREAS, Elijah Cummings was a member of the Congressional Progressive Caucus and served as chairman of the Congressional Black Caucus during the 108th United States Congress; and

WHEREAS, during his illustrious career in Congress, Elijah Cummings helped author and supported numerous pieces of legislation, including the Presidential and Federal Records Act Amendments of 2014, a bipartisan bill signed into law by then-President Barack Obama in December 2014; and the All Circuit Review Extension Act, a bill that "allows whistleblowers to file appeals where they live rather than being limited to the Federal Circuit Court of Appeals"; and

WHEREAS, Elijah Cummings was re-elected to the United States House, 11 more times, never dropping below 69 percent of the vote;

WHEREAS, throughout his career, Elijah Cummings remained dedicated to his core principles of racial and social justice, equity and equality; and

WHEREAS, Elijah Cummings lived in the Madison Park community of his beloved Baltimore and was an active member for 40 years of the New Psalmist Baptist Church; and

WHEREAS, following his death on October 17, 2019, Elijah Eugene Cummings was remembered across the political spectrum as a giant among his congressional peers and for his steadfast resolve and principled stands on politically charged issues.

NOW, THEREFORE, BE IT RESOLVED, that we, the President and Members of the Cook County Board of Commissioners, assembled this 23 day of October 2019, do hereby celebrate the life and achievements, as well as mourn the death of Congressman Elijah Eugene Cummings; and

BE IT FURTHER RESOLVED that a suitable copy of this Resolution be sent to the family and many friends of Elijah Eugene Cummings as a token of our esteem and good wishes.
