# HONORING THE EFFORTS OF TIMOTHY NOONAN TO RESTORE THE MONUMENT DEDICATED TO THE MOTHERS OF FALLEN SOLIDERS IN WORLD WAR I

WHEREAS, Timothy Noonan is a native of the North Beverly neighborhood of Chicago's South Side; and

WHEREAS, Timothy Noonan graduated from Marist High School in 1981 and attended Marquette University where he obtained a Bachelor of Science degree in Computer Science; and

WHEREAS, for the past 22 years, Timothy Noonan has worked for various corporations such as Exelon, Arthur Andersen, EMC Documentation, Hewlett Packard, Sierra Systems, EMC Kazeon-Electronic Discovery, and The Sedona Conference providing knowledge and expertise in developing enterprise-wide solutions addressing matters of compliance, discovery, strategic records management, and cyber security from mobile devices to the cloud; and

WHEREAS, since 2012, Timothy Noonan has served as the Director of Information Governance for Autotech Corporation. In this role, Timothy has led digital forensic investigations by case planning, acquisition, examination, data analysis, presentation and disposition; and

WHEREAS, during a walk with his children, in the Forest Preserves of Cook County, Timothy Noonan discovered the abandoned monument dedicated to the mothers of fallen World War I soldiers. Timothy became inspired to take action, and shortly thereafter, founded The Chicago Council of Gold Star Mothers (CCGSM), a nonprofit organization dedicated to the restoration and rebuilding of the memorial located in the Dan Ryan Woods; and

WHEREAS, Timothy Noonan hosted a community meeting at Ridge Park in May 2017 to explore ways for the monument to be restored. Based on this meeting and continuous advocacy efforts, the Forest Preserves of Cook County hosted a decommissioning ceremony at the memorial in November 2017; and

WHEREAS, under Timothy Noonan's leadership, CCGSM successfully restored the Gold Star Mothers monument. A rededication ceremony was hosted in November 2018, before Veteran's Day, and the 100year anniversary of Armistice Day. During the rededication ceremony, Timothy Noonan and CCGSM were recognized for its efforts to restore the site; and

WHEREAS, the Beverly Area Planning Association (BAPA) named Timothy Noonan the grand marshal of the BAPA's Beverly/Morgan Park/Mt. Greenwood 2019 Memorial Day Parade. The honor of grand marshal was given to Timothy Noonan due to his tireless dedication in restoring the CCGSM in the Dan Ryan Woods.

# CONGRATULATING CHICAGO COMMUNITY AND WORKERS' RIGHTS (CCWR) ON ITS 10TH ANNIVERSARY

**WHEREAS,** Chicago Community and Workers' Rights (CCWR) was founded in June 2009 by a group of Latinx immigrant workers who saw a need for an organization dedicated to empowering workers to defend their rights; and

WHEREAS, CCWR is a worker-led organization that builds leadership and develops organizing tools and collective strategies against labor and immigrant rights abuses, towards just living conditions, shifting the balance of power to the workers; and

**WHEREAS,** CCWR works mainly with low-wage, Latinx immigrant workers, regardless of immigration status- over 90% are people with low income, and over half are women; and

**WHEREAS,** immigrant workers are 1.5 times more likely to experience minimum wage violations and face dangerous working conditions, making up 54% of the foreign-born population who die of work-related injuries, and therefore CCWR fights and advocates for their rights; and

**WHEREAS,** as only about fifteen percent of workers in Illinois are unionized, immigrant workers are vulnerable to threats from employers such as contacting immigration authorities on their statuses, which is why CCWR assists immigrant workers in overcoming such barriers and organizes them to advocate for their workplace rights; and

WHEREAS, with CCWR's support, workers have recovered stolen wages, organized for better working conditions and defended their jobs. Their work has led to changes at the city, county, and state level to address issues of exploitation and push for the collective self-determination of workers; and

**WHEREAS,** in 2014, because of cases brought to the attention of the Illinois Department of Labor by CCWR, the implementation of three amendments to labor laws went into effect to make sure landscaping companies, and similarly structured companies, do not violate workers' rights; and

WHEREAS, in 2015, after years of organizing and advocacy together with Chicago street vendors, the City of Chicago approved a City ordinance in 2015 that allows pushcart street vendors to sell their prepared products on the street; and

WHEREAS, CCWR also works toward promoting laws and policies that create alternatives to provide people with more equitable economic opportunities, and has focused on supporting and establishing a worker cooperative ecosystem as a form of economic justice for communities of color that face poverty, marginalization and that have no documents; and

WHEREAS, CCWR is a founding member of the Illinois Workers Cooperative Alliance (IWCA), working towards creating financial and other resources for worker cooperatives at the city/county/state levels, and in collaboration with other organizations formed the Illinois Coalition for Cooperative Advancement (ICCA) with the main purpose to pass the worker cooperative association Act at the state level; in August 2019 the Limited Worker Cooperative Association Act was signed into law; and

WHEREAS, CCWR has been very active working with other coalitions to improve the lives of our community members and have been founding member of Raise the Floor Coalition, Organized Communities Against Deportation (OCAD), Chicago Immigration Policy Working Group, Resist, Reimagine Rebuild Coalition, and the Chicago Gang Database Coalition; and

WHEREAS, CCWR has helped protect the worker rights of immigrant communities and has been powerful advocate for all social justice issues.

NOW, THEREFORE, BE IT RESOLVED, the Cook County Board President and the Cook County Board of Commissioners do hereby congratulate the staff, volunteers, and supporters of Chicago Community and Workers' Rights on their 10th Anniversary; and

BE IT FURTHER RESOLVED, that this text be spread upon the proceedings of this Honorable Body and that a suitable copy of this resolution be presented to Chicago Community and Workers' Rights in honor of its outstanding achievements.

**WHEREAS,** Almighty God in His infinite wisdom has called Fidencio Sánchez from our midst on November 6, 2019 at the age of 92; and

WHEREAS, Mr. Sánchez was born in Morales, México on November 16, 1926; and

**WHEREAS,** Mr. Sánchez migrated to Chicago in 1990 and became a longtime resident of the Little Village neighborhood on Chicago's Southwest side; and

**WHEREAS,** Mr. Sánchez was known to be a hardworking provider for his family. He made his living selling popsicles - known in Spanish as *paletas* - for more than two (2) decades; and

WHEREAS, Mr. Sánchez spent eight (8) hours a day, six (6) days a week push his cart up and down major avenues and side streets in Little Village during the summer months to earn \$50.00 to \$60.00 a day; and

WHEREAS, he also spent the winter months selling candies and churros; and

WHEREAS, Mr. Sánchez build a reputation of being an all-around good person who cared deeply about his community; and

**WHEREAS,** in 2016, a Little Village native, Joel Cervantes Macias, was visiting his old neighborhood when he saw Mr. Sánchez struggling to push his cart; and

WHEREAS, Mr. Macias snapped a photo of Mr. Sánchez and posted it to social media outlets, instantly drawing sympathy from thousands of Mr. Sánchez's former customers who started a GoFundMe campaign; and

**WHEREAS,** the viral crowdfunding campaign, eventually raised nearly \$400,000.00 from more than 17,000 donors from about 60 countries that allowed Mr. Sánchez to retire and spend his twilight years in peace; and

**WHEREAS,** Mr. Sánchez is survived by his wife and best friend Eladia Sánchez, his children, grandchildren, and leaves behind a legacy of perseverance and generosity.

**WHEREAS,** in addition to serving the children, LAMP provides workshops and support groups for the parents and caregivers. These groups are designed to empower parents to enhance their ability to ensure their children are successful in school and grow up to live successful lives; and

HONORING THE DISTINGUISHED MEN OF OMEGA PSI PHI FRATERNITY, INC. 108TH FOUNDER'S DAY CELEBRATION

WHEREAS, on the evening of November 17, 1911, Edgar Amos Love, Oscar James Cooper and Frank Coleman. Joining them was their faculty adviser, Ernest Everett Just; founded Omega Psi Phi Fraternity inside the Science Building (later renamed Thirkield Hall) at Howard University located in Washington, D.C.; and

WHEREAS, from the initials of the Greek phrase meaning, "friendship is essential to the soul". Omega Psi Phi derived its name. The founders selected this as the motto; and

WHEREAS, the Cardinal Principles of Omega Psi Phi are Manhood, Scholarship, Perseverance, and Uplift; and

WHEREAS, Omega Psi Phi Fraternity, Inc. is the first international fraternal organization founded on the campus of a historically black college; and

WHEREAS, notable members include Michael Jordan, Langston Hughes, Percy Julian, Tom Joyner, L Douglas Wilder, and Cook County's favorite Omega's the late Robert B. Steele, Dr. Dennis Deer and John Roberson; and
