    - Round 1 expended and committed funding is \$1,588,217 to date
    - The remaining Round 2 funds of \$334,667 will be awarded dependent on the actions approved by the Cook County Complete Count Census Commission to address remaining HTC gaps.
  - Project Updates

      - Distributed 17 district plans to the Commissioners and their staffs
      - Scheduling one on one implementation sessions with each commissioner
    - Census Champions
      - Recruited 170 champions to date
      - Created a recruitment flyer and a census engagement toolkit with flyers, FAQs and talking points
    - Advertising, press and social media
      - Developed media buy plan
      - Begin social media paid campaign in January and radio, print and billboard campaign in February – May
    - Grantee Management
      - Approved 69 agencies for funding
      - Distributed project planning documents to grantees for completion
      - Scheduled 7 orientation training sessions for current grantees
      - Created reporting and monitoring mechanism
