 - 146 applicants applied (6 were duplicates or applicants awarded in Round 1)
 - 15 applicants recommended for award
 - Recommended funding amount: \$334,600
 - Total Funding
 - Total requested funding: \$4,950,397
 - Total applications received and reviewed: 225
 - Total agencies recommended for funding: 84
 - Total anticipated award: \$1,922,81
 - Hosted grantee application webinar
 - Attended community events to promote round 2 application

 - Created and distributed the 1st edition of the Cook County Census 2020 Quarterly Report
 - Began engagement and outreach efforts with Count Commission Committee members
 - United Way will include Census 2020 article in the UW Newsletter this month that will go out to over 100K donors
 - Census Champions
 - Over 230 Census Champions have been recruited
 - Created a recruitment flyer, digital toolkit, and map of Census outreach events to encourage Census Champion engagement
 - 1st edition of the Census Champions monthly newsletter was distributed in January
 - Media
- Created content for social media posts for the month of February
- Vocalo President Preckwinkle interview at Winter Block Party
- A detail medial buy plan and roadmap has been created.

- Shared social media posts with round 1 grantees to support and encourage upcoming outreach activities

 - Social Media Ads are being placed on identified social media (SM) sites such as special interest and ethnic websites, podcast/internet radio sites, Facebook, Instagram, Snap Chat and Twitter
 - Non-paid social media are being placed on identified social media (SM) sites that have demonstrated appeal to HTC populations
 - SnapChat geofilters have been created for major events such as the Chicago Auto show and NBA Allstars weekend
