causing injury to the Petitioner's back and right shoulder.

13 WC 15461 Petitioner was working in triage when she hit the left side of her

body on the edge of a portable interpreter machine.

Petitioner was hit by a portable ultrasound machine being pushed 16 WC 01679

by an ED resident, injuring her right foot and right hip.

Petitioner was backing away from an irate patient when her right 16 WC 28930

foot was caught on the bottom of a cart causing pain in her groin,

right foot and right hip.

14 WC 002563 Petitioner sustained a workplace injury and injuries to her left

shoulder and cervical spine.

10 WC 05129 Petitioner injured his back when he was driving a cart that hit a

depression.
