## 3. Approval of the Minutes

A motion to approve the October 17, 2019 meeting minutes was made by Commissioner Males and seconded by Commissioner Yonan. The minutes were approved through a unanimous voice-vote of the Commission.

# 4. Presentation on the History of the Commission and the 2019 Annual Report

- d. Commissioner Raymer, Chair of Financial Capital reported that her committee is exploring a marketing plan to further publicize the Lincoln Highway Logistics Corridor and any other opportunities or benefits for investors looking to develop in the south suburbs.
- e. Commissioner Cooley stated his committee's interest in recession resiliency planning, utilizing County procurement to build equity, and furthering the employment rubric developed last year.
- f. Commissioner Malone presented a toolkit developed in the meeting of the Intellectual Capital Committee which evaluated which Social Innovation presenters of the past three years should be invited for follow-up and which presenters' projects should be further pursued for project and legislative development by committees of the Commission.
