WHEREAS, CP Crawford was born August 25, 1905 in Jackson, Mississippi to John and Mattie Crawford; and

WHEREAS, CP Crawford was the youngest of five (5) siblings including three (3) brothers and two (2) sisters. At an early age, his mother passed away, and he was subsequently raised by aunts and uncles; and

WHEREAS, CP Crawford was not allowed to attend school that led him to start working in the fields picking cotton, ploughing the fields of corn and manning the gardens; and

WHEREAS, CP Crawford applied his early work experience and went on to a career at Southland Oil Refinery. He would eventually move to Chicago, Illinois in 1949 to work at Illinois Central Railroad; and

WHEREAS, throughout his lifetime, CP Crawford was known as a caring and charismatic person who was well respected by his peers. He enjoyed to fish, smoke cigars, and play cards; and

WHEREAS, CP Crawford's most significant accomplishment was the special relationship that he held with his four (4) stepchildren, Shawn (Yolanda), Martez, Paige, and Curtis and his grandchildren; and

WHEREAS, in November 2015, CP Crawford was awarded an honorary high school diploma from Thornton Fractional South High School in Lansing, Illinois. This honor was in recognition of his love of education and the community; and

WHEREAS, since 2012, CP Crawford lived in Lansing, Illinois at the Tri-State Nursing Rehabilitation Center. The Village of Lansing and Mayor Patty Eidam provided CP Crawford with a recognition as being the oldest living resident in the community; and

WHEREAS, the Chicago White Sox honored CP Crawford at a game on September 12, 2019 for his service, contributions and longevity in the Greater Chicago area; and

WHEREAS, prior to his passing, CP Crawford was one of the oldest known living men in the United States.

HONORING ALICE ELIZABETH DANDRIDGE-TURNER

WHEREAS, Alice Elizabeth Dandridge-Turner was born to Berry and Sarah Dandridge on December 25, 1919 in Memphis, Tennessee. She celebrated her 100th birthday on Christmas Day 2019; and

WHEREAS, Alice received her early education at home from her mother and father, and her religious training from her aunt, Ms. Hattie Bradley, at New Sardis Missionary Baptist Church. She attended elementary school at McKinney School where her teacher Nellie Roberts soon recognized her special talents. Both Ms. Bradley and Ms. Roberts placed her in leadership positions in school to help her understand her potential; and

WHEREAS, Alice subsequently attended LeMoyne College, now LeMoyne-Owen College, in Memphis Tennessee, Lane College in Jackson, Tennessee and Wilberforce University in Dayton, Ohio where she graduated Cum Laude. She later attended Chicago Teacher's College in Chicago, where she worked toward a master's degree in Education; and

WHEREAS, as a young person, Alice participated in Sunday School, Baptist Young People's Union, Sunshine Band, and the Children's Choir at New Sardis Missionary Baptist. Church. As she matured, she accepted the Lord Jesus Christ and joined the church in the days when everyone had to kneel at the "Mourner's Bench" and confess their sins in order to accept the Lord as their savior. She was then baptized in a gravel pit filled with rainwater on the side of the road because their church had been burned to the ground. It was reported that the church was burned because the leaders couldn't raise enough money to pay the note on the church. Eventually, her father who was a deacon and others raised enough money to build another church; and

WHEREAS, Alice comes from a long line of strong and generous women. Her mother Sarah Dandridge lived to be 101 years old. Her father's mother Vinnie Dandridge lived to 105. Her mother served on the Mother's Board of New Sardis Missionary Baptist Church where she worked with the children in the church instilling in Alice a love of children and the desire to better their lives through education. She credits her mother with teaching her how to serve others; and

WHEREAS, Alice moved to Chicago and married Reverend Clifton H. Turner, Sr. Together they raised three (3) children: Clifton, Jr. (now deceased), Deborah A. Turner, and Móna S. Turner. Alice taught for 43 years, more than half of those at Delano Elementary School, located in the school now known as Genevieve Melody Public School on Chicago's West side. She retired in 1993; and

WHEREAS, Alice lived in Chicago on the West Side during the riots that followed Dr. Martin Luther King, Jr.'s assassination. She remembers a long, scary night and driving around the city the next day, seeing much destruction and smelling the smoke, a painful reminder of how far she had come, but not yet far enough; and

WHEREAS, Alice is a published poet. She loves to write and sponsored an annual Essay Writing Contests at Delano Elementary School where she taught. This contest was recognized by the *Chicago Defender Newspaper*, Chicago's first Black newspaper. They noted that Alice was an educator who motivated children to write and to use their creativity constructively while rewarding them for their efforts; and

WHEREAS, Alice has lived a life of kindness and grace. She currently belongs to Springfield Baptist Church in Evanston, Illinois where she followed her mother's footsteps and joined the Mother's Board, eventually becoming President of the board. She believes strongly in the importance of religious training and worked many summers in the church's Vacation Bible School. She is an active member of the Missionary Society and continues to visit nursing homes, feed the hungry, and clothe those in need; and **WHEREAS**, Alice continues to be active in the Foster Senior Club where she is a "Golden Girl." The Golden Girls meet weekly for good clean Christian fun. There are lots of laughs and a little BINGO. There are field trips and other activities. Every year she participates in the large Fundraiser Fashion show; and

WHEREAS, Alice continues to thank and praise the Lord for the love he has shown her, allowing her to live 100 years and to accomplish all the things she has done. He has allowed her to experience history from being with her grandmother who shared her experiences as a slave to seeing Barack Obama elected as the first Black President of the United States. Her faith in God remains strong and she encourages young people to follow Jesus as their leader. Everything will work out right because he will always be with them.

WHEREAS, the League was a political experiment designed to help 20 million women carry out their new responsibilities as voters by educating them about issues; and

WHEREAS, from the beginning the league determined that it would be nonpartisan, neither supporting nor opposing any political party or individual candidate; and

WHEREAS, the League continues today as a nonpartisan political organization that encourages informed and active participation in government, works to increase understanding of major public policy issue, and influences public policy through education and advocacy; and

WHEREAS, today the League is composed of member in over 700 local, county and states leagues, in all 50 states plus the District of Columbia, the Virgin Islands, and Hong Kong; and

WHEREAS, among those local leagues in Illinois are 13 leagues whose over 1800 members are also members of the League of Women Voters of Cook County, and inter-League organization that focuses on the county-wide governments with the County of Cook; and

WHEREAS, members of the League first study and then take action on a broad rand of issues after reaching consensus on positions; and

WHEREAS, Leagues at all levels, among the other activities, register voters, educate voters by holding candidate forums and publishing voter guides, publish public policy research, and hold meeting on key issues; and

WHEREAS, the League is a civic organization that has fought since 1920 to improve government and engage everyone in the decision that impact their lives; and

WHEREAS, the League will celebrate its 100th Anniversary on February 14, 2020.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners declares February 14, 2020 as a day to celebrate the League of Women voters and its vision of democracy where every person has the desire, the right, the knowledge and the confidence to participate.

HONORING FOUR HEROIC UNITED STATES ARMY CHAPLAINS

WHEREAS, February 2, 2020 marks the 77th anniversary of the sinking of the United States (U.S.) troop ship, SS Dorchester; and

WHEREAS, on that day in 1943 while transporting soldiers overseas over the North Atlantic, the SS Dorchester was struck by a torpedo which knocked out the ship's electrical system, leaving the ship dark which created panic among the men aboard, many of them trapped below deck. It is what happened during these crucial 20 minutes before the ship sank, the reason we remember this day; and

WHEREAS, in a final act of valor and courage, four U.S. Army first lieutenant chaplains Methodist Reverend George L. Fox, Roman Catholic Priest John P. Washington, Jewish Rabbi Alexander D. Goode, Dutch Reformed faiths Reverend Clark V. Poling calmed the men and organized an orderly evacuation of the ship; and

WHEREAS, as they helped guide wounded men to safety into lifeboats and as life jackets were passed out to the men, the supply ran out. The chaplains removed their own life jackets and gave them to others. They then linked arms while praying and went down with the ship as it sank into the cold waters of the North Atlantic; and

WHEREAS, every year hence, citizens across our country have remembered the courage and extraordinary display of bravery from these four heroic men of faith; and

WHEREAS, this year's memorial program is hosted by the Military Order of the Purple Heart and is sponsored annually by the Combined Veterans Association of Illinois.

NOW, THEREFORE, BE IT RESOLVED, that I, Toni Preckwinkle, President of the Cook County Board of Commissioners, and the Cook County Board of Commissioners does hereby designate Sunday, February 2, 2020, Four Chaplains Sunday in Cook County, in honor to preserve the memory of these individuals who demonstrated the ultimate supreme sacrifice at sea.

HONORING EQUAL HOPE AND RECOGNIZING JANUARY AS CERVICAL HEALTH AWARENESS MONTH IN COOK COUNTY

WHEREAS, the United States Congress designated January as Cervical Health Awareness Month; and

WHEREAS, cervical cancer is still the second most common type of cancer for women worldwide and nearly 13,000 women in the United States are diagnosed with cervical cancer each year with more than 4,000 women dying as a result of this diagnosis, but the disease is preventable with vaccination and appropriate screening such as pap and human papillomavirus (HPV) tests; and

WHEREAS, the occurrence of cervical cancer in Chicago is 39% higher than the national average and the death rate is 60% higher, according to data from the National Cancer Institute; and

WHEREAS, HPV is the #1 cause of cervical cancer; however, HPV vaccines can help prevent infection from both high-risk HPV types that can lead to cervical cancer and low risk types that cause genital warts; and

WHEREAS, the Center for Disease Control (CDC) recommends all boys and girls get the HPV vaccine at age 11 or 12, but vaccination is available through age 26; and

WHEREAS, the vaccine produces a stronger immune response when taken during the preteen years, and it is for this reason that up until age 14, only two (2) doses of the vaccine are required; and

WHEREAS, young women and men can get the vaccine up to age 26, but for those 15 and older, a full three (3) dose series is needed; and

WHEREAS, it's important to recognize outstanding work being done here in Illinois and Cook County by our community partners such as Equal Hope; and

WHEREAS, Equal Hope is a not-for-profit organization originally set up in 2008 as the Metropolitan Chicago Breast Cancer Task Force after the publication of disturbing research that showed that Chicago had large and growing racial disparities in breast cancer mortality; and

WHEREAS, women of color are disproportionally affected with Black and Latina women nearly three times more likely to die of cervical cancer than white women in Chicago, and drastic variations exist among neighborhoods; women living in Washington Park, for example, are 85 times more likely to die of cervical cancer than women living in adjacent Hyde Park; and

WHEREAS, Equal Hope's mission is to save women's lives by eliminating health disparities in Illinois, originally through the lens of breast cancer and now expanded to cervical cancer and other women's cancers; addressing women's health holistically by helping women establish medical homes with the goal of eliminating inequities in prevention, screening, diagnosis, treatment, and survivorship for all women; and

WHEREAS, this Honorable Body wishes to promote and raise awareness of National Cervical Health Awareness Month in Cook County and to recognize the good work of Equal Hope in combatting this "silent killer" of women.

NOW, THEREFORE, BE IT RESOLVED, that the President and the Cook County Board of Commissioners, on behalf of the more than 5.2 million residents of Cook County, do hereby take this opportunity to acknowledge National Cervical Health Awareness Month; and

BE IT FURTHER RESOLVED, that in conjunction with National Cervical Health Awareness Month, that the month of January be hereby declared Cervical Health Awareness Month in the County of Cook; and

BE IT FURTHER RESOLVED, that this text be spread upon the official proceedings of this Honorable Body and that a suitable copy be presented to Equal Hope in recognition of National Cervical Health Awareness Month.

within Cook County, and nearly 300,000 members in more than 55 nations and all 50 states including the District of Columbia, the United States Virgin Islands, the Bahamas, Germany, Liberia, South Korea, Japan, Canada, South Africa and the Middle East; and

WHEREAS, Alpha Kappa Alpha's mission is to cultivate and encourage high scholastic and ethical standards, to promote unity and friendship among college women, to study and help alleviate problems concerning girls and women in order to improve their social stature, to maintain a progressive interest in college life, and embodied in their credo to be of "Service to All Mankind"; and

WHEREAS, for more than a century, the AKA Sisterhood has been an indomitable force for good in their communities, state, nation, and the world; and

WHEREAS, Alpha Kappa Alpha has maintained its focus in two (2) key arenas: the lifelong personal and professional development of each of its members; and galvanizing its membership into an organization of respected power and influence, consistently at the forefront of effective advocacy and social change that results in equality and equity for all citizens of the world; and

WHEREAS, the Alpha Kappa Alpha Sorority, Inc. chapters located in Cook County include: Beta (Chicago), Theta Omega (Chicago), Delta Omicron (Chicago), Theta Rho Omega (Markham), Delta Chi Omega (Evanston), Lambda Alpha Omega (Westchester), Lambda Mu Omega (Chicago), Lambda Tau Omega (Matteson), Xi Nu Omega (Chicago), Xi Kappa (Chicago), Omicron Alpha (River Forest), Tau Gamma Omega (Chicago), Pi Nu (Chicago), Phi Epsilon Omega (Harvey), Phi Kappa Omega (Oak Lawn), Chi Alpha Omega (Schaumburg), Chi Omega Omega (Chicago), and Tau Mu (Chicago); and

WHEREAS, the members of the Cook County Board of Commissioners are pleased to congratulate the members of the Cook County Chapters of Alpha Kappa Alpha, Inc. on the occasion of the sorority's 112th anniversary.

WHEREAS, Zeta Phi Beta Sorority, Incorporated is a Black Greek Letter Organization founded on January 16, 1920 on the campus of Howard University in Washington, D.C. by Arizona Cleaver Stemons, Pearl Anna Neal, Myrtle Tyler Faithful, Viola Tyler Goings and Fannie Pettie Watts. Zeta Phi Beta Sorority, Inc. was founded on the principles of Scholarship, Service, Sisterly Love and Finer Womanhood; and

WHEREAS, Zeta Phi Beta Sorority, Inc. is the only Black Greek Letter Organization constitutionally bound with another Black Greek Letter Organization, Phi Beta Sigma Fraternity, Incorporated, founded on January 9, 1914 on the campus of Howard University. Zeta Phi Beta was incorporated in the State of Illinois in 1939. Currently, the Sisterhood of Zeta Phi Beta Sorority, Inc. has over 100,000 members around the world; and

WHEREAS, Zeta Phi Beta Sorority, Inc. is currently led by the Sorority's 25th International President, Valerie Hollingsworth-Baker; and

WHEREAS, Zeta Phi Beta Sorority, Inc. has long-standing awareness partnerships and assists tirelessly year-round to raise funds on behalf National Organizations such as the March of Dimes and the American Cancer Society and St. Jude Children's Research Hospital; and

WHEREAS, Zeta Phi Beta Sorority, Inc. is one (1) of nine (9) Black Greek Letter Organizations in existence known as 'The Divine Nine'. The Divine Nine Organizations are listed as follows: Alpha Phi Alpha Fraternity, Incorporated (founded December 4, 1906); Alpha Kappa Alpha Sorority, Incorporated (founded January 15, 1908); Kappa Alpha Psi Fraternity, Incorporated (founded January 5, 1911); Omega Psi Phi Fraternity, Incorporated (founded November 17, 1911); Delta Sigma Theta Sorority, Incorporated

(founded January 13, 1913); Phi Beta Sigma Fraternity, Incorporated (founded January 9, 1914), Zeta Phi Beta Sorority, Incorporated (founded January 16, 1920); Sigma Gamma Rho Sorority, Incorporated (founded November 12, 1922) and Iota Phi Theta Fraternity, Incorporated (founded September 19, 1963); and

WHEREAS, Zeta Phi Beta Sorority, Inc. mentors young women from ages 4 - 18 through the Zeta Youth Auxiliaries known as the Pearlettes, Amicettes and Archonettes. Zeta Phi Beta Sorority, Inc. also sponsors an adult auxiliary formed in 1947 entitled The Amicae, making Zeta Phi Beta the first Sorority in the National Pan Hellenic Council to organize an auxiliary. The Amicae auxiliary consists of non-degreed women who have an opportunity to serve alongside Zeta Phi Beta with the same ideals and principles that the Sorority was founded upon; and

WHEREAS, in Cook County, there are three (3) undergraduate chapters of Zeta Phi Beta Sorority, Inc.: Alpha Alpha Chicago Metropolitan Chapter, Nu Sigma at Northwestern University, and Mu Phi at Loyola University; and eight (8) Graduate Chapters: Zeta Tau Zeta (Chicago Metropolitan); Zeta Zeta (Dolton), Xi Mu Zeta (Markham), Tau Alpha Zeta (Richton Park), Tau Xi Zeta (Forest Park), Tau Psi Zeta (Alsip), Omega Pi Zeta (Evanston) and Psi Psi Zeta (Chicago). Together, all of these chapters will be honoring Zeta Phi Beta's Centennial Year on January 16, 2020 collaboratively throughout Cook County under the initiative entitled 'One Zeta'; and

WHEREAS, in Cook County, as well as worldwide, members of Zeta Phi Beta Sorority, Inc. have given hours of time in the form of community service to the citizens of Cook County as well as raise several thousands of dollars to provide scholarships annually to college bound high school seniors in Illinois. Cook County Chapters of Zeta Phi Beta Sorority, Inc. participate County Wide in providing outreach services to women, men and children in Cook County as well as globally via National Programs approved by the Sorority such as Z-HOPE (Zetas Helping Other People Excel), which is designed to enhance, cultivate and develop lifestyle choices of a person's health be it mentally or physically, primarily those persons of color as well as Stork's Nest, a cooperative program between the Sorority and the March of Dimes that aims to increase the number of women receiving early and regular prenatal care in an effort to prevent premature births and infant mortality ; and

WHEREAS, nearly all Cook County Graduate Chapters of Zeta Phi Beta Sorority, Inc. are members of the National Pan Hellenic Council of Chicago, which is a collaborative organization of 40 chapters representing Divine Nine Organizations in the Chicagoland area as a chapter of the National Pan Hellenic Council, formed on May 30, 1930 on the campus of Howard University as a means for Historically Black Greek Letter Organizations to meet, fellowship and engage in cooperative programming and initiatives through various projects, activities and functions; and

WHEREAS, the undergraduate and graduate chapters of Zeta Phi Beta Sorority located in Cook County, Illinois are part of the Great Lakes Region, led by Great Lakes Regional Director Connie V. Pugh and Illinois State Director Dr. Dawn C. Edwards; and

WHEREAS, notable members of Zeta Phi Beta Sorority, Inc. include singer/talk show host Syleena Johnson, Past International President of Zeta Phi Beta Sorority, Inc., comedienne and talk show host Sheryl

Underwood; Violette Anderson, Past International President of Zeta Phi Beta Sorority, Inc. the first African American law school graduate in the State of Illinois and the 1st African American woman to practice law before the United States Supreme Court; the Honorable Willie Whiting, charter member of Zeta Tau Zeta Metropolitan Graduate Chapter - Chicago, Illinois; first woman executive secretary of the Chicago branch of the National Association for the Advancement of Colored People (NAACP); the first black woman to prosecute cases for the City of Chicago in Women's Court and first black woman employed in Northern Illinois as an Assistant United States Attorney who was eventually elected in 1978 to the Circuit Court of Cook County as judge and the first African American woman endorsed by the Regular Democratic Party to run county wide for election; and

WHEREAS, the current Presidents of the Chapters are listed as follows - Zeta Tau Zeta Chapter (Chicago) - Elizabeth Stevenson; Tau Psi Zeta Chapter (Alsip) - Darcell Norwood-Baugh; Tau Alpha Zeta Chapter (Richton Park) - Mersaydes Young; Xi Mu Zeta Chapter (Markham) - Robbin Cooper; Psi Psi Zeta Chapter (Chicago) - Denise Johnson-Bournes; Zeta Zeta (Dolton) Adrienne Kellum McDay; Omega Pi Zeta (Evanston) - Joanna Goodson; Tau Xi Zeta (Forest Park) - Tiffany Jones; Alpha Alpha (Chicago Metropolitan Undergraduate) - Erica Lee; Nu Sigma (Northwestern University) -Brittany Owens; Mu Phi (Loyola University) - Ngozi Ude.

IN CELEBRATION OF TIMOTHY J. FRENZER ON THE OCCASION OF HIS RETIREMENT

WHEREAS, longtime Wilmette Village Manager Timothy J. Frenzer will retire in early 2020 after 27 years of service to the Village of Wilmette; and

WHEREAS, Mr. Frenzer is a longtime Illinois resident. He was raised in Algonquin and spent his formative years there. He has been married to his wife Catherine Murray, an attorney, for 31 years. They have four (4) children: Patrick, a veterinarian, and triplet daughters: Caitlin, an attorney; Beth, a marketing professional; and Meagan, a Ph.D. candidate at the University of Florida. He is a fan of college football, following both the University of Florida, where his son attended, and the University of Auburn when his daughters graduated; and

WHEREAS, Mr. Frenzer attended Loyola University in Chicago, where he graduated *summa cum laude*, with a Bachelor of Arts and Honors degree in 1980. He received his Juris Doctor degree from Loyola University Chicago School of Law, where he graduated *cum laude* in 1983. He began his legal career with the Cook County State's Attorney's office, working in the Criminal Division from 1983-1988 and the Civil Division from 1988-1989. He became a staff attorney for the Central States Health and Welfare and Pension Funds from 1989-1990 and then Senior Assistant Corporation Counsel for the City of Chicago Department of Law from 1990-1993; and

WHEREAS, Mr. Frenzer joined the Village of Wilmette as its Corporation Counsel in January 1993 and served in that role for 15 years until he assumed the role of interim Village Manager. The Village Board unanimously appointed him to Village Manager in July 2009; and

WHEREAS, as a municipal attorney, Mr. Frenzer was a member of the International Municipal Lawyers Association (IMLA). From 2003-2007, he was IMLA Illinois State Chair. In 2007, he was elected IMLA Regional Vice President for the 7th Circuit, a position he held until his appointment as Village Manager. In 2005, Mr. Frenzer received IMLA's national award for Most Outstanding State Chair; and

WHEREAS, as Corporation Counsel, Mr. Frenzer was a member of the Northwest Municipal Conference (NWMC) Attorneys Committee for 16 years and served as its chair for eight (8) of those years. He remains a member of the International Municipal Lawyers Association Home Rule Attorneys Committee. He was also a member of the NWMC Telecommunications Subcommittee that prepared statewide model Ordinances. He also remains a member of the Local Government Committee of the Chicago Bar Association; and

WHEREAS, when he took over as Village Manager, the Village was experiencing serious revenue disruption due to the Great Recession. Frenzer and his team stabilized the Village's finances and reduced costs while maintaining the Village's coveted AAA bond rating and Village services; and

WHEREAS, as Village Manager, Frenzer was the Chief Administrative Officer of the Village. He represented the Village as a Director on the boards of the Northwest Municipal Conference, the Solid Waste

Agency of Northern Cook County, and the Northeast Illinois Public Safety Training Academy. He was also a member of the Northwest Municipal Conference Legislative Committee and its Transportation Committee; and

WHEREAS, Mr. Frenzer is a member of the International City/County Management Association, the Illinois City/County Management Association, and the Chicago Metro Managers. He has testified for the Village and Illinois Municipal League in state legislative hearings and works with the Northwest Municipal Conference, Illinois Municipal League, and the Metropolitan Mayors Caucus on legislative issues. He has been a speaker at meetings, conferences, and seminars hosted by the Illinois Municipal League, International Municipal Lawyers Association, Chicago Bar Association, Illinois Association of Municipal Management Assistants, and Metro Managers on multiple occasions; and

WHEREAS, during his 27 years with the Village, Frenzer was instrumental in launching initiatives, including the Village Center Master Plan; the revitalization of the Village's downtown; the modernization of its solid waste and recycling collection; and a slate of infrastructure projects, including the West Park Sanitary Storage Facility project; and

WHEREAS, Frenzer also helped negotiate several new wholesale water contracts with other municipalities that generated new revenue for the Village and held down water rates for Wilmette; and

WHEREAS, Wilmette Village President Bob Bielinski said in a statement that he and the Village Board appreciate Frenzer's "many years of dedicated service. Tim took over as Village Manager during very challenging economic times. His steady and thoughtful leadership stabilized, and then improved, the Village's finances and contributed to new economic development and improved resident services"; and **WHEREAS,** when he announced his retirement, Frenzer stated, "Over the years, I have had the pleasure of meeting and working with many elected officials, as well as boards and commission members, and residents. The commitment of the Village Board members to ensuring good government and providing forward-looking leadership has ensured that Wilmette is a very special place in which to live and work."

HONORING KULMEET "BOB" GALHOTRA

WHEREAS, Kulmeet "Bob" Galhotra retired from the Cook County Public Defender's Office in December 2019 after serving 29 years as an Assistant Public Defender. At the time of his retirement, he was a supervisor in the Homicide Task Force, a special unit in the Public Defender's office that represents defendants in homicide and capital cases; and

WHEREAS, born in India - where he was nicknamed "Bob" by family members, for either Bobby Kennedy or the Bollywood film "Bobby". Galhotra moved to Chicago with his family at age 5. Reflecting on his move, Galhotra remembered that there was snow on the ground the day they arrived. There was not even a word for "snow" in Punjabi, his first language; and

WHEREAS, Bob was raised in Chicago with his brother, who is now a doctor. He started college at Illinois Institute of Technology (IIT) as an engineering student but switched majors to English. He graduated with Honors in 1987. After a short internship writing technical manuals, he registered for law school at IIT Chicago Kent Law School. His first experience through a clinic in a criminal courtroom hooked him on criminal defense work. He was hired by the Cook County Public Defender two (2) days after taking the bar exam; and

WHEREAS, during his tenure at the Public Defender's office, Bob has undertaken 30 murder trials in front of juries and nearly 100 bench trials. A number of his cases were widely publicized, including the recent Harris case out of Rockford, Illinois and the Andrew Warren case. Bob successfully negotiated a plea agreement for Warren, who was charged, along with former Northwestern University professor Wyndham Lathem, with the murder of Lathem's boyfriend; and

WHEREAS, Bob was recognized by his peers for his encyclopedic knowledge of case law and the increasingly technical aspects of criminal law from deoxyribonucleic acid (DNA) to cellphone technology. He also had great insight into the temperament and taboos of the judges who decide the fates of the 400 plus indigent murder defendants on the Task Force's roster; and

WHEREAS, one of Bob's great accomplishments at the Public Defender's office was his role in forming AFSCME Local 3315, now the largest union of attorneys in Illinois. He was on the Executive Board from

1998-1999 and served as Vice President from 1999-2001 and in 2007; and served as President from 20022006 and 2008-2013. In these positions, he represented approximately 450 rank-and-file Assistant Public Defenders; and

WHEREAS, Bob's commitment to representing indigent defendants was followed closely by his commitment to strengthening the union and ensuring that other public defenders had the support necessary to do their jobs effectively. Through this work he successfully advocated for the recognition of collective bargaining rights for assistant public defenders under local home rule by Cook County Ordinance; managed and organized the participation of the state's largest attorney union in a one-day strike to win a fair contract for front-line public servants in Cook County (7/11/2002); chaired four (4) delegations from Local 3315 to Universal Bargaining with the County; boosted full union dues-paying membership to 100%; amended the local's constitution to lengthen the terms of office from one (1) year to two (2); and implemented an online presence for the Local in 2006; and

WHEREAS, through his work with Local 3315, he also helped advocate for the repeal of the death penalty in Illinois and founded the Jack Carey Memorial Scholarship that recognizes outstanding law clerks at the Public Defender's office. The scholarship has been awarded nearly 50 times since its inception in 2002; and

WHEREAS, throughout his career, Bob has shown a dedication to public service and has personally and professionally served the needs of many of the County's most vulnerable residents at a time of great need. He achieved a high level of responsibility in his professional life and was recognized by his peers as a great resource to them in the Public Defender's office.

PROCLAIMING FEBRUARY 3-7, 2020 AS BLACK LIVES MATTER AT SCHOOL WEEK.

WHEREAS, Black Lives Matter at School is a national coalition organizing for racial justice in education; and

WHEREAS, during the 2017-2018 school year, from February 5 to 9, thousands of educators around the United States wore Black Lives Matter shirts to school and taught lessons about structural racism, intersectional black identities, black history, and anti-racist movements for a nationally organized week of action; and

WHEREAS, during the week of action, educators taught: 1) restorative justice, empathy and loving engagement 2) diversity and globalism 3) trans-affirming, queer affirming and collective values 4) intergenerational black families and black villages; and

WHEREAS, Black Live Matter at School movement developed these demands: 1) end "zero tolerance" discipline, and implement restorative justice 2) hire more black teachers 3) mandate black history and ethnic studies in K-12 curriculum; and

WHEREAS, Cook County has 109 school districts, Chicago Public Schools (CPS) being the largest school district; and

WHEREAS, as of December 2019, Chicago Public Schools student body is nearly 90% students of color (46.6% of students are Latinx, 35.9% Black, 10.8% White, 4.2% Asian, and 0.3% Native American); and

WHEREAS, according to the University of Chicago Consortium on School Research (CCSR) (September 2015), black students face suspensions from school at disproportionate rates even when risk factors "such as poverty and low achievement" are controlled for; and

WHEREAS, according to the "Handcuffs in Hallways" report by the Shriver Center (February 2017), "In total, between 2012 and 2016, the police officers assigned to CPS schools accumulated \$2,030,652.00 in misconduct settlements for activities on and off school grounds," and "of that total, nearly \$1.5 million resulted from excessive use of force against a minor and \$215,000.00 from incidents that occurred on CPS grounds"; and

WHEREAS, discipline, criminalization, and over-policing of black students has proven to be ineffective in the improvement of outcomes, damaging on their health and well-being, and restorative practices are proven to be a powerful tool in the reduction of disproportionate discipline and improved school climate; and

WHEREAS, Illinois Senate Bill 100 was signed in 2015 and intended to address the causes and consequences of the "school-to-prison" pipeline which disproportionately affects Black students. Senate Bill 100 explicitly requires that schools minimize exclusionary discipline practices such as suspension and expulsion; and

WHEREAS, Illinois House Bill 2859 was signed in 1991 and section 27-20.4 of the Illinois School Code mandated that "every public elementary school and high school shall include in its curriculum a unit of instruction studying the events of Black History"; and

WHEREAS, the implementation of ethnic studies and culturally sustaining curricula is of critical importance to supporting the leaning needs of all students, but particularly black students.
