Petitioner was escorting a handcuffed detainee. Petitioner reported the detainee scratched and possibly bit her in a struggle. Petitioner complained of injuries to her right hand and left arm.

17 WC 22102

Petitioner was restraining two inmates who were fighting one another and complained of injuries to her left hand.

Vice Chairman Britton seconded by Commissioner K. Morrison moved Approval. The motion carried.

VUJOSEVIC, COLE 18 WC 25566

Petitioner was involved in an altercation with a detainee. During the altercation, the detainee kicked Petitioner in the knees, causing him to fall backwards.
