WHEREAS, Mack Herron although he was small in stature standing 5 feet 5 ½ inches and weighted approximately 170 pounds was selected in the sixth round by the Atlanta Falcons in 1970 NFL draft but joined the Canadian Football League out of college; and

WHEREAS, in 1972 during his tenure with the Winnipeg Blue Bombers the CFL team he won the Eddie James Memorial Trophy for being the leading rusher in the CFL's West Division and he also led the league in all-purpose yards; and

WHEREAS, from 1973-1976 he played for the National Football League having played three seasons with New England Patriots and one season with the Atlanta Falcons; and

WHEREAS, Mack Herron led the NFL in kickoff returns and kick-off return yardage in 1973 his best season was 1974 with the New England Patriots, when he set the then-NFL record for all purposed yards with 2,444; and

WHEREAS, Mack Herron remains 10th all- time in career punt return averages in the NFL; and

WHEREAS, Mack Herron may be gone but his spirit and memories shall forever live on in our hearts.
