WHEREAS, the alleged tactics and practices at Homan Square, if true, pose serious concerns with respect to the human rights of Cook County residents who live within the vicinity of the facility; and,

WHEREAS, allegations of torture, denial of counsel and off-the-books detentions raise serious questions of human and constitutional rights violations; and,

WHEREAS, such questions are squarely within the purview of the United States Department of Justice and its Civil Rights Division; and,

WHEREAS, any federal investigation of the Chicago Police Department that does not include Homan Square will be incomplete and woefully inadequate;

NOW THEREFORE, BE IT RESOLVED by the President and the Board of Commissioners of Cook County that the United States Department of Justice is hereby requested to expand its current "patterns and practices" investigation to look into allegations of civil and human rights violations at the Chicago Police detention facility known as Homan Square; and,

BE IT FURTHER RESOLVED that a copy of this resolution be sent at the earliest opportunity to the Honorable Loretta E. Lynch, Attorney General of the United States.
