The Chicago Transit Authority agrees to reimburse the Sheriff's Office for the full-time salary and benefits of two (2) SWAP Deputies; the half-time salary and benefits for one (1) sworn supervisor; the cost of transport daily and other associated administrative costs. The total per annum amount shall not exceed \$350,000.00. Amendment is also to authorize the Sheriff of Cook County and Chicago Transit Authority to execute a Second Amendment exercising the second option to renew.
