WHEREAS, Rev. Crider organized the New Hope Community Baptist Church of Chicago in 1991. He served as its Pastor until March of 1998; and

WHEREAS, Rev. Crider was installed as Pastor of Mount Calvary Baptist Church of Chicago in July of 2003 and served Thirteen (13) years, ten months (10) in that position; and

WHEREAS, Rev. Crider published *The Gospel Tribune* from 1994 to 2013, and launched the *African-American Tribune* in 2014; and

WHEREAS, Rev. Crider is survived by his wife Regina and their four children: Sandra, Shantoya, Tyrone Jr., Ti'Ana and one grand-daughter, Felice.
