WHEREAS, more than thirty-nine) percent 39% of ComEd's current electricity comes from emission-free energy production including nuclear and renewables; and

WHEREAS, the County's commitment to 100% clean energy will create good local jobs for residents of Cook County, reduce air pollution and associated public health risks, and save consumers money; and
